



ORDER

Order No. 13/126-2016 HRME-I (4)

Dated, Panchkula, the: 28/03/23

Whereas, the petitioners have filed various civil writ petitions in the Hon'ble High Court i.e. CWP No. 11006/2016 – Bharat & others V/s State of Haryana & others, CWP No. 12606/2016 – Mam Raj Sharma V/s State of Haryana & others, CWP No. 4060/2021 – Rajender Singh & others V/s State of Haryana & others, CWP No. 23860/2017 – Balwinder Singh & others V/s State of Haryana & others, CWP No. 25130/2021 – Ramesh Chand V/s State of Haryana & others, CWP No. 13321/2016 – Satish Kumar & another V/s State of Haryana & others for praying to quash the impugned order dated 17.03.2016 passed by the respondent No. 2 to the extent of denying for relaxation of passing type test as a result of which petitioners have not been paid the benefit of notional pay fixation & arrears thereof, saying that there is no provision in the Government instructions for grant such relaxation, whereas the other similarly situated employees have been granted all the benefits including notional pay fixation 1st, 2nd and 3rd ACP vide order dated 12.01.2016, after granting the relaxation from passing type test, who had joined as Clerk from the same selection list in compliance of judgment.

These writ petitions came up for hearing on 25.07.2022 and on that day the Hon'ble High Court was pleased to allow the writ petitions partly. The operative part of the order is as under :-

“Keeping in view the above, the present petition is allowed to the extent that the order passed by the respondents declining the grant of exemption to the petitioners only on the basis of the condition of the appointment order is set-aside. Let the respondent-department consider the claim of the petitioners afresh keeping in view the various facts including that when the petitioners were appointed, they were already above the age of 45 years and their proficiency in typing must have gone down by passing years as the petitioners were appointed after 24 years of competing for the post of Clerks. Further, the respondents may also keep in mind that the Clerks, who were appointed after being retrenchment and the Clerks, who were appointed against the reserve quota of Ex-servicemen, have already been granted this benefit by the respondents, then why the same cannot be extended to the petitioners. Let the respondents pass a fresh order upon reconsideration of the case of the petitioners within a period of two months of the passing of this order.

Petition is disposed of in above terms.”

Whereas, in compliance of the above said orders of the Hon'ble Punjab and Haryana High Court, the matter was examined by the department and it has been found they were appointed by the department vide order No. 13/80-2013 HRME (5) dated 08.05.2013. They were granted the benefit of appointment from deemed date i.e. 12.04.1990, seniority & fixation of pay from the date their juniors in rank were

appointed. They will be entitled for pay fixation notionally from 12.04.1990 & actually from the date they joined their duty actually vide order No. 13/265-2013 HRME (4) dated 31.08.2016. The petitioners competed for appointment to the post of clerks in pursuance to the Advertisement No. 4 of 1987 dated 27.07.1987 and were declared successful in the result, which was declared on 15.10.1989 but the appointments were not made as the said selection became the subject matter of litigation before this Court. As per averments made, the petitioners were proficient in typing in the year 1987 and in case they would have been appointed then they would have cleared the said typing test but the matter with regard to their selection remained pending and subjudiced in the Court and it was only in the year 2013, the petitioners were granted appointment in pursuance to their selection, which was done in the year 1989. As per clause-6, the petitioners were required to pass typing test so as to get the annual increment.

The petitioners, unfortunately, could not pass the said typing test and requested the respondents to grant them exemption from passing of the said typing test, which request was turned down by the respondents. Therefore, the petitioners challenged the denial of exemption from typing by way of filing various writ petitions.

Thereafter, in compliance of the order of Hon'ble High Court, the claim of the petitioner was examined sympathetically and the matter was sent to W/Chief Secretary Haryana for taking decision with regard to grant of the relaxation of type test to the petitioners of the above writ petitions. A meeting was held on 03.01.2023 under the Chairmanship of W/Chief Secretary to resolve the issue.

The Chief Secretary Haryana has advised to give one time relaxation in the present case owing to the peculiar conditions and delay in their recruitment. This relaxation may not to be treated as precedent. Further, this one time relaxation is subject to the condition that no retrospective benefits, either promotional or financial will be granted to these Clerks. All retrospective benefit is only notional and only prospective benefits, from the date of approval of relaxation by the competent authority is granted to these Clerks.

I Order accordingly.


