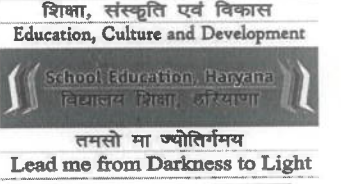

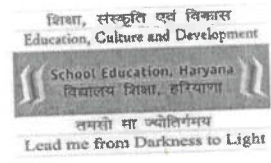

**ORDER**

**Memo No. 38/3-2019 PS (3)**

**Dated, Panchkula: 14.02.2023**

Whereas, Convent of Jesus and Mary School, Staff Road, Ambala Cantt, was granted NOC vide order no. 4201-23/13-76-S1 (5) dated 24.05.1976. A complaint vide no. CMOFF/N/2017/017934 was received on CM window against Convent of Jesus and Mary School, Staff Road, Ambala Cantt. from Sh. Nitin Bagga, R/o 4C, Preet Nagar, Ward No. 18, Ambala Cantt, wherein, it has been alleged that the Convent of Jesus & Mary School, Staff Road, Ambala Cantt is operational in the Old and Newly Constructed building which is not having the structural safety certificate as per ruling of Hon'ble Supreme Court in Avinash Malhotra Versus Union of India and others Writ Petition (C) No. 483 of 2004 decided on 13.04.2009. That property in which school is running should be safe and no school can be run without safety certificate which is to be obtained from District Education Officer or the Municipal Corporation. It was further alleged that the plan of school building has not been sanctioned by the appropriate authority and school has not complied with fire safety norms. All such safety, securities are required. The school building is situated on lease land and no permission was taken to raise construction from competent local body and Ministry of Defence or Govt. of Haryana. The concerned officials are shielding the school authorities to violate all rules of law which are required to be adhered to. The lease of land upon which school has been constructed has already expired. There is no record of expiry of lease of said school with the office of Govt. of Haryana.

Whereas, District Education Officer, Ambala was directed vide letter no. 38/3- 2019 PS (3) dated 23.07.2019 to conduct an enquiry and submit the report regarding the present complaint.

Whereas, District Education officer, Ambala submitted its report in the Department vide memo no. G-1/22/96 dated 15.02.2022.

Whereas, it has been stated in the report that the principal of Convent of Jesus and Mary School was intimated vide letters no. G-2/19/2954 dated 19.04.2019, 2966 dated 26.04.20219, 1700 (1) dated 11.07.2019, 2192 dated 30.07.2019, 2934 dated 08.08.2019, 3279 dated 03.09.2019, 3946 dated 02.12.2021 to submit Form no. 2 for reviewing of recognition/ NOC along with all relevant documents in the department but the school has not yet submitted any of the documents till date. The department vide letters no. 38/3-2019 PS(3) dated 15.02.2019 & vide reminder on 13.03.2019, 27.07.2019 and 20.08.2019 has also intimated the school management to submit the case for review of its recognition. It was further stated that when District Education Officer, Ambala after giving notice to the school, visited the said school on



03.12.2021, the principal was absent and the staff did not give any satisfactory reply regarding the recognition related documents. Thereafter, DEO, Ambala wrote another letter vide memo no. G-1/21/3955 dated 03.12.2021 to the school and directed the school to submit the documents on the online portal of the Department within 3 days for reviewing of NOC/Recognition. But the school had not uploaded the documents on the online portal.

Whereas, a show cause notice was served upon School Management vide order no. 38/3-2019 PS(3) dated 01.03.2022 to give reason as to why the recognition or "No Objection Certificate" already granted vide Directorate order dated 24.05.1976 be not withdrawn.

Whereas, school failed to submit its reply to show cause notice dated 01.03.2022.

Whereas, the school management has also been granted opportunity of personal hearing on 29.04.2022 with liberty to produce all the relevant documents in its favour. The school management failed to refute the violation of above-said statutory provisions. However, the school management assured that the process of updating Form-II was under process and they would submit Form-II for review of recognition.

Whereas, school was granted NOC way back in 1976. Whereas a infrastructural condition of the school including its building, drinking water facilities, wash room, Library, Labs would have depilated over the passage of time.

Whereas, rule 39 of Haryana School Education Rules, 2003 provides for reviewing of the recognition of a school. Rule 39 of Haryana School Education Rules, 2003 is reproduced here as under:-

**39. The recognition granted to schools affiliated to any board shall be reviewed after every [ten years]. If the managing committee fails to comply with any of the conditions and facilities specified in these rules, the appropriate authority can withdraw its recognition after giving a reasonable opportunity and one month time to show cause of the proposed action.**

Whereas, Rule 42 of the Haryana School Education Rules, 2003 provides for suspension or withdrawal N.O.C of the school under the circumstances mentioned therein. Rule 42 of the said Rules is reproduced here as under:-

**42 (1). The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of commission and commission contrary to the acts/rules or directions issued their under to the managing committee either directly through or Principal/Head of the Institution**

**(2) The recognition/NOC of the school shall lapse if the school,-**

**(a) XXXXXXXX**

**(b) XXXXXXXX**

**(c) XXXXXXXX**

**(d) XXXXXXXX**

**(e) has not complied with one or more of the conditions of recognition, specified in these rules.**

Whereas the school was granted recognition/ NOC on the condition that it shall abide by the rules, regulation and instructions of the appropriate authorities issued from time to time. Whereas management of the school has not submitted its case for reviewing its recognition despite so many opportunities granted to it.

In view of record and relying on the credible inquiry reports, I am of the considered view that the school management has been running the school in violation of rule 39. Hence recognition/NOC granted to the school vide this office order no. 4201-23/13-76-SI(5) dated 24.05.1976 is withdrawn from next academic session 2023-24.


