

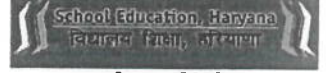

**Terms and conditions:-**

1. His appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to him at present. His services can be terminated without any notice, whenever there is no vacancy against which he can be retained.
2. If at any stage he desired to resign his post, he will be required to give one month's notice or forfeit in lieu thereof, his salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to him by the Directorate Secondary Education, Haryana, Panchkula in case it is proposed to terminate him services for the reason other than that mentioned in clause (I) above.
3. He will be required to take the prescribed oath of allegiance to the constitution of India.
4. In case any candidate is married, he/she will have to furnish a declaration to the Head of the Department that he has not taken any dowry after marriage. 5. In case he/she is unmarried, he/she will have to furnish a declaration to the effect that each of these will not have more than one living spouse.
6. The candidate will have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment.
