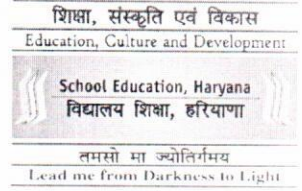

In pursuance with order dated 02.07.2021 passed by Hon'ble Punjab & Haryana High Court in CM-6745-CWP2021 in CWP No 19403 of 2019 titled as Baljit Singh and others V/s State of Haryana, the Governor of Haryana is pleased to promote Shri Kailash Chand [051072] (Seniority no. 252) Headmaster, Government High School, Kurhawata [3827] Mahendragarh to the post of principal w.e.f. 26.04.2023/28.04.2023 i.e. the date his junior Saurabh Kapil [006898] (seniority no. 253) Headmaster was promoted to the post of principal along with benefit of notional pay fixation & seniority on officiating capacity as Principal (School Cadre) (Rest of Haryana Cadre), as per Haryana State Education School Cadre (Group B) Service Rules, 2012 amended in 2014, in the pay scale of Rs.15,600–39,100 + 6600 (G.P.) plus usual allowances as sanctioned by the Haryana Government from time to time.

**Terms & Conditions:**

1. If any, disciplinary proceeding under Rule 7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbent(s) shall be reverted without issuing any notice.
2. **This promotion orders are subject to final outcome of Civil Writ Petitioner No. 19403 of 2019 titled as Baljit Singh and others V/s State of Haryana.**
3. This promotion orders are subject to final outcome of Civil Writ Petitioner No. 6175 of 2023 titled as Anoop Singh v/s State of Haryana, CWP NO. 30137 of 2022 titled as Priyavart and others V/s State of Haryana and Civil Writ Petition No. 8443 of 2023 titled as Arvind Kumar and others v/s State of Haryana
4. The promote(s) will remain on probation for one year as per rule 27 of Haryana Civil Services (General) Rules, 2016.
5. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate shall be reverted in view of the CS office instructions dated 31.05.2006, without issuing any notice.
6. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding the integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
7. 8. If any discrepancy regarding not fulfilling the essential qualifications as prescribed in the 'Haryana State Education School Cadre (Group B) Service Rules, 2012 amended in 2014, the said incumbent(s) shall be reverted without issuing any notice.
9. In case the promote(s) officer found ineligible for the feeder post or unsuitable for appointment/promotion as Post Graduate Teacher/Headmaster on account of any reason, such officer shall stand reverted without any notice.
10. In the case of candidates whose inter se seniority as PGT/ Lecturer is not available in the database, then such candidates will be suitably placed by determining their inter se seniority as PGT/ Lecturer and will be assigned subsequent seniority in the corresponding Principal seniority list accordingly.
11. If subsequently any senior person becomes eligible for promotion due to availability of ACRs or other records, then in that eventuality, he/she shall be treated as senior to any promoted junior candidate, even if promoted later.
12. After joining at the station allotted herein he/she shall proceed on a School Leadership training to be imparted through *Teacher Education Institutions* controlled by the SCERT, Haryana. The detail programme in this respect shall be communicated to her by the SCERT, Haryana.

Whereas, Sh. Surender Singh was appointed as Lecturer English on *ad-hoc* basis on 17.02.1987 and his services were regularized w.e.f. 01.01.1991. He was further promoted as Principal on 12.10.2002 on the basis of seniority as Lecturer at Sr. No. 668 as it stood on 01.04.1998. The said seniority was assigned wrongly because he furnished wrong particulars in the Pro-forma filled up by him. He showed his date of regular appointment w.e.f. 17.02.1987 whereas his regularization date is 01.01.1991. He concealed material facts and misled the department by submitting wrong particulars in Pro-forma for fixing his seniority in the lecturer cadre. Accordingly, his seniority has been re-fixed at Sr. No. 1403 (C) instead of 668 as Lecturer vide order No. 15/319-2002 E-IV(5) dated 12.02.2004 and Show Cause Notice dated 24.03.2004 was issued regarding reversion back on his substantive post.

Whereas, he filed writ petition no. 4489 of 2004 titled as Surender Singh Vs State of Haryana by challenging the order dated 12.02.2004 whereby his seniority was re-fixed. He was reverted to his substantive post of Lecturer English subject to final decision of aforesaid writ petition vide order dated 16.06.2004/21.06.2004 and relieved from the post of Principal on 07.07.2004. The aforesaid writ petition was disposed of by the Hon'ble High Court on 25.08.2005 with the direction to reconsider the case of the petitioner in the light of the fresh facts provided by petitioner. The claim of the petitioner was rejected by passing speaking order dated 02.01.2006/06.01.2006.

Thereafter, he again filed writ petition no. 1205 of 2006 titled as Surender Singh Vs State of Haryana challenging the reversion order dated 16.06.2004/21.06.2004 and the Hon'ble High Court stayed the operation of the above said order by passing interim order dated 23.10.2006. In compliance of this order, he was posted as Principal at GSSS Kondal (Mewat) subject to final decision of CWP No. 1205 of 2006. During the pendency of writ petition he was promoted as Deputy DEO on 29.07.2015 and HES-I Officer on dated 28.02.2018.

The CWP No. 1205 of 2006 has been decided by the Hon'ble High Court on dated 21.01.2019, order is reproduced as under:-

***"This order will dispose of CWP Nos.5211, 17979 of 2000 and 1205 of 2006 as common questions of law and facts are involved in these petitions.***

***It is past cavil that ad hoc service will not be counted towards seniority. Ad hoc appointment through Employment Exchange is not sufficient compliance of Article 16 (1) of the Constitution of India. Besides, third party rights have been settled from time to time which are not open to be disturbed as they are not parties to these cases. In similar circumstances, I have already taken a decision in CWP No.6305 of 2009 (Parmod Kumar and others vs. State of Haryana and others alongwith 100 connected cases decided on 17.9.2018). The entire law on the subject as was cited by both the sides, has been noticed and discussed.***

***In view of the above, I find no merit in these petitions which are accordingly dismissed."***

In view of the Hon'ble High Court orders and record submitted by the branch, you Sh. Surender Singh are not entitled for benefit of seniority on the basis of *ad-hoc* service. However, before taking final action, a Show Cause Notice is hereby served upon you to show cause as to why your promotion as Principal as per seniority be not considered w.e.f. 20.07.2007 when your junior i.e Shri Subhash Chander Dudeja, [Seniority No. 1405 as stood on 01.04.1998], was promoted as Principal and as to why your pension as Principal be not re-fixed as per revised Seniority No. 1403 (C) as stood on 01.04.1998. The reply of the present Show Cause Notice must be given within 15 days from the receipt of this notice. In case, no reply is received within the stipulated period, it shall be presumed that you have nothing to say and further action will be taken accordingly.
