In continuation of this office public notice No. 8/2-2022 PS(2) dated 06.03.2023 on the subject cited above.

Vide above referred public notice dated 06.03.2023, all the District Education Officer and District Elementary Education Officers were requested to direct all the private schools (whether they submitted final Form-VI or not) to fill a Self-Declaration Form regarding fee structure applicable on existing students as well as fee structure for newly admitted students for the academic year 2023-24 in place of point No. 10, 11, 12 & 13 of Form-VI and school shall submit the same on the online portal of Form-VI in PDF format, however, it has come into the notice of the Directorate that most of the schools have not filled Self-Declaration Form or the Self-Declaration has not been filled properly and due to the reason, the schools, who applied for CHEERAG Scheme but not filled Self-Declaration Form have not been considered for CHEERAG Scheme.

Therefore, it has been decided to re-open the portal for Form-VI from 08.05.2023 at 9:00am to 12.05.2023 at 11:59pm and all the District Education Officer and District Elementary Education Officers are requested to direct all the private schools (whether they submitted final Form-VI or not) to fill Self-Declaration Form. It is also clarified that the date to fill Self Declaration Form for Form-VI has not been extended further and this is the last opportunity to fill the same.

Vide this office public notice No. 8/2-2022 PS(2) dated 06.03.2023, all the District Education Officer and District Elementary Education Officers were requested to direct all the private schools (whether they submitted final Form-VI or not) to fill a Self-Declaration Form attached as **Annexure-A** in regard to per capital increase of monthly salary of teaching staff, maximum permissible fee increase, fee structure applicable on existing students as well as fee structure for newly admitted students for the academic year 2023-24 in place of point No. 10, 11, 12 & 13 and school shall submit the same on the online portal of Form-VI in PDF format, so that, the same can be used as evidence in regard to salary/fee related litigations to avoid future litigations, however, it has come into the notice of the Directorate that most of the schools have not filled Self-Declaration Form or the Self-Declaration has not been filled properly and due to the reason, the schools, who applied for CHEERAG Scheme but not filled Self-Declaration Form have not been considered for CHEERAG Scheme. Therefore, it has been decided to re-open the portal for Form-VI from 08.05.2023 at 9:00am to 12.05.2023 at 11:59pm and all the District Education Officer and District Elementary Education Officers are requested to direct all the private schools (whether they submitted final Form-VI or not) to fill Self-Declaration Form attached as **Annexure-A**. SOP FOR FILLING THE PDF OF FORM VI

01. Point no 10 of Form VI:

- a) Make a list of teachers who were in school in January' 2022 and also in January' 2023. Do not include teachers who were in school in January' 2022 but were not there in January' 2023. Likewise, do not include teachers who were in school in January' 2023 but were not there in January' 2022.
- b) Compute average salaries paid to these teachers in January' 2022 as well as January' 2023 by dividing the sum-total of salaries paid to all these teachers in the months of January' 2022 and January' 2023 respectively by number of teachers.
- c) Compute the average increment between these two average salaries.
- d) This is the '**per capita increase of monthly salary of teaching staff**'.

02. Point no 12 of Form VI:

- a) Schools that have maintained a single fee structure for all its students and have never made any incremental increase in the fee structure in the past for new admissions should submit a single fee chart for existing students.
- b) Schools that had revised their fee structure for new students in one or more academic years in the past should submit multiple fee charts for existing students.

Illustration:

- A school increases its fee by 10% every year;
- The school had a particular fee structure in academic year 2020-21;
- For the academic year 2021-22, the school increased the fee for new students by 15% i.e. more than 10%. Subsequently the fee of these new students increased 10% year on year.
