

Whereas, the petitioner namely Smt. Nisha [5003097], PGT Economics [Guest] approached and others to Hon'ble High Court by way of filing CWP No. 27271 of 2022 titled as Nisha versus State of Haryana & others praying therein to issue a writ in the nature of Certiorari by quashing the deployment/adjustment list Annexure P-1 dated 22.11.2022.

This case came up for hearing before Hon'ble High Court on 29.11.2022 and the Hon'ble High Court disposed of the case with the directions to respondents which are as under:-



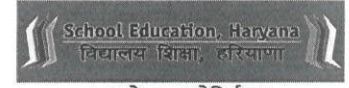

Whereas, the petitioner namely Sh. Lokesh Dutt [5002293], PGT Hindi [Guest] approached to Hon'ble High Court by way of filing CWP No. 27540 of 2022 titled as Lokesh Dutt versus State of Haryana & others praying therein to issue a writ in the nature of certiorari for quashing the order dated 28.11.2022 (Annexure P-5) qua the petition.

This case came up for hearing before Hon'ble High Court on 01.12.2022 and the Hon'ble High Court disposed off the case with the directions to respondents as under:-

**"Notice of motion.**

**Mr. Harish Nain, Assistant Advocate General, Haryana, who is present in the Court, accepts notice on behalf of the respondents.**

**Learned counsel for the respondents submits that the representations of the petitioner(s), if already filed or submitted by the petitioner(s) within a period of three days from today, will be considered and decided within a period of eight weeks from the receipt of copy of this order.**

**Learned counsel for the petitioner(s) submit that once the respondents have undertaken to decide the grievance raised in the representations, in order to avoid the harassment, the petitioner(s) be allowed to continue at their present place of posting till the decision of the said representations so that in case, tomorrow their grievance is accepted, they are not uprooted again so as to cause further inconvenience to the teachers.**

**Keeping in view the above, it is directed that till the decision of representations already filed by the petitioner(s) or filed till Monday, petitioner(s) will be allowed to continue at the present place of posting. It is made clear that in case, petitioner(s) have already been relieved, they will be allowed to join back at the same place of posting till the decision.**

**It is made clear that this Court is not making any observation with regard to the legality or illegality of the transfer at this stage and the respondents will be free to decide the representations filed by the petitioner(s) in accordance with the facts of each case whether, the dislocation of the petitioner(s)**

*is on account of joining of a regular employee or being surplus as informed to this Court by the learned counsel for the respondents keeping in view the information supplied by the department to the learned State counsel.”*

In compliance of the order of Hon'ble High Court, representation dated 15.11.2022 of the petitioner has been examined. It is found that the petitioner has prayed for staying at his current place of posting in GMSSSS Bodia Kamalpur [2519], Rewari. The petitioner was posted at GMSSSS Bodia Kamalpur [2519], Rewari without any screening so, during Transfer Drive of Guest Teacher in November-2022 the petitioner was allocated station GSSS Gaunchhi [977], Faridabad as per transfer policy. After that during adjustment of Guest Teachers, the petitioner was temporarily deputed in nearby GGSSS Sohna [852, Gurugram as per his merit points till the next transfer drive.

Thus, it is found that there is no merit in representation dated 15.11.2022 of the petitioner. However, the claim of the petitioner has been resolved.

Whereas, the petitioner namely Smt. Suman Rani [5000112], PGT Hindi [Guest] approached Hon'ble High Court by way of filing CWP No. 21330 of 2022 titled as Suman Rani versus State of Haryana & others praying therein to quash the action of respondents whereby the stations which are lying vacant have not been made available for allocation in pursuance to the General Transfer Drive 2022 and further quashing of the action of the respondents whereby the petitioner was made to participate compulsorily in the transfer drive whereas the petitioner was entitled to be protected under the notice dated 07.09.2022 (P-3) and further for quashing of the transfer order dated 12.09.2022 (P-5) vide which the petitioner have been transferred and posts are lying vacant in the nearby stations along with the present station of the petitioner, in the interest of justice. Further, directing the respondents to exclude the petitioner from General Transfer Drive.

This case came up for hearing before Hon'ble High Court on 16.09.2022 and the Hon'ble High Court disposed off the case with the directions to respondents as under:-

***"Notice of motion.***

*Mr. Harish Nain, Assistant Advocate General, Haryana accepts notice on behalf of the respondents and submits that the reasons for challenging the transfers being forwarded by the petitioner(s) are specific to them and in case, the petitioner(s) have already raised their grievances by filing of appropriate representation(s) or any representation is filed by the petitioner(s) upto Monday i.e. 19.09.2022, the same shall be looked into by the competent authority within a period of 10 days from today by passing an appropriate speaking order.*

*Learned State counsel further submits that in case, the petitioner(s) have not been relieved till today from the present place*

*of posting then they will be allowed to continue at the present place of posting till the decision of the said representation(s) in case, the same are filed and in case, the petitioner(s) have already been relieved from the present place of posting, they will not be forced to join at the new place of posting till the decision of the said representation(s).*

**Ordered accordingly.”**

In compliance of the said orders the representation dated 13.09.2022 [**Annexure P-7**] of the petitioner has been minutely examined. Department conducted Online Transfer Drive for Guest Teachers in September, 2022 to ensure equitable, demand based distribution of teachers/heads to protect academic interest of students and optimise job satisfaction amongst its employees in a fair and transparent manner. However, on conclusion of Guest Teachers Transfer Drive, some guest teachers made representation praying therein to either cancel their transfer order or to adjust them to a nearby station. So, to address their grievances, uniform decision was taken to adjust the guest teachers and choice of one district was sought from all guest teachers. Even after these efforts by the department, the petitioner not fill up any preference in the portal as per the information received from the I.T. Cell.

In view of the submissions made above, the grievance of the petitioner in the representation dated 13.09.2022 [**Annexure P-7**] is not tenable and liable to be rejected. The transfer of petitioner is done as per the provisions of the teacher transfer policy. However, taking into

consideration the next transfer drive which is being conducted in May/June 2023, petitioner is allowed to remain posted where she is working presently.

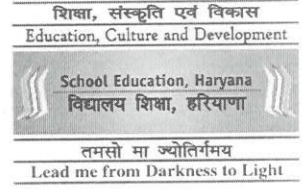

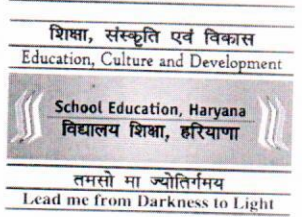
