

Whereas, Shri Ramesh Kumar [072300], the then Head Master Govt. High School, Bari, Sonapat, now posted at Govt. High School, Sohata (Ambala) was charge sheeted under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order No.5/7-2019 HRG-II (2) dated 04.01.2021 and the following allegations were leveled against him:-

“कर्मचारी के विरुद्ध जारी की गई चार्जशीट का विवरण यह कि जिला शिक्षा अधिकारी सोनपीत ने अपने पत्र क्रमांक जी-2/19/1828-1881 दिनांक 18.03.2019 द्वारा निदेशालय को अवगत करवाया कि उपमंडल मजिस्ट्रेट के उड़न दस्ते द्वारा दिनांक 08.03.2019 को राजकीय उच्च विद्यालय लडसौली के परीक्षा केन्द्र का औचक निरीक्षण किया गया। निरीक्षण के दौरान पाया गया कि श्री रमेश कुमार तथा अन्य तीन-चार कर्मचारी परीक्षा केन्द्र पर अप्राधिकृत रूप से मौजूद थे। उक्त अधिकारी के हाथों में नकल सम्बन्धी पेपर (पर्चिया) थी, जिसके माध्यम से उक्त अधिकारी बच्चों को नकल करवा रहे थे। जिसे यह स्पष्ट होता है कि उक्त अधिकारी उक्त परीक्षा केन्द्र को अधीक्षक और अन्य स्टाँफ से मिलीभगत करके परीक्षा केन्द्र पर बच्चों को नकल करवा रहे थे। जिससे आम जनता में विभाग की छवि छूमिल हुई तथा बच्चों की पढ़ाई पर बुरा असर पड़ा, जिसके लिए वे जिम्मेदार हैं।”

Thereafter, the charged officer submitted his reply to the said chargesheet on 25.01.2021 and denied all the allegations leveled against him. The reply of the charged officer found unsatisfactory. Resultantly, Sh. O.P. Langyan, IAS (Retd.) appointed as inquiry officer vide order /Memo dated 12.05.2021 to conduct the regular departmental inquiry. The inquiry officer submitted his report on 10.12.2021 wherein charges leveled against him were found not proved. However, Government expressed its disagreement with the report of regular inquiry officer and issued the dissenting note to the charged officer vide letter dated 21.04.2022.

Whereas, the charged officer submitted his reply to the said dissenting note on 29.11.2022 wherein, he reiterated the facts as mentioned in his earlier replies. The charged officer further submitted in his reply that although board examination was held in his school but he was not the center superintendent at the time of board examination and there was not a single unauthorized person was present within the premise of the said school. However, what happened outside the examination center was the responsibility of

the authorities maintaining law and order at the time of board examination. The charged officer prayed to consider his version and requested to drop the present charge-sheet as his retirement is due on 31.03.2031 .

Keeping in view the above facts and circumstances enunciated above, finding of inquiry officer, reply of charged officer to the dissenting note and documents on record, it is found that the charged officer cannot be held responsible for administrative lapse as he was not the center superintendent at said school during the board examination. The same has also been proved in the report of the regular inquiry officer.

Therefore, taking a lenient view, the present charge sheet Shri Ramesh Kumar (072300), the then Head Master Govt. High School, Bari , Sonapat, now posted at Govt. High School, Sohata (Ambala) is hereby filed.

Sh. Mahipal Singh [049817], Post Graduate Teacher Hindi, Government Senior Secondary School, Budhwal [3915] (Mahendergarh) is hereby informed that it is proposed by the Governor of Haryana to take action against him under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016, on the grounds set out in the enclosed statement of charges. The charges are based on the statement of allegations appended thereto.

2. **Sh. Mahipal Singh [049817]** is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by him whether he admits the truth of all, or any, of the charges, what explanation or defence, if any, he has to offer and whether he desires to be heard in person.
3. **Sh. Mahipal Singh [049817]** is hereby further informed that if for the purpose of preparing his written statement, he wishes to have an access to the relevant official records, he should inspect the same in the Office of the Director, Secondary Education, Haryana, Panchkula, on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to him as are in the possession of the Director, Secondary Education, Haryana, Panchkula, and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If, **Sh. Mahipal Singh [049817]**, wishes to consult any other relevant record, which is not in the custody of the Director, Secondary Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however, made clear to **Sh. Mahipal Singh [049817]** that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that he has none to submit.

4. The written statement should be submitted direct to the undersigned.

Statements of charges against Sh. Mahipal Singh [049817], Post Graduate Teacher Hindi, Government Senior Secondary School, Nangal Chaudhary [3884] (Mahendergarh) (Now Government Senior Secondary School, Budhwal [3915] (Mahendergarh)).

While being posted as Post Graduate Teacher Hindi in Government Senior Secondary School, Nangal Chaudhary [3884], Mahendergarh from 10.08.2016 to 31.08.2022, Sh. Mahipal Singh [049817] committed following acts of omission and commission for which he is being charged as under:-

“That a complaint was received from Sh. Makhan Lal Tanwar S/o Sh. Srichand Tanwar, R/o House No. 173, Sector-1 HUDA, Narnaul District Mahendergarh against him i.e. Sh. Mahipal Singh being Post Graduate Teacher Hindi to the effect that he i.e. Sh Mahipal Singh obtained two degrees i.e. Diploma in Education and Bachelor of Arts in the same year i.e. 1992-93. Further, the District Education Officer, Narnaul conducted a fact finding enquiry into the allegations and found that he i.e. Sh. Mahipal Singh, Post Graduate Teacher has obtained Diploma in Education and Degree in Bachelor of Arts in the same year i.e. 1992-93. He i.e. Sh. Mahipal Singh obtained Degree in Bachelor of Arts through private mode and Diploma in Education through regular mode. After obtaining said degree he i.e. Sh. Mahipal Singh got promotion in a fraudulent manner illegal manner.”

In this way, he i.e. **Sh. Mahipal Singh** remained negligent and irresponsible towards the Government duty and committed an act unbecoming of a Government officer and violated the provisions of **rule 4(1) (ii) (iii) (iv) and 5 of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.**

The lapses detailed above constitute grave misconduct on the part of Sh. Mahipal Singh, Post Graduate Teacher Hindi, Government Senior Secondary School, Nangal Chaudhary [3884] (Mahendergarh) (Now Government Senior Secondary School, Budhwal [3915] (Mahendergarh)) rendering him liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.

“That a complaint was received from Sh. Makhan Lal Tanwar S/o Sh. Srichand Tanwar, R/o House No. 173, Sector-1 HUDA, Narnaul District Mahendergarh against him i.e. Sh. Mahipal Singh being Post Graduate Teacher Hindi to the effect that he i.e. Sh Mahipal Singh obtained two degrees i.e. Diploma in Education and Bachelor of Arts in the same year i.e. 1992-93. Further, the District Education Officer, Narnaul conducted a fact finding enquiry into the allegations and found that he i.e. Sh. Mahipal Singh, Post Graduate Teacher has obtained Diploma in Education and Degree in Bachelor of Arts in the same year 1992-93. He i.e. Sh. Mahipal Singh obtained Degree in Bachelor of Arts through private mode and Diploma in Education through regular mode. After obtaining said degree he i.e. Sh. Mahipal Singh got promotion in a fraudulent manner illegal manner.”

In this way, he i.e. **Sh. Mahipal Singh** remained negligent and irresponsible towards the Government duty and committed an act unbecoming of a Government officer and violated the provisions of **rule 4(1) (ii) (iii) (iv) and 5 of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.**

The lapses detailed above constitute grave misconduct on the part of Sh. Mahipal Singh, Post Graduate Teacher Hindi, Government Senior Secondary School, Nangal Chaudhary [3884] (Mahendergarh) (Now Government Senior Secondary School, Budhwal [3915] (Mahendergarh)) rendering him liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.
