

Whereas, the petitioner namely Smt. Geeta Rani [5000130], PGT Hindi [Guest] approached the Hon'ble High Court by way of filing CWP No. 27162 of 2022 titled as Virender Singh and others versus State of Haryana & others praying therein to issue a writ in the nature of mandamus directing the respondents not to adjust the Guest Teachers at the place of petitioners by way of transfer as the Guest Teachers can't be replaced/dislocated by way of transfer of other Guest Teachers. AND/OR a writ in the nature of mandamus directing the respondents to decide the representation dated 22.11.2022.

This case came up for hearing before Hon'ble High Court on 24.09.2022 and the Hon'ble High Court disposed of the case with the directions to respondents as under:-

"Notice of motion.

Mr. Harish Nain, Assistant Advocate General, Haryana, who is present in the Court, accepts notice on behalf of the respondents.

Learned counsel for the respondents submits that the representations of the petitioner(s), if already filed or submitted by the petitioner(s) within a period of three days from today, will be considered and decided within a period of eight weeks from the receipt of copy of this order.

It is directed that till a decision is taken on the representations already filed by the petitioners or to be filed within three days from today, no coercive action of their displacement shall be taken by the respondent department.

At this stage, learned counsel for the petitioner(s) submits that though this Court had already directed the respondents that till the decision of the representations, no coercive action is to be taken but despite the said order, the petitioners are being relieved and the orders of this Court are being violated. One such order was shown in the Court today relieving an employee without deciding the representation for the information of the learned State counsel.

Learned State counsel submits that even if, someone has been relieved after the passing of an order by this Court, the said employee will be allowed to work at the same station by withdrawing the relieving order and appropriate instructions to the authorities concerned have already been issued in this regard

and the Department will ensure that the orders passed by this Court are not violated in any manner.

The said statement removes the grievance of the petitioner(s) as noticed hereinbefore.

All the writ petitions stand disposed of in above terms."

In compliance of the said orders the writ petition of the petitioner has been examined. It is found that the petitioner was transferred to Government Senior Secondary School Tilpat (1009), Faridabad in September, 2022 as per her merit points. Further, choices of districts was sought from Guest Teacher for re-adjustment. She gave preferences of districts; Panipat, Sonipat and Karnal. But, she was re-adjusted in other district i.e. Government Sr. Sec. School Ledi (225), Yamunanagar as per transfer policy and want of vacancies in Distirct Panipat, Sonipat and Karnal. Petitioner did not join there.

In view of the submissions made above, the grievances of the petitioner is not tenable and liable to be rejected as per transfer policy. However, keeping in view upcoming transfer drive petitioner is allowed to remain posted in GSSS School Tilpat Faridabad till next transfer drive.






