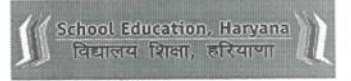

Whereas, Smt. Shashi Bala [065932], District Elementary Education Officer, Gurugram [now retired] was charge-sheeted under rule-8 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/255-2022 HRG-I (2) dated 22.02.2023 and the following allegations were leveled against her:-

“That she i.e. Smt. Shashi Bala updated the service profile of Smt. Sapinder Kaur [1034764] on MIS portal to the post of Trained Graduate Teacher (which is a state cadre post) instead of Classical and Vernacular Teacher (which is a district cadre) due to which she i.e. Smt. Sapinder Kaur were included in General Transfer Drive-2022. Resultantly, explanation of Smt Shashi Bala was called vide letter no. 5/255-2022 HRG-I(2) dated 11.10.2022 and reply dated 25.11.2022 was submitted by her i.e. Smt Shashi Bala which was examined and found that she i.e. Smt. Shashi Bala updated/edited the service profile of Smt. Sapinder Kaur on 19th August, 2022 at 12:26:58 PM which was a sheer negligence on her part i.e. of Smt. Shashi Bala being District Elementary Education Officer”.

Thereafter, Smt. Shashi Bala submitted her reply to the said charge-sheet on 06.04.2023 and admitted her mistake. She assured that such negligence would not be repeated in future.

Therefore, taking a lenient view, a punishment of ‘Censure’ is hereby inflicted upon Smt. Shashi Bala, District Elementary Education Officer, Gurugram [now retired].

It is ordered accordingly.

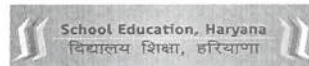

ORDER

On the recommendation of Haryana School Teachers Selection Board, Panchkula conveyed vide their Memo No. 2/1/2013-HSTSB/2013/CA dated 20.03.2013, the Governor of Haryana is pleased to appoint the following candidates as Post Graduate Teacher (PGT) **Punjabi** (HES-II) against Advt. No. 1/2012 in the pay band of Rs. 9300-34800 + Grade Pay 4800/- plus usual allowances as admissible from time to time. He/She directed to join at the place of posting as mentioned below:-

Terms and conditions:-

1. The benefit of ante-date appointment will be admissible w.e.f. 14.12.2013 from the date when his/her juniors have been appointed only for notional pay fixation & seniority and actual financial benefits will be admissible to him/her from the date he/she joins duty as **PGT Punjabi**.
2. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
3. He/She shall have to take an oath of allegiance to the Constitution of India.
4. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt him/her from this condition.
5. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.

6. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
7. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules as applicable to Haryana Government Employee and such orders/ instructions as may be issued by the Government from time to time.
8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be, is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
9. Candidate is hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned alongwith photostat self- attested copies. District Education Officer is directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
10. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining. District Education Officer will also give character and antecedent verification forms to his/her and after filling the form, the candidate would submit it to the District Education Officer concerned immediately.
11. He/She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
12. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
13. No TA/DA will be admissible to the candidate for joining as PGT.
14. If he/she gets an appointment as PGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information / facts which are detected later on, he/she would be liable for termination of service without any notice.
15. In case, he/she has not passed STET/HTET and B.Ed. as yet, he/she shall have to qualify HTET and B.Ed. as mentioned in Rule 19A of the 'Haryana State Education School Cadre (Group-B) Service (Second Amendment) Rule, 2012' amended from time to time, otherwise his/her appointment shall stand terminated automatically without giving any further notice.

16. The appointment will be subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
17. The exercise of the verification of character and antecedents should be carried out within a period of three months. Once the verification report is received and there are no objections on the facts given by the candidate, the provisional appointment letter will be confirmed.
18. If he/she is willing to accept this offer of appointment as PGT, HES-II (School Cadre) on the above terms and conditions, he/she should submit his/her joining report as per aforesaid directions.
19. **He/She is directed to join his/her place of posting within 15 days and send the joining report (duly signed by DDO) at dsepgt1@gmail.com, failing which this offer of appointment letter will be deemed to have been withdrawn.**
