The petitioner had filed the CWP No. 29231 of 2022 titled as Sona Devi Vs State of Haryana & others, praying therein for issuance of a writ in the nature of mandamus directing the respondents to decide legal notice 21.09.2019 of the petitioner and to compute the part time service rendered by the petitioner i.e. from 04.05.1986 to 10.01.2006 as qualifying service for pension and pensionary benefits while considering the case of the petitioner under Old Pension Scheme.

The above-said Civil Writ Petition came up for hearing on 19.12.2022 before the Hon'ble High Court & on that day the same was disposed of by the Hon'ble High Court. The operative part of the said order is as follows:-

"In view of the request made, without expressing any opinion on the merits of the case or the claim being made by the petitioner in her legal notice dated 21.09.2019 (Annexure P/11), respondent No.2 is directed to decide the legal notice dated 21.09.2019 (Annexure P/11) by passing a speaking order within a period of 08 weeks from the date of receipt of copy of this order."

In compliance to the aforesaid directions of the Hon'ble High Court, the legal notice dated 21.09.2019(Annexure P/11) of the petitioner was duly examined and it has been found that the petitioner was initially engaged as Part-time class IV on 04.05.1986 through direct recruitment method (i.e. without employment Exchange) in Govt. Primary School, Malwas Devsar District Bhiwani against un-sanctioned post for a short span of 01:30 Hours daily (w.e.f. 04.05.1986). However, after working for 01:30 Hours daily, the petitioner was free to do any work/job.

Whereas, the Education Department had its own regularization policy dated 30.12.1998/25.02.1999 wherein, the seniority of part time class IV employees was at institutional level and according to the said policy only those part time class IV employees were entitled for regularization of their services against vacant regular sanctioned post who had requisite experience mentioned in the policy in the institutions where sanctioned posts of class IV were available. But the petitioner could not be regularized as per the regularization policy dated 30.12.1998/25.02.1999

because of not fulfilling the terms and conditions of the said policy. Thereafter the said policy dated 30.12.1998/25.02.1999 was superseded by the new regularization policy of dated 11.11.2003 (herein after called the departmental specific policy). Accordingly Services of the petitioner were regularized w.e.f. 11.01.2006, as per her seniority and eligibility as and when regular sanction post was available, under the departmental regularization policy of 11.11.2003 wherein the seniority list of part time class IV employees was made at District level and accordingly the petitioner stood at Seniority Number 54, So, the petitioner is entitled to get the benefit as regular employee w.e.f. 11.01.2006 onwards and not prior to that and the petitioner was retired on 31.05.2018 from Government Senior Secondary School, Kasumbhi, Kairu, Bhiwani School.

Whereas, as per State Govt. notification dated 18.08.2008, New Pension Scheme came-in-to force, which is applicable to the employees, who have joined as regular employee on or after 01.01.2006 and the petitioner namely Smt. Sona Devi had joined as regular employee on dated 11.01.2006. Therefore, on the basis of "New Pension Scheme", the PRAN Number was allotted to her and she had also deposited her share of NPS amount. In this manner, the General Provident Fund attached to Old Pension Scheme is not applicable to her.

Further, **Rules 3.17 A(g) (iii)** of Civil Service Rules Volume-II provides that the service rendered by an employee on "PART TIME" basis cannot be computed for pension & pensioner benefits. Relevant portion of the said rule is reproduced as under.

Rule 3.17 A (g): The entire service rendered by an employee as work charge shall be reckoned towards retirement benefits provided:-

- (1) **Such service is followed by regular employment.**
- (2) **There is no interruption in the two or more spells of services or the interruptions fall with-in condonable limits; and**
- (3) **Such services is a whole time employment and not part-time or portion of day.**

In view of the above-mentioned facts, the case of the petitioner cannot be considered under Old Pension Scheme as the petitioner was entitled for regularization from 11.01.2006, therefore, she is entitled to get the benefits of New Pension Scheme which was prevalent at the time of

regularization of the petitioner and accordingly, the benefits of New Pension Scheme have already been granted/released to the petitioner. Further, for the purpose of getting benefits under the Old Pension Scheme, the person has to serve as a regular employee within the prevalence of Old Pension Scheme and the same is discontinued from 01.01.2006 onwards and the petitioner was regularized after said date. Therefore, she is not entitled to get the benefits of Old Pension Scheme.

Whereas, LPA No. 1892 of 2019 titled as State of Haryana and others Vs. Jai Bhagwan in CWP No. 1048 of 2016 titled as Jai Bhagwan Vs. State of Haryana and others is still pending for adjudication before the Hon'ble High Court of Punjab and Haryana at Chandigarh. So, the claim of the petitioner demanded through legal notice dated 21.09.2019 is not tenable and is hereby rejected being devoid of merits.




Order No. 13/150-2022 PGT-IV (1) Dated, Panchkula, the, 05.06.2023

Whereas, Sh. Amanjeet, PGT Geography (5019142), presently working in Government Senior Secondary School, Jamalpur Sheikhan, Fatehabad was earlier transferred from Government High School, Hansa Dahar (1598), Jind to Government Girls Senior Secondary School, Shikrawa (6567), Nuh, Mewat in online transfer drive-2022, vide order dated 09.09.2022. He did not join at Government Girls Senior Secondary School, Shikrawa (6567), Nuh, Mewat and filed CWP No. 24904/2022 in the Hon'ble High Court to quash the impugned order dated 09.09.2022 which was disposed-off by the Hon'ble High Court vide dated 10.11.2022 with the following order:-

“Learned counsel for the respondents submits that the petitioner has already been adjusted in his cadre 'rest of Haryana' as per order dated 10.11.2022 passed by the respondents but with the condition that the petitioner will participate in next transfer drive for permanent posting.

Learned counsel for the petitioner submits that the said condition is acceptable to the petitioner and prays that the petitioner be adjusted at the nearby vacant station wherever possible and submits that keeping in view the said order passed by the respondents, no grievance of the petitioner survives in the present writ petition and the same may be disposed of as such.”

In compliance of the said orders of the Hon'ble High Court, he was temporarily adjusted from Government Girls Senior Secondary School, Shikrawa (6567), Nuh, Mewat to Government Senior Secondary School, Malvi (1673), Jind vide orders no. 13/150-2022 PGT-IV (2) dated 15.12.2022/20.12.2022 and he has joined his duty as such as Government Senior Secondary School, Malvi (1673), Jind.

 After consideration of the said facts and circumstances the transfer order dated 09.09.2022 is hereby reviewed and cancelled because he never joined at Govt. Girls Sr. Sec. School Shikrawa (6567) Mewat and his on road period from 15.09.2022 to 23.12.2022 is treated as duty period for all purposes.
