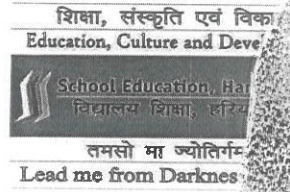

In compliance of the orders dated 12.07.2022 passed by the Hon'ble High Court in CWP No. 11116 of 2021 titled as Hanuman & Others Vs. State of Haryana & Others and other connected matters, the Hon'ble High Court directed that :

In case their representation is accepted and they are posted in a school which they have opted in the representation, they will join the same, otherwise, the petitioners will join schools where they have already been transferred by the respondents in the orders impugned in their petitions, which fact would be made clear by the respondents while deciding their representation. It is also made clear that a particular petitioner can not opt for more than three schools in his representation and in case, any of the petitioners opt for the same posting, the length of the service should be taken into consideration while deciding their claim with regard to the option.

In view of the said orders, an opportunity to all the petitioners were granted by the department to provide 03 stations of their choices and suitability, which were lying vacant. After that it has been found that 06 newly appointed Clerks were temporarily adjusted against the stations, which were already allotted to the petitioners participated in the General Transfer Drive-2020.

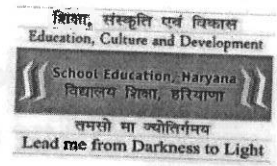

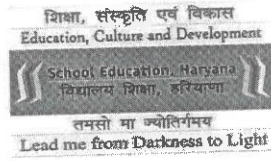

Bhagwan & Others vs. State of Haryana & Others, CWP No. 21727 of 2022 Deepak & Others vs. State of Haryana & Others and CWP No. 13727 of 2020 titled as Parveen Kumar & Another vs. State of Haryana & Others, the Hon'ble High Court directed that :

In case their representation is accepted and they are posted in a school which they have opted in the representation, they will join the same, otherwise, the petitioners will join schools where they have already been transferred by the respondents in the orders impugned in their petitions, which fact would be made clear by the respondents while deciding their representation. It is also made clear that a particular petitioner can not opt for more than three schools in his representation and in case, any of the petitioners opt for the same posting, the length of the service should be taken into consideration while deciding their claim with regard to the option.

In view of the said orders, an opportunity to all the petitioners were granted by the department to provide 03 stations of their choices and suitability, which were lying vacant. Accordingly, there were total 133 petitioners, out of which 28 petitioners could not be adjusted due to non availability of vacant stations and some stations have been allocated to other petitioners, whose length of services is more than the service of these 28 petitioners.
