Whereas, the petitioner namely Sh. Savita [5002199], PGT Hindi [Guest] approached Hon'ble High Court by way of filing CWP No. 21327 of 2022 titled as Parmod Chaudhary and others versus State of Haryana & others praying therein to quash the impugned transfer orders dated 11.09.2022 (Annexure P-9).

This case came up for hearing before Hon'ble High Court on 16.09.2022 and the Hon'ble High Court disposed of the case with the directions to respondents as under:-

"Notice of motion.

Mr. Harish Nain, Assistant Advocate General, Haryana accepts notice on behalf of the respondents and submits that the reasons for challenging the transfers being forwarded by the petitioner(s) are specific to them and in case, the petitioner(s) have already raised their grievances by filing of appropriate representation(s) or any representation is filed by the petitioner(s) upto Monday i.e.19.09.2022, the same shall be looked into by the competent authority within a period of 10 days from today by passing an appropriate speaking order.

Learned State counsel further submits that in case, the petitioner(s) have not been relieved till today from the present place of posting then they will be allowed to continue at the present place of posting till the decision of the said representation(s) in case, the same are filed and in case, the petitioner(s) have already been relieved from the present place of posting, they will not be forced to join at the new place of posting till the decision of the said representation(s).

Learned counsel for the petitioner(s) submit that keeping in view the statement of the learned State counsel, the present petitions may kindly be disposed of as having been not pressed any further with liberty to the petitioner(s), who are yet to file the representation, to approach the respondents by filing appropriate representation(s) raising their grievance as raised in the present petitions.

Ordered accordingly"

In compliance of the said orders, the representation of the petitioner (hereinafter referred to as claimant) has been examined at length. Petitioner is aggrieved by his transfer orders wherein he was transferred to Government Senior Secondary School Ahmedpur, Darewala(2851) Sirsa from Government Senior Secondary School, Bidhnoi (675) Bhiwani.

It is relevant to mention here that the 'Transfer Drive of Guest Teachers', was initiated in September, 2022, to ensure equitable, demand based distribution of teachers/heads to protect academic interest of students and optimize job satisfaction amongst its employees in a fair and transparent manner. However, some of Guest Teachers were not allotted station of their choice. After, Transfer Drive of Guest Teachers', number of Guest Teachers got posting far away from their previous place of posting and accordingly they submitted number of representation to the respondent Department. Thereafter, a uniform decision was taken to adjust the guest teachers in district of their choice and on deputation till the next transfer drive. Petitioner is claiming transfer/posting in his Home District Bhiwani or nearby District. Accordingly, she was adjusted in Government Girls Senior Secondary School Behal, (370), Bhiwani till the next transfer drive. In view of this, grievance of the petitioner has been resolved.

Whereas, the petitioner namely ~~Sh.~~ Mukesh Devi [5008789], PGT Hindi [Guest] approached Hon'ble High Court by way of filing CWP No. 26817 of 2022 titled as Sunil Rani and others versus State of Haryana & others praying therein to quash the impugned order/letter dated 19.11.2022, (Annexure P-6).

This case has been disposed of by Hon'ble High Court on 22.11.2022. The operative part of the order is as follows:-

"Notice of motion.

Mr. Harish Nain, Assistant Advocate General, Haryana, who is present in the Court, accepts notice on behalf of the respondents.

Learned counsel for the respondents submits that the representations of the petitioner(s), if already filed or submitted by the petitioner(s) with in a period of three days from today, will be considered and decided within a period of eight weeks from the receipt of copy of this order.


It is directed that till a decision is taken on the representations already filed by the petitioners or to be filed within three days from today, no coercive action of their displacement shall be taken by the respondent department."
