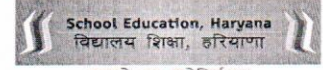

In compliance of order dated 09.05.2022 passed by the Hon'ble Supreme Court of India in SLP Nos. 25184-25214 of 2018, on the recommendation of Haryana Staff Selection Commission, Panchkula conveyed vide their Memo No. HSSC/Confid./Recomm/2022/5098 dated 21.11.2022, the Governor of Haryana is pleased to appoint the following candidate as Post Graduate Teacher **Computer Science** (HES-II) (Rest of Haryana cadre) against Advt. No. 5/2015 in the Scheduled-1 of Revised Pay Matrix of functional Pay Level 8 i.e. 47,600 - 1,51,100/- plus usual allowances as admissible from time to time. She is directed to join at the place of posting as mentioned against her name:-

Terms and conditions:-

1. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
2. The benefit of notional pay fixation and seniority will be admissible w.e.f. 17.12.2018 from the date when his/her juniors have been appointed and actual financial benefits will be admissible to him/her from the date when he/she joins duty as **PGT Computer Science**.
3. He/She shall have to take an oath of allegiance to the Constitution of India.
4. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied

- that he/she has special ground for doing so, and exempt his/her from this condition.
5. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
 6. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
 7. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
 8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
 9.  11. He/She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
 12. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
 13. No TA/DA will be admissible to the candidate for joining as PGT.
 14. If he/she gets an appointment as PGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information/facts which are detected later on, he/she would be liable for termination of service without any notice.
 15. This appointment letter is provisional subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.

16. If in case character and antecedents of the candidate is found not verified or any false information is given by the candidate in his self-declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken as per provisional of Indian Penal Code (IPC) etc as deemed fit.
17. The exercise of the verification of character and antecedents should be carried out within a period of three months. Once the verification report is received and there are no objections on the facts given by the candidate, the provisional appointment letter will be confirmed.

ORDER

Order No. 21/2-2023 ACD (15)

Dated: 23.06.2023

Sh. Sandeep Kumar Sharma filed CWP No. 26852 of 2022 titled as Sandeep Kumar Sharma vs. State and others, for the issuance of a writ, order or direction especially in the nature of certiorari for quashing the order dated 15.11.2022 (Annexure P-8) and further for quashing of transfer order dated 17.11.2022(Annexure P-9)

The aforesaid writ petition was disposed of by Hon'ble Punjab and Haryana High Court of vide its order dated 13.03.2023. The operative part of the order is reproduced here as under:-

“Keeping in view the orders passed in the earlier writ petitions preferred by the petitioner from time to time, but without going into the merits of the case, the present writ petition is disposed of with a direction to the petitioner to move a representation before respondent No.2-Director, Secondary Education, Haryana, for redressal of his claim qua allotting a station nearby District Sonipat, and qua releasing his due salary, within one week from the date of receipt of copy of this order. In case such a representation is filed by the petitioner, the same shall be decided by respondent No.2 sympathetically, within a period of four weeks thereafter.”

In compliance of the aforesaid directions of the Hon'ble High Court, the representation dated 17.03.2023 of the petitioner has been examined. Whereas petitioner was appointed as Lecturer Mathematics in the year 1996. In 2016 the petitioner was transferred from Govt. Senior Secondary School, Gannuar (3679) District Sonipat to Office of District Education Office Sonipat Code- 4611 Sonipat, on the post of DMS through General Transfer Drive-2016 inadvertently. The above stated transfer orders were cancelled by the department vide order no. 2/140-2016 PGT-II (1) Dated 08.08.2016. However, in CWP No. 16601 of 2016 the Hon'ble Punjab

and Haryana High Court has stayed the operation of order no. 2/140-2016 PGT-II (1), so the petitioner remained working as DMS in O/o DEO Sonipat. The CWP No. 16601 of 2016 titled as Sandeep Kumar Sharma versus State of Haryana and ors was disposed of by the Hon'ble Punjab & Haryana High Court vide order dated 24.08.2021 in terms of the order passed in CWP No.15108 of 2021 titled as Vikram Singh and Others V/s State of Haryana. The operative part of the order dated 24.08.2021 is as follows:

“The present writ petition is disposed of in terms of observations made in the order of even date passed in CWP No.15108 of 2021 'Vikram Singh and others Vs. State of Haryana and others’”

The CWP No.15108 of 2021 titled as Vikram Singh and Others V/s State of Haryana was disposed of with following directions:-

“Accordingly, the present writ petitions are disposed of with the directions to the respondents to consider the case of the petitioners as per their eligibility in the transfer drive as per the policy, which is ongoing and they will permit them to give option within a period of five days. The respondents shall ensure that the portal is opened for the petitioners to exercise their option for transfer.

The stay granted on earlier occasion will continue to operate in the favour of the petitioners till the date when they get their transfer orders on the completion of the transfer drive. It is also clarified that the portal shall also show the said post as 'Voluntary Deemed Vacancy' for other eligible persons to exercise their options. Similarly, the posts against which the petitioners were posted will also be treated as 'Voluntary Deemed Vacancy' as per the transfer policy. The State shall also take appropriate steps to revise the schedule accordingly, so that all concerned can take advantage of the opening of additional seats.

The writ petitions are, accordingly, disposed of, in the above said terms.”

Whereas, the department declared the post of DMS, District Education Officer, Sonipat as vacant. The petitioner challenged this act of the department by filing CWP No. 21397 of 2022 titled as Sandeep Kumar Sharma Versus State of Haryana & Ors. This writ petition was disposed of by Hon'ble High Court of Punjab and Haryana vide its order dated 19.09.2022 with the direction to respondent to decide the representation of the

petitioner. The operative part of the order dated 19.09.2022 is reproduced as given here under:-

“In view of the request made, without expressing any opinion on the merit of the case or the claim being made by the petitioner in his representation, respondent No. 2 is directed to decide the representation dated 13.09.2022 by passing a speaking order within a period of four weeks from the receipt of this order”.

Present writ petition stands disposed off.

Consequently, in compliance of the aforesaid direction of the Hon'ble High Court, representation of Sh. Sandeep Kumar Sharma was examined and decided vide Order No. 1/8-2018 ACD (7) dated 15.11.2022.

While conducting the general online transfer drive- 2022 department had given option to the petitioner to participate in the transfer drive. However he did not participate in the general online transfer drive- 2022. Furthermore he did not even update his MIS portal in order to avoid to participate in the transfer drive. The work profile of a DMS requires a lot of interpersonal, event management and other special skill set and a DMS is appointed purely on the basis of merit after following proper screening procedure. However, the petitioner was posted as DMS without under-going screening process and in view of order passed by Hon'ble Punjab and Haryana High Court in CWP No. 15108 of 2021, his post was treated as vacant. He was relived on 21.11.2022 vide order no. 1/8-2018 ACD(7) dated 17.11.2022 and directed to report to the concerned branch of the Directorate, but he failed to report to the concerned branch. The petitioner has been charge sheeted vide order 16/53/-2022 PGT IV(3) dated 01.05.2023 under Rule 8 of Haryana Civil Service (Punishment and Appeal) Rules, 2016 for showing lack of responsibility and devotion to duty and acting in manner which is unbecoming of Government officer. However, in view of order dated 13.03.2023 passed by the Hon'ble High Court in CWP No. 26852 of 2022

titled as Sandeep Kumar Sharma vs. State, he has been adjusted at GSSS Anwali (3584) in Sonipat district itself. Furthermore decision as to the release of arrears of salary from the date he was relieved from office of District Education Officer, Sonapat till his date of joining at GSSS Anwali (3584), Sonipat, that is from 21.11.2022 to 10.05.2023, will be subject to the departmental proceedings, under Rule 8 of Haryana Civil Service(Punishment and Appeal) Rules, 2016. Therefore the claim of the petitioner is not tenable and liable to be rejected.

I pass order accordingly.

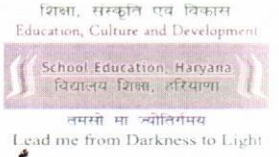
