

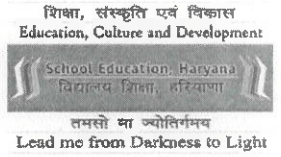

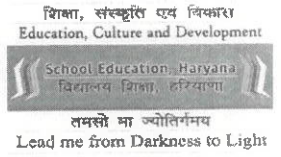

Whereas, the petitioner had filed the CWP No. 831 of 2023 titled as Sewapati Vs State of Haryana and others, praying therein for the issuance of a writ in the nature of mandamus directing the respondents to count and treat the period from 12.07.1988 to 01.07.2006 as qualifying period for grant of pensionary benefits on superannuation.

The above CWP came up for hearing on 16.01.2023 before the Hon'ble Punjab & Haryana High Court and on that day Hon'ble High Court was pleased to dispose of with direction to respondent. The operative part of order is as under:-

In view of the above, the present petition is disposed of with a direction to respondent No.2 to decide the legal notice dated 15.09.2022 (Annexure P-7) issued by the petitioner through her counsel, within a period of six months from the date of receipt of certified copy of this order, by passing a speaking order, in accordance with law."

Whereas, in compliance of the above said direction of the Hon'ble Punjab & Haryana High Court Order, the legal notice dated 15.09.2022 of the petitioner was examined and it has been found that the petitioner was initially engaged as Part-time class IV on 12.07.1988, through direct recruitment method (i.e. without employment Exchange) in Govt Girls Primary School Parta, District Fatehabad against non-sanctioned post for a short span for 1 ½ hours from 8 am to 9.30 am per day. However, after working for 01:30 Hours daily, the petitioner was free to do any work/job.

Whereas, the Education Department has its own regularization policy dated 30.12.1998/25.02.1999 and thereafter superseded by the new regularization policy of dated 11.11.2003 (herein after called the department

specific policy) instead of policy dated 01.10.2003 (General Policy). Further Services of the petitioner were regularized w.e.f. 01.07.2006, as per her seniority and eligibility as and when regular sanction post was available, under the regularization policy of 11.11.2003 (department specific policy), wherein the seniority list of part time class IV employees was made at District level and accordingly the petitioner stands at Seniority Number 43, So, the petitioner is entitled to get the benefit as regular employee w.e.f. 01.07.2006 onwards and not prior to that. The petitioner was regularized vide order no. E-2-20/6407-6407 dated 06.02.2020 w.e.f. 01.07.2006 notionally and actually from 08.08.2014 as per Department regularization policy dated 11.11.2003 as per their seniority, eligibility as well as the availability of posts of class IV.

Whereas, as per the notification dated 18.08.2008 of Haryana Government Finance Department, New Pension Scheme, Haryana, 2008 came into force applicable to all Govt. servants joining the service on or after 01.01.2006 and the petitioner had joined as regular employee on dated 01.07.2006. Therefore, on the basis of "New Pension Scheme", the PRAN Number was allotted to her and she had also deposited her share of NPS amount. In this manner, the General Provident Fund attached to Old Pension Scheme is not applicable to her.

Further Rule 3.17 (A) (g) (iii) of CSR vol.2 provides that the service rendered by an employee on Part-Time basis cannot be reckoned towards retirement benefits. Rule 3.17 (A) (g) (iii) of CSR vol.2 is reproduced here as under:-

"Rule 3.17 A (g): The entire service rendered by an employee as work charge shall be reckoned towards retirement benefits provided:-

- (i) Such service is followed by regular employment.***

- (ii) *There is no interruption in the two or more spells of services or the interruptions fall within condonable limits: and*
- (iii) *Such services is a whole time employment and not part-time or portion of day."*

In view of the above-mentioned facts, the case of the petitioner cannot be considered under Old Pension Scheme as the petitioner was entitled for regularization from 01.07.2006, therefore she is entitled to get the benefits of New Pension Scheme which was prevalent at the time of regularization of the petitioner and accordingly, the benefits of New Pension Scheme have already been granted/released to the petitioner. Further, for the purpose of getting benefits under the Old Pension Scheme, the employee has to serve as a regular employee within the prevalence of Old Pension Scheme and the same is discontinued from 01.01.2006 onwards and the petitioner was regularized after said date. Therefore, she is not entitled to get the benefits of Old Pension Scheme. So, the petitioner do not fulfill the above said condition, therefore, the claim of the petitioner is not maintainable.

Keeping in view of above mentioned facts and circumstances, the claim of the petitioners is not tenable as per prevalent rules/instructions and hence rejected being devoid of merits.

I order accordingly.

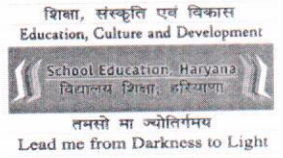



Whereas Jyoti Vidya Mandir School, Jyotishar, Kurukshetra run by the Managing Committee Jyoti Shiksha Samiti, VPO Jyotishar, Distt. Kurukshetra was granted recognition upto 10th level vide order no. 18/6-2019 PS (3) dated 02.05.2019 by the Director Secondary Education Haryana, Panchkula under the provisions of Haryana School Education Rules, 2003

Whereas a complaint was received against Jyoti Vidya Mandir School, Jyotishar Kurukshetra from Sh. Neeraj, R/o Nilokheri, District Karnal wherein, it has been alleged that school has been running classes upto 12th level despite being recognized upto 10th level. It has been further alleged that the board exams of the students are being conducted through other recognized schools and the school has neither teachers nor any infrastructure to conduct classes for 12th class students.

Whereas an enquiry committee has been constituted under the Chairmanship of Block Education Officer, Thanesar, Kurukshetra. The complaint the enquiry committee enquired into the matter and submitted its enquiry report vide Letter-G-1/2023/1274 dated 27.02.2023. As per enquiry report residential a house has been built on the school premises. It has also been stated that the school management has been running 11th and 12th classes without any recognition/permission and that school premises is also being used for non-educational purpose.

Whereas the school was granted recognition on the condition that it shall abide by the rules, regulations, instructions of the appropriate authorities issued from time to time under the Haryana School Education Rules, 2003.

Whereas Rule 30 of Haryana School Education, 2003 provides for the conditions for grant of the recognition to private schools of the State of Haryana.

The operative part of Rule 30 of Haryana School Education Rules, 2003 is reproduced here as under: -

30. (1) *No private school shall be recognized, or continue to be recognized, by the appropriate authority unless the school fulfils the following conditions, namely:*

(xvii) that the school buildings or other structures or the grounds are not used during the day or night for commercial or residential purposes (except separate residence of any employee of the school away from academic wing) or for communal, political or non educational activity of any kind whatsoever; Whereas the school was granted recognition on the condition that it shall abide by the rules, regulation and instructions of the appropriate authorities issued from time to time under the Haryana School Education Rules, 2003.

Further rule 36 of Haryana School Education Rules, 2003 provides that no school can upgrade any new class without prior approval of the competent authority. Rule 36 of Haryana School Education Rules, 2003 is reproduced here as under:-

“No recognized school without giving full justification and without prior approval of the appropriate authority, shall open any new class other than which have received approval from the appropriate authority.”

In view of enquiry report dated 27.02.2023 it appears that school is being run in violation of rule 30 and rule 36 of Haryana School Education Rules, 2003.

Whereas Rule 42(1) of the Haryana School Education Rules, 2003 provides that the appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued there under to the managing committee either directly or through Principal/ Head of the institution.

Therefore, a show cause notice is being issued to the management of the said school as to why the recognition granted to the school not to be withdrawn under Rule 42 of the Haryana School Education Rules, 2003.

The reply, if any, the Management of school wants to submit, should be submit to this Department within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and an appropriate order shall be passed in accordance with Rules.
