



Whereas, the petitioners had filed the Civil Writ Petition No. 1282 of 2023 titled as Chandi Ram & Others V/s State of Haryana and Others in the Hon'ble Punjab and Haryana High Court at Chandigarh with the prayer for the issuance of a writ in the nature of Mandamus for directing the respondents to consider the case of the present petitioners for regularization of their services along with all consequential benefits with effect from the date they became eligible for regular appointment as per the terms of the policy formulated in this regard and further directing the respondents to decide the legal notice dated 08.06.2020 (P-8) & representation dated 19.12.2020 (P-10) by passing a speaking order within a stipulated period.

The above mentioned Civil Writ Petition came up for hearing on 27.03.2023 before the Hon'ble High Court and on that day the same was disposed of with the direction to decide the representation dated 19.12.2020 (P-10) of the petitioners. The operative part of the said order is as under:-

"Notice of Motion.

On the asking of this court, Mr. R.S. Bhudhwar, Addl. A.G. Haryana, accepts notice on behalf of the respondents-State and submits that he has no objection if the aforesaid limited prayer made by the learned counsel for the petitioners is allowed.

In view of the above, the present petition is disposed of with a direction to respondent No. 2- The Commissioner-Cum-Director General, School Education, Haryana to decide the representation dated 19.12.2020 (P-10) moved by the petitioners, within a period of eight weeks from the receipt of the certified copy of this order, as per law."

In compliance of the above said order of the Hon'ble High Court, the representation dated 19.12.2020 (P-10) of the petitioners was examined and it has been found that the petitioner nos. 1 to 18 were engaged as Class-IV employees on part time basis against unsanctioned

posts on the post of Sweepers in the years 2007 & 2008 in the different-2 Schools in District Jind only for one and half hour per day for which they were paid remuneration according to the prevailing D.C. rates revised from time to time. Whereas, according to previous departmental policy dated 30.12.1998/25.02.1999 the seniority of part time Class-IV employees was at institutional level & as per this policy only those part time Class-IV employees were entitled for regularization of their services against vacant regular sanctioned posts who had requisite experience mentioned in the policy in the institutions where sanctioned post of class-IV were available and the said policy was superseded by new departmental policy dated 11.11.2003. Since the petitioners were engaged part time class-IV in the years 2007 & 2008, therefore the departmental policy dated 30.12.1998/25.02.1999 is not applicable to the petitioners.

Whereas, the question of regularization of the services of the petitioners under the New Departmental Policy dated 11.11.2003 is concerned, it is hereby clarified that as per the departmental regularization policy dated 11.11.2003, a common seniority list of all the part time Class-IV employees working in Govt./ Primary/Middle/High/Sr. Secondary Schools and the field offices like O/o BEOs/ SDOs/DPEOs/DEOs/SCERT/DIETs/GETTIs etc as on 30.06.2003 was prepared by the DEOs concerned at District Level and this seniority list of part time Class-IV employees acts as a reference point for sponsoring the names of the senior most person for regularization against the regular sanctioned Class-IV post in the field offices/Schools of the Education Department. Therefore, on completion of the tenure of part time service mentioned in the policy dated 11.11.2003, the part time Class-IV employees are regularized from time to time on the basis of the above said seniority provided they would fulfill the prescribed qualification for other Class-IV posts.

Whereas, the petitioners joined the Education Department in the year after 2007 and 2008, hence, their names don't fall in the seniority of part time Class-IV employees made at District level. Therefore, the services of the petitioners cannot be regularized in view of the new departmental policy dated 11.11.2003.

Moreover, it is relevant to clarify here that the claim of the petitioners had already been decided while rejecting their claim vide order No. E-3/2021/4618-39 dated 13.04.2021 of District Education Officer, Jind in view of the directions of the Hon'ble High Court passed in CWP

No. 20195 of 2020 titled as Chandi Ram & others Vs State of Haryana & others.

Therefore, keeping in view of the position explained above, the claim of the petitioners demanded through legal notice (P-8) dated 08.06.2020 & representation dated 19.12.2020 (P-10) is not tenable & hence rejected being devoid of merits.







Learned counsel for the petitioner(s) submit that once the respondents have undertaken to decide the grievance raised in the representations, in order to avoid the harassment, the petitioner(s) be allowed to continue at their present place of posting till the decision of the said representations so that in case, tomorrow their grievance is accepted, they are not uprooted again so as to cause further inconvenience to the teachers.

Keeping in view the above, it is directed that till the decision of representations already filed by the petitioner(s) or filed till Friday, petitioner(s) will be allowed to continue at the present place of posting. It is

made clear that in case, petitioner(s) have already been relieved, they will be allowed to join back at the same place of posting till the decision.

It is made clear that this Court is not making any observation with regard to the legality or illegality of the transfer at this stage and the

respondents will be free to decide the representations filed by the petitioner(s) in accordance with the facts of each case whether, the dislocation of the petitioner(s) is on account of joining of a regular employee or being surplus as informed to this Court by the learned counsel for the respondents keeping in view the information supplied by the department to the learned State counsel.

All the writ petitions stand disposed of in above terms.



Thereafter, a uniform decision was taken to adjust the guest teachers in district of their choice and on deputation till the next transfer drive, but the petitioner did not submit her choice. Thus, the claim of the petitioner is not tenable and liable to be rejected.

However, keeping in view of upcoming transfer drive, the petitioner is allowed to remain at her present place of posting till the next transfer drive.

Whereas, the petitioner namely Sh. Kuldeep Sharma [5007686], PGT History [Guest] approached Hon'ble High Court by way of filing CWP No. 28083 of 2022 titled as Anil Kumar and others versus State of Haryana & others for issuance of a writ in the nature of mandamus/certiorari directing the respondents not to adjust the guest teachers at the place of petitioners by way of transfer as guest teachers cannot be replaced/dislocated by way of transfer of the other guest teachers.

This case came up for hearing before Hon'ble High Court on 06.12.2022 and the Hon'ble High Court disposed of the case with the directions to respondents as under:-

“Notice of motion.

On asking of Court Mr. Harish Nain, AAG, Haryana accepts notice on behalf of respondent-State. Learned State counsel raised no objection in deciding the representation dated 28.11.2022 Annexure P-11 in a time bound manner by passing a speaking order.


Without going into the merits of the case or the claim being raised by the petitioner in the present petition, the respondent No.2 is directed to decide the representation dated 28.11.2022 Annexure P-11 filed by the petitioner within a period of 8 weeks. It is directed that till a decision is taken on the representation filed by the petitioners, no coercive action of their displacement will be taken by the respondent-department.


