Whereas the petitioner had filed the CWP No 16980 of 2022 titled Khazani Devi v/s State of Haryana and others, praying therein to quash the impugned order dated 09.05.2019 (P-8) passed by the respondent No. 4 Further prayed for directions to the respondents to add the entire service period rendered by petitioner for the purpose of pensionary benefits alongwith 18% interest from the date of entitlement till the realisation.

The above said Civil Writ Petition came up for hearing on 04.08.2022 and on that day the same was pleased to dispose of with direction to respondent. The operative part of the order is reproduced as under:

This petition is disposed of with a direction to the respondent No. 2 to pass an appropriate speaking order on the appeal dated 11.07.2019 (Annexure P12), filed by the petitioner, within a period of eight weeks from the date of receipt of the copy of this order and after the said decision, in case the petitioner is found entitled for the grant of any benefit, the same be also released in her favour within a period of four weeks thereafter."

The brief facts of the case are that the petitioner namely Smt. Khazani Devi was engaged as Part Time Water Carrier on 17.09.1993 in GHS Titoli District Rohtak against unsanctioned post who was relieved from her part time service of class IV by Headmaster, GHS Titoli on 31.03.2000 as there was no further requirement of the services of the petitioner. Thereafter, the petitioner challenged her relieving orders dated 31.03.2000 in the Industrial Tribunal-cum-Labour Court, Rohtak through Reference No. 12 of 2008, consequently, the award dated 14.07.2014 was passed by the Hon'ble Labour Court whereby the petitioner was entitled to be re-instated on her previous post with continuity of service and with 50% back wages from the date of demand notice i.e. 14.02.2006. Meanwhile, the said award dated 14.07.2014 passed by the Hon'ble Labour Court was challenged by the Department in the Hon'ble Punjab & Haryana High Court in CWP No. 2962 of 2015 titled as Head

Master, Govt. High School, Titoli (Rohtak) Vs. Smt Khazani Devi and the same was dismissed by the High Court on 20.02.2015 and thereafter LPA No. 1160 of 2015 in CWP No. 2962 of 2015 titled as Head Master, Govt. High School, Titoli (Rohtak) Vs. Smt Khazani Devi and another was filed by the Head Master and the same was also dismissed by the Hon'ble Court on 07.12.2015.

Resultantly, the petitioner was allowed to re-join as a Part Time Water Carrier on 07.11.2015 and back wages amounting to Rs. 49,303/- with 50% back wages from the period of 14.02.2006 to 06.11.2015 was also released on 10.05.2016 in compliance of award dated 14.07.2014. On completion of 60 years of age the petitioner was relieved from the post of part time class IV from Government Senior Secondary School, Titoli (Rohtak) on 09.11.2015. Apart from this, the petitioner came to know that similarly situated junior part time employees working in other Government schools were regularised w.e.f 20.02.2013 as per Notification Dated 29.07.2011 of Government of Haryana, General Administration Department (General Service-1) by the department.

Thereafter, the petitioner had again filed the CWP No. 16031 of 2016 titled as Khazani Devi vs. State of Haryana and Others which was disposed of with direction vide order dated 09.08.2016 of the Hon'ble High Court and in compliance of the said order, the services of the petitioner were regularized notionally w.e.f 20.02.2013 and actually w.e.f 07.11.2015 vide Order No. E-4-17/22-24 dated 03.04.2017 of the District Education Officer, Rohtak. Thereafter, the petitioner had filed CWP No. 24303 of 2017 titled as Khazani Devi vs. State of Haryana & Others, wherein the petitioner claimed benefits of period of regularization and the same was disposed of by the Hon'ble High Court on 10.12.2018 with the following orders:-

As per reply filed by Principal, Government Sr. Sec. School, Titoli, Rohtak-respondent No.4, services of the petitioner have been regularized. After regularization, entire arrears has also been paid to her. It is further stated that the school administration has already paid 50% back wages on the basis of last pay drawn by the petitioner.

In view of the reply filed, no further directions are required to be issued in this petition.

Disposed of accordingly.

Further, the petitioner again filed CWP No. 17823 of 2019 titled as Khazani Devi vs. State of Haryana & Others wherein, the petitioner claimed for pensionary benefits on basis of regular services for more than 10 years services and same was dismissed by the Hon'ble High Court on 05.07.2019 as withdrawn writ petition by the petitioner, with a liberty to file representation before the appropriate/competent authority.

Now, in compliance of the orders dated 04.08.2022 of the Hon'ble High Court in the present writ petition, the appeal of the petitioner was examined and an opportunity of personal hearing was also granted to her on 05.04.2023 by the Department. On the examination of the matter, one more peculiar thing came to the notice of the Department that the petitioner worked as Mid-Day Meal Worker from September 2004 to April 2008 in GPS Titoli Rohtak (Now GMSPS), from May 2008 to November 2015 and January 2016 till 11.11.2020 in GSSS Titoli Rohtak and also received the undue benefits in the guise of the award dated 14.07.2014 as she also received the benefits of the said period when she was not working as a part-time water carrier, whereas during the said period she was engaged somewhere else as a mid-day meal worker from September 2014 to April 2008 in GPS Titoli Rohtak (Now GMSPS) and from the period May 2008 to November 2015. The services of the petitioner had already been regularized notionally w.e.f 20.02.2013 and actually w.e.f 07.11.2015 vide Order No. E-4-17/22-24 dated 03.04.2017 of the District Education Officer, Rohtak in compliance of CWP No. 16031 of 2016 titled as Khazani Devi vs. State of Haryana and Others. The petitioner was relieved from Government Senior Secondary School, Titoli (Rohtak) dated 09.11.2015 on attaining the age of superannuation, where she joined actually on 07.11.2015. Since she actually worked only for three days, so the matter of petitioner cannot be considered for NPS as no payment was deducted from her salary account qua the same and still further she had not completed 10 years regular

services therefore she cannot be covered under old pension scheme and hence no pensionary benefits can be granted to her.

However, as per Rule 3.12 Civil Services Rules (Volume II) the service of the petitioner does not qualify for pension as her service is neither substantive nor permanent and further service of the petitioner has not been declared as qualifying for pension by the competent authority as per Rule 3.13 of Civil Services Rule. Whereas, as per Rule 3.17 A (g) (iii) of Civil Service Rules (Volume II) the part time service rendered by an employee cannot be counted as qualifying services for the purpose of pensionary benefits.

Moreover, the facts and circumstances of cited case of Smt. Santosh Devi are completely different from that of the case of the petitioner, being the involvement of the services of the husband of Smt. Santosh Devi rendered on work charged basis, whereas the present petitioner has worked as part time employee and hence no similarity/lies between both the cases.

Therefore, in view of the position explained above, the claim of the petitioner is not tenable and hence liable to be rejected being devoid of merits.

I order accordingly.

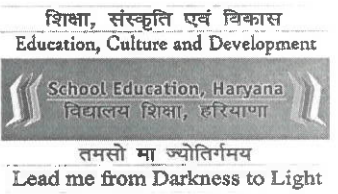
