ORDER

No. 13/46-2018 HRME-II (1)

Whereas the petitioner had filed the CWP No. 28917 of 2017 titled as Pardeep Kumar V/s State of Haryana and others in the Hon'ble Punjab and Haryana High Court, praying therein for issuance of a writ in the nature of mandamus for directing the respondents to release the minimum regular pay scale of the post of sweeper in the Grade Pay of Rs. 7440-9840 or any other permissible pay scale to the petitioner with all consequential benefits as the petitioner is working on the post of sweeper against a vacant sanctioned post in the respondent School continuously since 08.05.2007 and further prayed to consider the claim of the petitioner for regularization of his services as Class-IV employee, as per law.

The above said writ petition came up for hearing on 16.02.2023 and same was disposed of by Hon'ble High Court. The operative part of the said order is as under:-

"I have heard the learned counsel for the parties and have also gone through the case file.

Admittedly, the petitioner has been continuously working as a part-time Sweeper since 08.05.2007 in the High School and one sanctioned post is also vacant in the said School

In view of the above, the present petition is disposed of with a direction to respondent No.2-Director General, Secondary Education, Haryana, to consider the case of the petitioner as per the regularization Policy-2003 as and when his turn comes. As far as the minimum wages is concerned, since no other Sweeper is working on the post of regular Sweeper cum-Chowkidar in the School, the minimum pay scale be given/granted to the petitioner."

In compliance of the above said direction of the Hon'ble High Court the case of the petitioner was examined and it has been found that that the petitioner was engaged as part time class IV employee (Sweeper) on 08.05.2007 in GHS Giwana, Sonipat against unsanctioned post, only for two hours as per D.C rate and accordingly he has received his wages.

Whereas, as per departmental regularization policy dated 11.11.2003 district level common seniority list of all part time class-IV employees

working in Government Primary / Middle / High / Senior Secondary schools and field offices like O/o BEO's, SDEO's, DPEO's etc. as on 30.06.2003 was made for regularization of the services of class IV part time employees against vacant regular sanctioned posts and accordingly the District Education Officer, Sonipat also prepared that district level common seniority list as per Policy dated 11.11.2003, which was framed in compliance of order dated 20.02.2002 of the Hon'ble High Court, issued in C.W.P. No. 5926 of 2001 titled as Vidya Devi & others V/s State of Haryana & others. But the petitioner was engaged after 30-06-2003 i.e. on 08-05-2007. Therefore the petitioner does not come under the ambit of regularization under the departmental regularization policy dated 11-11-2003

Hence, keeping in view the above facts, the claim of the petitioner demanded through the present writ petition is not tenable and hence rejected being devoid of merits.

I order accordingly.
