Whereas, the petitioner namely Sh. Narender [5007492], PGT Sociology [Guest] approached the Hon'ble High Court by way of filing CWP No. 21478 of 2022 titled as Priyanka and others versus State of Haryana & others praying therein to quash the impugned transfer orders dated 11.09.2022, 12.09.2022 and 13.09.2022, Annexure P-8 to P-54.

This case came up for hearing before Hon'ble High Court on 19.09.2022 and the Hon'ble High Court disposed of the case with the directions to respondents as under:-

***"Notice of motion.***

***Mr. Harish Nain, Assistant Advocate General, Haryana accepts notice on behalf of the respondents and submits that the reasons for challenging the transfers being forwarded by the petitioner(s) are specific to them and in case, the petitioner(s) have already raised their grievances by filing of appropriate representation(s) or any representation, if filed manually till Wednesday i.e. 21.09.2022, will also be accepted and the same shall be looked into by the competent authority within a period of 10 days from today by passing an appropriate speaking order.***

***Learned State counsel further submits that in case, the petitioner(s) have not been relieved till today from the present place of posting then they will be allowed to continue at the present place of posting till the decision of the said representation(s) in case, the same are filed and in case, the petitioner(s) have already been relieved from the present place of posting, they will not be forced to join at the new place of posting till the decision of the said representation(s).***

***Learned counsel for the petitioner(s) submit that keeping in view the statement of the learned State counsel, the present petitions may kindly be disposed of as having been not pressed any further with liberty to the petitioner(s), who are yet to file the representation, to approach the respondents by filing appropriate***

**representation(s) raising their grievances as raised in the present petitions.**

**Ordered accordingly.”**

In compliance of the said orders, the representations of the petitioner (hereinafter referred to as claimant) has been examined at length. Petitioner is aggrieved by his transfer orders wherein he was transferred to Government High School Gangwani (724), Nuh Mewat from GGHS Siswala [1412] Hisar.

It is relevant to mention here that the 'Transfer Drive of Guest Teachers', was initiated in September, 2022, to ensure equitable, demand based distribution of teachers/heads to protect academic interest of students and optimize job satisfaction amongst its employees in a fair and transparent manner. However, some of Guest Teachers were not allotted station of their choice. After, Transfer Drive of Guest Teachers', number of Guest Teachers got posting far away from their previous place of posting and accordingly they submitted number of representation to the respondent Department. Thereafter, a uniform decision was taken to adjust the guest teachers in the district of their choice or on deputation till the next transfer drive. Accordingly, during adjustment of guest teachers in Nov-2022, petitioner was deputed as BRC Tohana, Fatehabad [5289] till the next transfer drive Thus, the grievance of the petitioner is resolved.




