Sh. Lalit Kumar S/o Sh. Chander Singh R/o 1630-A, Om Colony, Near Shiv Mandir, Band Gali, Jattal Road, Panipat filed a complaint dated 03.07.2017 against Dr. M.K.K. Arya Model School, Model Town, Panipat before the Fee & Fund Regulatory Committee, Karnal for charging increased admission fee/annual fee/development charges which were not mentioned by the school in their FORM-VI for the academic year 2017-18.

The Fee & Fund Regulatory Committee heard the complaint dated 03.07.2017 and passed an order dated 28.10.2022. The operative part of order dated 28.10.2022 passed by the Fee & Fund Regulatory Committee is as under:-

During hearing the Manager of Dr. M.K.K. Arya Model School, Model Town, Panipat submitted a copy of the DSE Hr Panchkula order No. 8/43-2022 PS(1) dated 26-05-2022 having a decision in the case titled as Students Parents welfare Group Vs OS DAV Public school Kaithal . Deponent School submits the above said order having facts similar to their school in which Director Secondary Education Haryana Panchkula mainly quotes that " Taking in to consideration above all facts, I am in the considered opinion that there was indeed technical glitch in the FORM-VI (which has been corrected vide notification No. 07/24-2020PS(4))dated 08.12.2021."

Hearing through complainant & school authorities and in view of the DSE Panchkula vides order no. 8/43-2022 PS(1) dated 26-05-2022 case filed by Sh. lalit Kumar against Dr. M.K.K. Arya Model School, Model Town, Panipat for charging excess fee and funds for the academic year 2017-18 as per FORM-VI , committee came to the conclusion that school is charging fee as shown in FORM-VI for the year 2017-18. Hence, case may be filed.

Order passed accordingly.

Whereas, Sh. Lalit Kumar S/o Sh. Chander Singh R/o 1630A, Om Colony, Near Shiv Mandir, Band Gali, Jattal Road, Panipat filed an appeal against the order dated 28.10.2022 of the Fee & Fund Regulatory Committee, Karnal under Rule 158B of Haryana School Education Rules, 2003 pleading to set aside the Order No. FFRC/ 2022/19-23 dated 28.10.2022 passed by the FFRC. The appellant further prayed that the additional charges charged by the

Respondent No.1 during the year 2018-19 be repaid to the aggrieved parents with interest.

In pursuance of this appeal, both the parties were called up for hearing on 07.02.2023. During the hearing, the appellant submitted that the respondent school hiked the fees unreasonably during the academic year 2018-19 and the school has charged fee from the appellant parents apart from the tuition fees which was not mentioned in FORM-VI of the academic year 2017-18. The Counsel on behalf of Dr. M.K.K. Arya Model School, Model Town, Panipat submitted that the school had been filling and submitting FORM-VI since last many years. The school, under Column 6 of FORM-VI had always provided a full statement of all its income under different heads namely admission fee, development fund, yearly charges and other income. The Counsel of the school also stated that the school submitted duly filled FORM-VI for the academic session 2017-18 in to the office of Block Education Office, Panipat vide letter No. MKK/2016/1075 dated 27.12.2016 and the same was received by Sh. Vijay Kumar, Clerk. Thereafter, the school submit one another additional information in regard to FORM-VI into the O/o Block Education Office, Panipat vide letter No. MKK/2016/1076 dated 29.12.2016 with the request to add Rs. 500/- per month for Class I to X and Rs.600/-per month for class XI-XII and the same was also received by Sh. Vijay Kumar Clerk. In these letters school mentioned the tuition fee as required under column 7 in FORM-VI. The respondent management stated that they had also mentioned the fee structure of the school in their prospectus and fee slip book. This fee structure had also been intimated to all stakeholders by way of notice displayed at the school notice board. Sh. Vijay Kumar Clerk also corroborated the facts that the MKK school had submit another additional information in regard to FORM-VI vide letter no. MKK/2016/1076 dated 29.12.2016 which was received by him and the same was also sent to the O/o District Education Office, Panipat.

In view of submissions of the parties and official record made available in the department, it is apparent that the school management had rectified its

omissions and submitted additional information in regard to their FORM-VI vide letter No. MKK/2016/1076 dated 29.12.2016. The fee structure had also been displayed at the school notice board and duly intimated to stakeholders through other modes by the school management. The school has been filling up FORM-VI as per the Haryana School Education Rules, 2003 and complainant also had due notice of the fee being charged by the school. Taking into consideration all the above mentioned facts, I am of the considered view, that Dr. M.K.K. Arya Model School, Model Town, Panipat duly submit its FORM-VI as per "Haryana School Education Rules, 2003" for the academic year 2017-18. Hence, I dismiss the appeal dated 30.11.2022 and uphold the order dated 28.10.2022 passed by the Fee & Fund Regulatory Committee, Karnal.

Whereas, Vaish Arya Kanya Senior Secondary School, Mal Godam Road, Bahadurgarh, District Jhajjar was granted permission upto 12th level vide order dated 06.08.1991 by the Director Secondary Education Haryana, Chandigarh.

Whereas, many complaints were received against Vaish Arya Kanya Senior Secondary School, Mal Godam Road, Bahadurgarh, District Jhajjar from Sh. Mohit Gupta & other residents of Bahadurgarh, Distt. Jhajjar wherein, it was alleged that Vaish Arya Kanya Senior Secondary School, Mal Godam Road, Bhadurgarh, District Jhajjar has opened a different branch for classes from 1st to 5th in the name of Vaish Arya Kanya Primary School, which is situated opposite to Punjab National Bank, Railway Road, Bahadurgarh District Jhajjar.

Whereas said complaints were enquired in to by a committee under the Chairmanship of Block Education Officer, Bahadurgarh. The committee submitted its report vide letter-Spl-1 report dated 21.04.2023 stating that the school management has been running primary classes from a separate premises situated opposite to Punjab National Bank, Railway Road, Bahadurgarh District Jhajjar.

Whereas the school was granted recognition/permission on the condition that it shall abide by the rules, regulation and instructions of the appropriate authorities issued from time to time under the Haryana School Education Rules, 2003.

Whereas, Rule 42 (3) of Haryana School Education Rules 2003, provides that branch opened by managing committee of a recognised school shall be treated as new school. Rule 42(3), which is reproduced here as under:-

"42(1) *****

(2) *****

(3) ***Branches opened by the managing committee of a school already recognized shall be treated as new schools for the purpose of recognition i.e. no managing committee is allowed to run two schools affiliated with different Boards/Council in the same building/premises.***

(4) *****

(5) *****

Whereas, Rule 3 provides that no school in the state can function, establish or start classes without the prior approval or permission of the Director and every school established by any individual or association of individuals or firm or society or trust or company, shall follow the norms specified under these rules. It further provides that any act or disobedience on the part of management of school managing committee contrary to the provisions of these rules shall make it liable under these rules.

In view of this, Vaish Arya Kanya Primary School, Punjab National Bank, Railway Road, Bahadurgarh District Jhajjar being a new school, must have obtained recognition from the competent authority. The management of school is at fault for opening a new branch.

Whereas Rule 42(1) of the Haryana School Education Rules, 2003 provides that the appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued there under to the managing committee either directly or through Principal/ Head of the institution.

Therefore, a show cause notice is being issued to the management of the said school as to why the recognition granted to the school not be withdrawn under Rule 3 read with Rule 42 of the Haryana School Education Rules, 2003.

The reply, if any, the Management of said school wants to submit, should be sent to this Department within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and the appropriate order shall be passed in accordance with Rules.
