No. 47/1/2017-5Pol.— Whereas in the opinion of the Governor of Haryana, the employment under the Data Centres as established and covered under Haryana State Data Center Policy, 2022 are essential for securing the public safety, the maintenance of public order and for maintaining supplies or services to the community.

Now, therefore, in exercise of the powers conferred under clause (ii) of the section 3 of the Haryana Essential Services Maintenance Act, 1974 (40 of 1974), the Governor of Haryana hereby, declares that said Act shall apply to the employments the Data Centres as established and covered under the Haryana State Data Centres Policy, 2022.
