

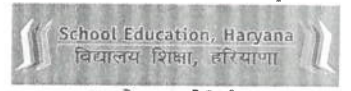

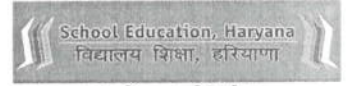

Whereas, Smt. Meena Kumari had filed the Civil Writ Petition No.10196 of 2023 titled as Meena Kumari vs. State of Haryana & Another in the Hon'ble Punjab & Haryana High Court praying therein for issuance of a writ in the nature of certiorari for quashing the promotion order dated 27.04.2023 (P-6) whereby the respondents have promoted the juniors of the petitioner standing at seniority numbers 467, 480, 490, 496 and 500, whereas the seniority number of the petitioner is 462. Further prayed for issuance of writ in the nature of mandamus directing the respondents to consider and promote the petitioner to the post of Deputy Superintendent as per her seniority, along with all consequential benefits

The aforesaid writ petition came up for hearing before the Hon'ble Punjab and Haryana High Court on 11.05.2023 and on that day Hon'ble Court was pleased to dispose of with the direction to respondent No.2 to decide the representation of the petitioner. The operative part of the said order is as under:-

In view of the above and without commenting anything on the merits of the case, the petitioner would be at liberty to move a representation for redressal of her grievances, within two weeks from today, if so advised.

On her doing so, respondent No.2-Director, Secondary Education Department, is directed to decide the said representation, within a period of eight weeks thereafter, by passing a speaking order, as per law.

Disposed of in the above terms.

Whereas, in compliance of the above said directions, the representation dated 19.05.2023 of the petitioner has been minutely examined by department and it has been found the petitioner namely Meena Kumari was initially appointed as clerk on 25.07.1989 on regular basis in Government Senior Secondary School Mahmudpur, Sonipat (3568) and was promoted to the post of Assistant vide order no. 2/2-2016 HRME-1(4) dated 16.11.2018 on the basis of seniority as on 01.08.2015. However, it is further clarified here that the examples quoted by the

petitioner namely Raj Bala at seniority no.467, Ramesh Chand at seniority no. 480, Satbir Singh at seniority no. 490, Anil Kumar at seniority no. 496 and Lumxi at seniority no.500 belong to reserved category of Schedule Caste, who were promoted as Assistant on 02.02.2011, 22.02.2011, 02.02.2011, 01.02.2011 and 01.02.2011 respectively and hence having the experience of 5 years as Assistant as per Service Rule, 1983, they were promoted to the post of Dy. Superintendent on 27.04.2023.

But the petitioner could not be promoted as Deputy Superintendent vide order 2/4-2021HRME-1(4) dated 27.04.2023 as she does not fulfil the condition of having 5 years' experience as an Assistant as per Service Rule, 1983 for the promotion to the post of Dy. Superintendent and hence the claim of the petitioner demanded through the representation dated 19.05.2023 is not tenable and hereby rejected.

Whereas, the petitioner had filed Civil Writ Petition No. 4631 of 2023 titled as Surender Kumar vs. State of Haryana & Others, before the Hon'ble Punjab and Haryana High Court, praying therein for issuance of a writ, order or direction in the nature of mandamus directing the respondents to regularize the service of the petitioner in view of regularization policy notified by the School Education Department vide memo 13/94-2000 ME (3) dated 11.11.2003.

The above-said Civil Writ Petition came up for hearing on 09.03.2023 before the Hon'ble High Court and on that day the same was disposed of with direction to decide the legal notice dated 01.11.2022 of the petitioner. The operative part of the said order is reproduced as under:-

Without expressing any opinion on the merits of the case, respondent No.2 is directed to decide the legal notice dated 01.11.2022 (Annexure P-16) by passing a speaking order within a period of eight weeks from the date of receipt of certified copy of this order.

Disposed of.

Whereas, in compliance of the above said directions of the Hon'ble High Court, the legal notice dated 01.11.2022 (Annexure P-16) of the petitioner was examined and it has been found that petitioner was engaged as Class-IV employees on part time basis against unsanctioned posts of peon on 18.08.2003 in GSSS Agondh, Karnal only for three and half hour per day for which he was paid remuneration according to the prevailing D.C. rates revised from time to time.

Whereas, according to previous departmental policy dated 30.12.1998/25.02.1999 the seniority of part time Class-IV employees was prepared at institutional level & as per this policy only those part time Class-IV employees were entitled for regularization of their services against vacant regular sanctioned posts who had requisite experience mentioned in the policy in the

institutions where sanctioned post of class-IV were available and the said policy was superseded by new departmental policy dated 11.11.2003.

Whereas, the question of regularization of the services of the petitioner under the New Departmental Policy dated 11.11.2003 is concerned, it is hereby clarified that as per the departmental regularization policy dated 11.11.2003, a common seniority list of all the part time Class-IV employees working in Govt./ Primary/Middle/High/Sr. Secondary Schools and the field offices like O/o BEOs/ SDOs/DPEOs/DEOs/ SCERT/DIETs/GETTIs etc. as on 30.06.2003 was prepared by the DEOs concerned at District Level and this seniority list of part time Class-IV employees acts as a reference point for sponsoring the names of the senior most person for regularization against the regular sanctioned post of Class-IV in the field offices/Schools of the Education Department. Therefore, on completion of the tenure of part time service mentioned in the policy dated 11.11.2003, the part time Class-IV employees are regularized from time to time on the basis of the above said seniority provided they would fulfill the others prescribed qualifications mentioned in the policy for regularization to the post of Class-IV.

Since the petitioner was engaged as part-time employee after 30.06.2003, therefore, the petitioners do not come under the ambit of the new departmental regularization policy dated 11.11.2003 and hence, the services of the petitioner cannot be regularized under the said new departmental policy dated 11.11.2003.

Keeping in view of the position explained above, the claim of the petitioner demanded through legal notices dated 01.11.2022 (Annexure P-16) is not tenable & hence rejected being devoid of merit.

I order accordingly.
