Whereas, the petitioners had filed the CWP No.1829 of 2020 titled as Umesh Kumar & Others vs. State of Haryana & Others before the Hon'ble High Court praying therein for issuance of a writ in the nature of certiorari quashing the order dated 17.09.2018 (Annexure P-8) passed by respondent No.2 in compliance to the order dated 01.06.2018 passed by this Hon'ble High Court in CWP No. 14943 of 2018 titled as Umesh Kumar & Others vs. State of Haryana & Others vide which the claim of the petitioners has been rejected. Further prayed for direction to the respondents to grant the minimum of the regular pay scale as extended to regular employees holding the same post and allow them the difference of wages as has been done by the state of Haryana vide order dated 12.04.2012 (P-3) along with interest @18% with all consequential benefits.

The above-said Civil Writ Petition came up for hearing on 02.02.2023. and on that day, the Hon'ble High Court was pleased to dispose of the same with some direction to the respondent. The operative part of the said order is as under:-

In view of the above, the impugned order dated 17.09.2018 is set aside and the Secretary/Director, Secondary Education, Haryana, is directed to re-consider the case of the petitioners in view of the judgments rendered by the Coordinate Benches in Ram Harsh's case (supra) and Bishan Singh's case (supra), and pass a speaking order within a period of eight weeks from the date of receipt of copy of this order.

Disposed of.

In compliance of the above said orders of the Hon'ble High Court, the legal notice dated 26.02.2018 of the petitioners has been re-examined and it has been found that the petitioners are working as part time sweeper in different schools since the year 2007 and they are performing the duties only for one and half hours per day, they are getting consolidated major emoluments as per prescribed rate of wages according to the timing of their work. The emoluments of the petitioners got enhanced as per instructions issued by the Government

from time to time. The petitioners had earlier filed the CWP No.14943 of 2018 which was disposed of on 01.06.2018 by the Hon'ble High Court and accordingly the claim of the petitioners had already been decided by the respondent Department by way of passing speaking order vide Order No. 13/74-2018 HRME (6) dated 17.09.2018.

Further it is also clarified here that the prayer in the CWP No. 1133 of 2010 and CWP No 9861 of 2012 cited by the petitioners is totally different from the present Civil Writ Petition as the petitioners in the cited writ petitions have pleaded that they are class IV part time employees in the Haryana Police Department and they are getting the reduced salary of Rs. 1920/- per month w.e.f 01.03.2009, whereas earlier they were getting the salary of Rs.2840/- per month. The said writ petition was allowed to get the salary at the rate of Rs. 5400/- per month in consonance to an employee who performs the similar duties as per rate Rs.5400/-per month. The case of the petitioner cannot be equated at par with the cited cases being having different facts and circumstances. In the cited cases the employees worked for 6 to 8 hours in the concerned department and the petitioners are performing their duties only for one and half hours. A mere nomenclature designating a person as part time sweeper is not enough to come to the conclusion that he is doing the same work in another department. Hence it is evident that petitioners only work for one and half hours per day.

Keeping in view of the above facts, the claim of the petitioner demanded through legal notice dated 26.02.2018 is not tenable and hence rejected being devoid of merits.

Whereas, the petitioner namely Minakshi had filed the CWP No. 37738 of 2018 titled as Minakshi Vs State of Haryana and others praying therein for the issuance of a writ in the nature of mandamus directing the respondent to regularize the services of the petitioner under instructions dated 11.11.2003/27.02.2004 from the date on which junior to the petitioner have been regularized i.e. 24.12.2017 and also prayed to release all consequential benefits arising out of it as well as to decide the legal notice dated 30.07.2018 by passing a speaking order within a stipulated period.

The above mentioned civil writ petition was listed for hearing on 20.12.2018 and on that day interim order was passed with direction to the respondents. The said interim order is reiterated here as under:-

On asking the court, Mr Harish Rathee, Sr. DAG Haryana accepts notice on behalf of the state. Learned Counsel for the petitioner shall supply copy of the petition to the learned state counsel by today itself.

In the meantime, the respondents shall pass appropriate orders on the legal notice given by the petitioner and place on record on the next date of hearing.

In compliance of above said interim order of Hon'ble High Court, the legal notice dated 30.07.2018 of the petitioner was examined and the claim of the petitioner was rejected by DEO Narnaul vide order no.E-3/2019-961-63 dated 22.07.2019.

Thereafter, the petitioner had filed CM-6420/22 in the present writ petition before the Hon'ble High Court for taking on record the letter dated 10.09.2019 (Annexure P-9), letter dated 14.01.2022 of DEO Bhiwani (Annexure P-10) as well as order dated 19.07.2019 passed in CWP No. 16086 of 2019 (Annexure P-11) and the same was allowed by the Hon'ble High Court on

29.10.2022 and the present writ petition was disposed of with direction to the respondent. The operative part of the order is as under:-

Without commenting upon the merits of the case or about the entitlement of the petitioner for the relief, which has been claimed by her in the legal notice dated 30.07.2018 (Annexure P-5), the present writ petition is disposed of with a direction to respondent No.2 to decide the legal notice dated 30.07.2018 (Annexure P-5) within a period of eight weeks from the date of receipt of copy of this order.

Whereas, in compliance of above said order of Hon'ble High Court, the legal notice dated 30.07.2018 (P-5) of the petitioner was again minutely examined and it has been found that the petitioner was engaged as part time Class-IV peon in the Government Middle School Nangal on dated 14.08.2003 against unsanctioned post. Therefore, as per department regularization policy dated 11.11.2003 the seniority of all the part time employee working in Govt. primary/ Middle/ High/ Sr. Sec. School and field offices like O/o DEOs, BEOs, DPEOs, SDEOs etc. as on 30.06.2003 was prepared at district level and this seniority list of part time Class IV employees made at district level acts as a reference point for sponsoring the names of the senior employees for regularization of their services against vacant regular sanctioned posts of Class IV and accordingly eligible candidates were regularized by department from time to time on the availability of vacant sanctioned post of Class IV.

Whereas the petitioner was engaged as a part time Class IV 13.08.2003 i.e. beyond the deadlines i.e. 30.06.2003 mentioned in the policy dated 11.11.2003 and hence the petitioner does not come under the ambit of the departmental regularization policy dated 11.11.2003. Further the petitioner quoted the example of sh. Shri Dutt in the present writ petition, saying that Sh. Shri Dutt was appointed on 24.08.2004 and hence junior to her but in actual sh. Shri Dutt was initially appointed as part time Mali on 21.08.2002 instead of 24.08.2004 and hence regularized w.e.f. 24.12.2016 vide order no. 315/16 dated

24.12.2016 in view of the departmental regularization policy dated 11.11.2003.
However, no junior of the petitioner has been regularized prior to the petitioner.

Keeping in view of the facts and circumstances of the case, the claim of the petitioner is not tenable. Hence, the claim of the petitioner is hereby rejected being devoid of merits.

School Namunda [2036], Panipat, was charge-sheeted under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order No. 16/48-2020 PGT-II (5) dated 27.08.2021 and the following charges were levelled against him:-

“That he i.e. Shri Devinder Singh [047696], PGT History, GSSS Deewana [2021], Panipat remained as ‘Drawing and Disbursing Officer’ (DDO) from 01.04.2019 to date. He was well versed with Case No. 24 dated 04.07.2019 lodged in Sector-29, Panipat under section 6 of ‘Protection Of Children from Sexual Offences (POCSO ACT) & Section 328 & 506 of the Indian Penal Code as well as of the National Human Right Commission, New Delhi Show Cause Notice No. 1584/7/15/2019-WC/LD/Full dated 12.07.2019 against Shri Sharwan son of Shri Bhan Singh resident of Deewana, who had allegedly raped a student of 11th class but failed to bring this serious incident in the notice of the Higher authorities which is a very serious lapse on his i.e. Shri Devinder Singh part.”

In context to aforementioned chargesheet, Sh. R.P. Bhasin, District & Session Judge [Retd.] was appointed as Inquiry Officer vide order No. 16/48-2020 PGT-II(5) dated 26.11.2021/02.12.2021 who submitted his enquiry report dated 25.02.2022. The conclusion of the said enquiry is as under:-


“Evaluating the evidence as noticed in the earlier part of this report, the only logical conclusions which can be drawn by legal/Judicial standards are that the prosecution has been able to prove the charges as highlighted in the earlier part of this report by acceptable legal evidence and accordingly while accepting the evidence of the prosecution and rejecting the evidence of the delinquent, I return firm findings in favour of prosecution and against the delinquent by concluding that the charges stood proved against the delinquent and I hold accordingly.”

In reference to the aforementioned enquiry report, Shri Devinder Singh, PGT History submitted his reply that the case laws mentioned in the enquiry report are not applicable to the facts of the present case. There were no malicious intentions of the delinquent. All the information and documents were supplied to different officers as and when the same were asked for, in writing and against receipt and nothing was concealed or withheld from being disclosed by the applicant. He also wrote letter No. 774 dated 09.07.2019 to Block

Officer, Panipat when the incident came in his notice. The said documents whereby the information and relevant record was submitted by the applicant was very much on the file, but the same were ignored by the Ld. Inquiry Officer while submitting the enquiry report. On the basis of these submissions, applicant requested to drop the charges imposed on him.

I found his reply satisfactory.

Hence, I pass the order to drop the above said charge-sheet disciplinary action against Shri Devinder Singh, PGT History, GSSS Diwana [2021], District Panipat now posted at Govt. Sr. Sec. School Namunda [2036], Panipat.
