Whereas, Crime Investigation Department vide its memo no. 3377/ शिकायत शाखा -3 गुन्तचर विभाग (Hry) Panchkula dated 26.04.2021 informed that certain schools including , H.C Public Sr. Sec School, Manjhawali, Faridabad, is being run without recognition from competent authority. An inquiry in this matter was marked to the Vigilance Team O/o Directorate of Secondary Education Haryana, Panchkula.

Whereas, the Vigilance Team, Directorate Secondary Education, Haryana, Panchkula consisting of Sh. Dalbir Singh, Administrative Officer, Vigilance, Sh. Sukhdev Singh, Superintendent, Vigilance, Sh. Prem Kumar, Superintendent HRG-I Branch, Sh. Umesh Kumar, Assistant, Admn. and Sh. Harinder Attri, Assistant, Vigilance, submitted its report vide memo no. 1/10-2021 Vig. Wing (1) dated 13.02.2023. In its report, it has been stated that the school namely , H.C Public Sr. Sec School, Manjhawali, Faridabad is being run without obtaining Change of Land Use Certificate, No Objection Certificate and Hygienic Certificate from the competent authority.

Whereas, H.C Public Sr. Sec School, Manjhawali, Faridabad, was granted permanent recognition for 9th to 12th level vide order G-13/11-2009 PS(4 dated 14.11.2009 under the provisions of Haryana School Education Rules, 2003 on the condition that it shall abide by the rules, regulations, instructions of the appropriate authorities issued from time to time under the Haryana School Education Rules, 2003.

Whereas Rule 30 of Haryana School Education, 2003 provides for the conditions for grant of the recognition to private schools of the State of Haryana. It requires that a private school shall have hygienic certificate for its sanitary arrangements from Chief Medical Officer/Local Medical Authority. Furthermore rule 31 of Haryana School Education Rules, 2003 provides that a school shall submit Change of Land Use Certificate at the time of applying for recognition.

Whereas, H.C Public Sr. Sec School, Manjhawali, Faridabad, has been running without Hygienic Certificate, Change of Land Use Certificate, in clear violation of rule 30 of Haryana School Education Rules, 2003.

Whereas Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School Education Rules, 2003. Rule 42 of Haryana School Education Rules, 2003 is reproduced here as under:-

Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution

(2) The recognition/NOC of the school shall lapse if the school,-

(a) xxxx

(b) xxxx

(c) xxxx

(d) xxxx.

(e) has not complied with one or more of the conditions of recognition, specified in these rules.

Therefore, a show cause notice is being issued to the school management of the said school as to why the recognition granted to the school may not be withdrawn under Rule 42 of the Haryana School Education Rules, 2003.

The reply, if any, the Management of said school wants to submit, should be sent to this Department within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and the appropriate order shall be passed in accordance with Rules.



DPSG Block-1, Palam Vihar, Gurugram, run by the Managing Committee, Delhi Public School, Ghaziabad Society, Site No.3, Meerut Road, Ghaziabad, Uttar Pradesh was granted permanent recognition/NOC upto 12th level vide order no. 23/18-2017 PS (4) dated 06.12.2017 by the Director Secondary Education Haryana, Panchkula under the provisions of Haryana School Education Rules,2003. A complaint was received against DPSG Block-1,Palam Vihar, Gurugram from Rajbala Dagar, Lalita Rana, Luxmi , Manju, Dinesh Sharma, Shravan, Rajesh and Rattan Lal, wherein, it was alleged that school management had issued notice for termination of their services. It was further alleged that their salary has not been paid from many months. It was further stated that they had already been facing personal issues due to COVID-19 and the termination of their services would aggravate their problems. Thereafter it was prayed that action be taken against the school.

Whereas, vide letter No. 38/58-2021 PS (1) dated 29.08.2022, the District Education Officer, Gurugram was directed to enquire this matter and submit a report. The District Education Officer, Gurugram submitted her report vide letter No. 922 dated 23.08.2022. In the report it was stated that school had not participated in the enquiry proceedings despite 8 reminders given to concerned school from 10.02.2022 to 05.07.2022. It was also recommended that action may be taken against the said school as per the rules.

Whereas a personal hearing was granted to the complainant and school management vide memo No. 38/58-2021 PS (1) dated 02.02.2023 by the competent authority, however, no one appeared on behalf of the school. Thereafter, reminders were sent to the school management vide memo No. 38/58-2021 PS (1) dated 20.02.2023 & 20.03.2023. The school management failed to attend personal hearing despite a number of opportunities given to the management.

Whereas, complainants have alleged that school management has not paid their salary for previous months. In this regard, Rule 30 of Haryana School Education Rules, 2003 provides that a school shall remain recognized from the department if the salary of teaching and non-teaching staff is paid regularly.

Therefore, before any action is taken a show cause notice is being issued to the management of the school as to why the recognition granted to the school not be withdrawn under Rule 42 of the Haryana School Education Rules, 2003.

The reply, if any, the Management of school wants to submit, should be sent to this Department within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and an appropriate order shall be passed in accordance with Rules.
