As per provision in the Haryana Civil Services (Compassionate Financial Assistance/Appointment) Rules, 2019, issued vide notification No. G.S.R. 32/Const./Art.309/2019 dated 02.08.2019. You are hereby appointed as Clerk on provisional basis in the office of Director Secondary Education Haryana, Panchkula in the pay band FPL-2 (19900-63200) of Schedule-1 pay matrix of Haryana Civil Services Schedule-I pay matrix of Haryana Civil Services (Revised pay) Rules, 2016 plus usual allowances as sanctioned by the Haryana Government from time to time, with effect from the date you resume duty in the office on the terms and conditions mentioned below:-

1. Your appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to you at present and in this respect you will have to take your claims like others who have been recruited similarly. Your services can be terminated without any notice, whenever there is no vacancy against which you can be retained.
2. If at any stage, you desires to resign from your post you will be required to give one month's notice or forfeit in lieu thereof, your salary including allowances for one month or for the period by which the notice falls is short of one month. Such a notice will be given to you by the Directorate also in case it is proposed to terminate your services for the reason other than that mentioned in clause (I) above.
3. You will be required to take the prescribed oath of allegiance to the Constitution of India.
4. In case you are married, you will produce the following certificate in this Head of office:- "That he/she is not having more than one living spouse." In case you are unmarried, you shall have to furnish a declaration to the effect that you will not have more than one living spouse.



5. In case you are unmarried, you will have to furnish a declaration to the Head of the Department that you have not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in-law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
6. As per Govt. Notification No. G.S.R. 65/Const.Art. 309/2013 dated 08.11.2013, the you shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC). You shall not be entitled to earn any increment in her pay-scale till you qualify the SETC Test failing which the services of such employees shall be dispensed with.
7. You will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
8. You will be required to produce the original Educational documents and date of birth certificate.
9. You shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining her duties.
10. You shall get themselves vaccinated and re-vaccinated at any time when so directed by the Government by general or special order.
11. No TA/DA and joining time will be paid to you for joining this post.
12. You will remain on probation for a period of two years, from the date of your appointment. The period of probation can be extended in accordance with the existing rule on the subject. For passing her performance during the period of probation, your work conduct will be taken into consideration, If your work and conduct during this period is not found satisfactory your services will be terminated without any notice.
13. Your appointment is subject to have passed 10+2 or its equivalent examination with Hindi.
14. Your services will be governed under the "NEW DEFINED CONTRIBUTORY PENSION SCHEME" of the Haryana Government as per Finance Department's notification dated 28.10.2005.
15. That in the matters, not specifically mentioned in this Communication, you shall be governed by the Civil Service Rules as applicable to Haryana Government employees and such rules/order /instructions as may be issued by the State Government from time to time. You shall further be governed by the "Haryana Education Directorate (State Service Class-III) Rules, 1974" as amended from time to time.





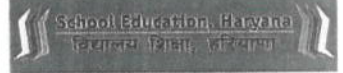

The petitioners had filed the CWP No. 8021 of 2023 titled as Vijay Kumar & Others vs. State of Haryana & Others in the Hon'ble High Court of Punjab & Haryana, Chandigarh, praying therein to grant/release annual increment to petitioners w.e.f 2018 and to release all consequential benefits.

The present case came up for hearing before the Hon'ble Punjab & Haryana High Court on 19.04.2023 and on that day the Hon'ble High Court was pleased to dispose of the same with direction to undersigned. The operative part of order is as under:-

Notice of motion.

On the asking of this Court, Mr. Rajesh Gaur, Addl. A. G. Haryana, accepts notice on behalf of the respondents-State and submits that he has no objection if the aforesaid limited prayer made by the learned counsel for the petitioners is allowed.

In view of the above, the present petition is disposed of with a direction to respondent No.2-Director, School Education, Haryana, to decide legal notice dated 17.09.2021 (Annexure P-4) moved by the petitioners, within a period of eight weeks from the receipt of the certified copy of this order, by passing a speaking order, as per law.

In compliance of the above said direction of the Hon'ble Punjab & Haryana High Court, the legal notice dated 17.09.2021(P-4) of the petitioners has been examined at length and it has been found that the petitioners were promoted to the post of clerk from Group-D post vide Order No. 2/9-2017-HRME (5) dated 14.09.2017 subject to the applicability of amended service rules in view of the notification dated 08.11.2013 of Haryana Education Department, Sub-offices, Ministerial (Group-C) Service (Amendment) Rules, 2013 regarding passing of type test.

As per Notification No. G.S.R.65/Const./Art.309/2013 dated 08.11.2013 of Haryana Education Department, Sub-offices, Ministerial (Group-C) Service (Amendment) Rules, 2013, the following rule was inserted: ***“the existing Clerks, who have been promoted from Group-D and Restorer etc. Who have not passed the typing test till date as required under the Services Rules shall have an option either to pass the typing test or the State Eligibility Test in Computer Appreciation and Applications (SETC).*”**

As per Rule 4(2) of Notification No. G.S.R.65/Const./Art.309/2013 dated 08.11.2013 of Haryana Education Department, Sub-offices, Ministerial (Group-C) Service (Amendment) Rules, 2013, the persons who are promoted to the post of Clerk and Steno-typist shall also qualify the State Eligibility Test in Computer Appreciation and Applications (SETC) within the period of probation of one year extendable by one year, failing which he/she will be reverted back.

In addition to that the Proviso to Rule 38 the Haryana Civil Services (Pay) Rules, 2016 clearly provides the condition of passing Departmental test for grant of increment. The same is as under:-

“Rule 38- Grant of increment in case departmental test is a pre- condition:-

Provided that on appointment by promotion to such a post, the presumptive basic pay of feeder post shall, if it is more advantageous, be admissible till qualifying the departmental test or fulfilling of other conditions prescribed for normal increment of promotional post”.

Further in continuation of instruction issued vide number 42/164/2008-3GS-II dated 7.11.2013, the Government has issued instruction No.17/28/2018-3GSII dated 17.11.2018 and incorporated provision regarding qualifying both the Part-1 (Knowledge test) and Part-II (typing test) of the SETC which shall be compulsory for all clerks who are currently working and all those who want to work as clerk on promotion or by direct recruitment. No further increment or promotion (where applicable) will be allowed to clerks without

passing both the components of SETC i.e. Part-1 (Knowledge test) and Part-II (typing test). It is further clarified vide instructions No. 17/30/2020-3GS-II dated 22.12.2020 that all clerks who have been promoted after 07.11.2013 shall have to clear SETC test. During maximum duration of two years they get ten chances to qualify. Instructions are as under:-

(3)(c) That all those persons who have been appointed/promoted to the post of clerk after 07.11.2013 shall have to clear SETC test.

(d) 10 chances to qualify the SETC exam shall be provided to all those who have been promoted after 07.11.2013, during maximum duration of two years irrespective of the chances availed earlier. The ten chances (irrespective of any chances availed earlier) shall also be allowed to all the persons who have been reverted due to non-passing of SETC.

Thereafter, as per Government Notification No. 17/02/2021-3GS-II dated 30.03.2021 all persons, who are promoted to the post of clerk shall to qualify SETC to be eligible for increment or promotion.

Whereas, the petitioner cited the examples of CWP No. 5566 of 1999 titled as Prithvi Raj Versus State of Haryana and Others and CWP No. 4585 of 2009 titled as Rama Nand Versus State of Haryana and Others, wherein the petitioners were allowed the benefit of annual increments along with arrears of pay in compliance of the direction of Hon'ble High Court however before the issuance of Notification No. G.S.R.65/Const./Art.309/2013 dated 08.11.2013 of Haryana Education Department, Sub-offices, Ministerial (Group-C) Service (Amendment) Rules, 2013. Resultantly, the case of the petitioners does not cover under the purview of judgments passed in above-said civil writ petitions, because the petitioners were promoted as clerks from Group-D in the year 2017 after the issuance of above said Notification dated 08.11.2013 & hence the same is applicable to them.

Therefore, in view of the facts mentioned above, it is clear that passing of SETC test is an essential requirement for the post of clerk which petitioners have not passed till date. Therefore, the claim of the petitioners for annual increment demanded through legal notice dated 17.09.2021(P-4) is not tenable and hereby rejected being devoid of merits.

I order accordingly.

Smt. Seema and others have filed Civil Writ Petition No. 2161 of 2019 titled as Seema & ors. Vs. State of Haryana and others in the Hon'ble High Court of Punjab and Haryana at Chandigarh with the following prayer for issuance of a writ of mandamus be issued to the respondents to decide the legal notice dated 10.10.2018 in view of the judgments passed by the Hon'ble High Court in the writ petition no. 7862 of 2006 Hanumant Singh and others vs. State of Haryana by counting the period of ad hoc service of the petitioner for the purpose of seniority and for grant of other reliefs as prayed for.

The aforesaid writ petition came up for hearing before the Hon'ble High Court on 24.11.2022 and on that day Hon'ble Court was pleased to dispose of the matter with direction to respondents which is as under:-

“Learned counsel for the petitioners submits that though the present writ petition has been filed seeking the benefit of seniority for the ad-hoc service rendered by the petitioners but as the claim of the petitioners is still pending consideration with the respondents keeping in view the legal notice dated 10.10.2018 (Annexure P-3), the petitioner will be satisfied at this stage, in case a time bound direction is issued to the respondents to decide the said legal notice by passing an appropriate speaking order.

Learned counsel for the respondents raises no objection in deciding the legal notice of the petitioners dated 10.10.2018 (Annexure P-3) in a time bound manner by passing an appropriate speaking order.

Without commenting upon the merits of the case or about the entitlement of the petitioners for the relief which has been claimed by them in the legal notice

dated 10.10.2018 (Annexure P-3), the present writ petition is disposed of with a direction to respondent No.2 to decide the legal notice dated 10.10.2018 (Annexure P-3) within a period of eight weeks from the receipt of copy of this order”.

Haryana Veterinary and AHTS Association & another, 2000(4) SCT 664, in Civil Appeals Nos. 5740-5741 of 1997, State of Haryana Vs. Ravinder Kumar & other connected matters, in State of Haryana Vs. Sita Ram, 2014(1) SCT 515 and a series of judgments delivered by Hon'ble Supreme Court held that 'the expression which is recurrent in these schemes/ Rules and the burden of the song played of minimum requirement of regular satisfactory service or regular service, the intention of the Government that the service to be reckoned for the purpose for grant of time bound promotional benefits such as Additional Increments/ ACP Scales is without doubt REGULAR SERVICE and not just service so as to be inclusive of temporary, ad-hoc or work charge service, and this plain meaning is clearly discernible through the thread of the concession of ameliorate stagnation in service which was accepted bane of efficiency in administration so that the will to work is not stifled. *(ii) The petitioners **are not entitled** to benefit of Additional Increments for the period of their ad hoc/ work-charged service on completion of 8/18 years of service as well as 10/20 years, since such period does not qualify as regular satisfactory service as per modified scheme dated August 7, 1992.*

It is also relevant to mention here that in an identical matter i.e. an SLP i.e. Civil Appeal No. 5947 of 2012 (Arising out of SLP (C) No. 29274 of 2009) titled as State of Haryana and others vs. Vijay Singh & others preferred in the CWP No. 2409 of 2008 titled as Vijay Singh & others vs. State of Haryana and others, judgment dated 18.08.2008 of the Hon'ble High Court was set aside and Writ Petition was dismissed by the Hon'ble Apex Court. The operative part of the order dated 22.08.2012 passed by the Hon'ble Supreme Court is reproduced below:

"As a corollary to this, we hold that the direction given by the High Court for re-fixation of the respondents seniority by counting the ad-hoc services cannot be approved.

In the result, the appeal is allowed, the impugned order is set aside and the writ petition filed by the respondents is dismissed. The parties are left to bears their own costs."

Thus, the claim of the petitioners for the counting of ad-hoc services for seniority and grant of additional increments/ACP pay scale is not tenable.

Hence, the claim of the petitioners is rejected being without any merits.

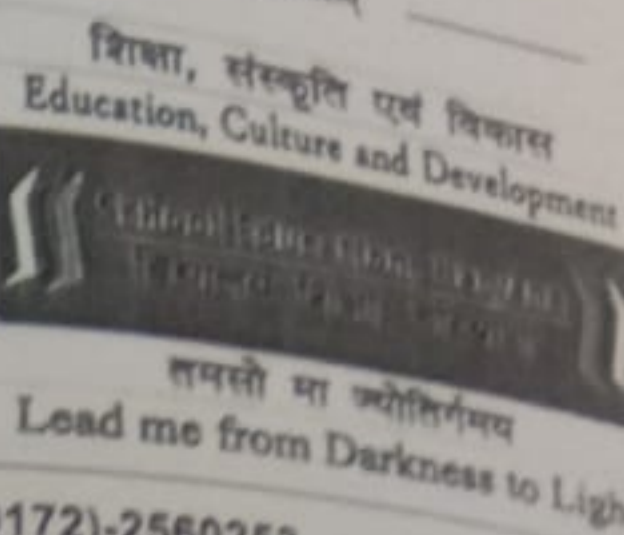
