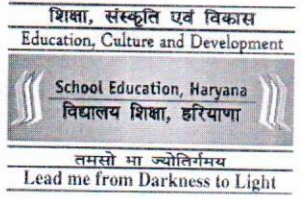

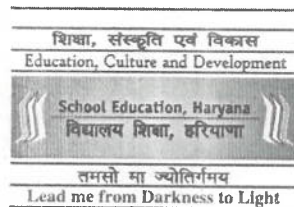

Sarasvati Vidya Mandir Sr. Sec. School, Karawara Manakpur, Rewari, run by the Managing Committee, S.S Educational Society, Karawara Manakpur, Rewari was granted permanent recognition/NOC upto 12th level vide order no. G-3/10/667 dated 31.12.2010 under the provisions of Haryana School Education Rules, 2003.

Whereas, vide letter No. 7823/SS dated 06.07.2023 & vide letter No. HSSPP/2023/IT/8060-8133 dated 10.07.2023 all Principals/Headmasters of Government as well as Private schools running in the State of Haryana, were directed to upload details of school infrastructure, teachers and students on the U-DISE Portal. However, management of Sarasvati Vidya Mandir Sr. sec. School Karawara Manakpur, Rewari, failed to upload required data on U-DISE Portal. It was also intimated through these letters that in case any school failed to upload such data then the department may withdraw the recognition of the school. On repeated occasions Block Resource Co-Ordinator, Jatusana, Rewari directed the school management to upload the required data on U-DISE Portal.


Whereas, vide letter No. 6/36-2023 PS (1) dated 27.07.2023, the District Education Officer, Rewari was directed to enquire this matter and submit a report. The District Education Officer, Rewari submitted her report vide letter No. SPL-27/2023 dated 03.08.2023. In the report, it was concluded that the school management had not uploaded the U-DISE data. It was also recommended that action may be taken against the said school as per the rules.

Whereas, Sarasvati Vidya Mandir Sr. Sec. School Karawara Manakpur, Rewari was granted permanent recognition up to 12th level vide order G-3/10/667 dated 31.12.2010 under the provisions of Haryana School Education Rules, 2003, on the condition that it shall abide by the rules,

regulations, instructions of the appropriate authorities issued from time to time under the Haryana School Education Rules, 2003.

The Rule 42 of Haryana School Education rules, 2003 empowers appropriate authority to withdrawn recognition granted to the school for non compliance of instruction issued by the appropriate authority. Tarun Dhiman i.e. vide No. 258 dated 17.12.2022 at Police Station, Dhand (Kaithal), No. 603 dated 17.12.2022 at Police Station, Pundri (Kaithal), No. 547 dated 02.06.2022 at Police Station, Shahabad (Kurukshetra) and No. 502 dated 12.07.2022 at Krishna Gate Thana (Kurukshetra). The said FIRs were lodged due to the reason that the school authorities concerned stated that one Sh. Tarun Dhiman duped and defrauded them for obtaining the affiliation from the Central Board of School Education, New Delhi on the basis of fake NOC which were not issued by the Director Secondary Education, Haryana, however, the Director Secondary Education, Haryana is the competent authority for the same.

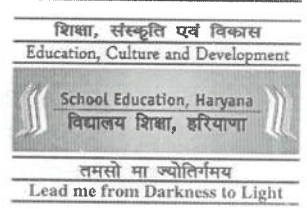
