

Sh. Kunal Malik S/o Sh. C.S Malik Singh R/o House No.1121, Sector 37. Faridabad filed a complaint dated 05.03.20218 against M.V.N. Aravali Hills School, Sector 43, Faridabad before the Fee & Fund Regulatory Committee, Faridabad alleging that the school is being run in violation of Haryana School Education Rules, 2003. He alleged that the school management has been illegally transferring money against the legal provisions and the school management does not maintain records of annual income and expenditure incurred by it. He further alleged that the school management has been increasing school fee without any approval of parents association.

The Fee & Fund Regulatory Committee, after hearing the parties, passed an order dated 27.12.2019. The operative part of order dated 27.12.2019 passed by the Fee & Fund Regulatory Committee is as under:-

"I have perused the above sequence of events and various representations/ complaints submitted by both the parties, as well as the contentions made by the school authorities it was observed that the school had filed Form VI within the stipulated timeframe prescribed under Rule 158(2). The school has not charged any capitation fee and was charging fees according to what has been declared in Form VI. It was further observed that the school had complied with the norms/ parameters prescribed in the directives given in the order dated 18.5.2017 passed in appeal under Rule 158(B) of the Haryana School Education Rules, 2003 by the Addl. Chief Secretary to Govt. Haryana, School Education Department and the guidelines issued vide letter No. KW 8/27-2013 PS (2) dated 22.5.2017.

I am of the considered opinion that the various complaints by parents regarding charging of exorbitant fee in violation of the prescribed rules are not proved and deserve to be rejected. The School has submitted a detailed plan for deployment of cash reserves. The funds are meant for up gradation of sports infrastructure, basic operation and maintenance of buildings and futuristic addition to pedagogy and the joy of learning of the students. Hence, the complaints regarding charging of fee in violation of rules by MVN Aravali Hills School, Sector 43, Faridabad for the academic sessions 2015-16, 2016-17 & 2017-18 are not made out."

The complainant (hereinafter referred as appellant) filed an appeal against the order dated 27.12.2019 of the Fee & Fund Regulatory Committee, Faridabad under Rule 158B of Haryana School Education Rules, 2003 pleading therein to set aside the order No. FFRC/ 2019/378-75 dated 27.12.2019. The appellant further prayed that the unreasonable fee amount paid to school be repaid to the appellant.

In pursuance of this appeal, both the parties were called for hearing on 26.06.2023. During the hearing, the appellant submitted that the respondent school made unreasonably hike in school fee during the academic year 2015-16, 2016-17 & 2017-18. It was also submitted that fee charged by the school is more than the fee mentioned in FORM VI of the year 2015-16, 2016-17 & 2017-18. The Counsel appearing on the behalf of M.V.N. Aravali

Hills School submitted that the school has been filling and submitting FORM-VI since last many years. The school, under Column 6 of FORM-VI had always provided a full statement of all its income under different heads namely admission fee, development fund, yearly charges and other income.

In view of submissions made by parties and official record made available by the department, I am of the opinion that the management had mentioned fee structure in their prospectus and fee slip book. This fee structure had also been duly intimated to stakeholders through other modes. The school has been filling FORM-VI regularly as per the Haryana School Education Rules, 2003 and complainant also had due notice of the fee being charged by the school. As per report of chartered accountant the school management has increased school fee in a reasonable manner. Hence I, dismiss the appeal dated 24.01.2020 and uphold the order dated 27.12.2019 passed by the Fee & Fund Regulatory Committee, Faridabad.

I order, accordingly.
