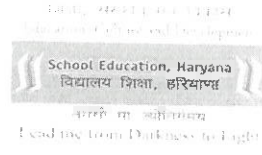

Whereas, Sh. Ranjodh Singh [5007256], PGT History [Guest], GSSS Dauhala [754], Block Sohana, District Gurugram was charge-sheeted under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 16/50-2021 PGT-II(5) dated 08.07.2021 and the following charges were leveled against him:-

“That he i.e. Ranjodh Singh, Post Graduate Teacher History, Government Senior Secondary School, Daulah, Sohna (Gurugram) filled up wrong numbers in the mark list while deputing with the Board of School Education, Bhiwani for marking answer sheets of Social Science subject for Secondary examination held on March, 2020. Due to such mistake, result of 117 students were to be modified, therefore, they had to face mental torture and image of the Board of School Education, Bhiwani has also been tarnished.”

The charged officer submitted his reply to the said charge-sheet whereby he submitted that he was allotted duty of examiner by Haryana School Education Board, Bhiwani during session 2019-20. He was given answer sheets of Social Studies by Sh. Hukam Singh, Social Studies Teacher, Govt. Model Sr. Sec. School Sohna [Gurugram] who was deputed as Controller-cum-Chief Examiner. Further, he stated that he carefully checked the answer sheets and returned it to Sh. Hukam Singh and claimed that he had not filled the obtained marks in mark list. However, vide order No. 041/गोपनीय-|| dated 22.10.2020 of Haryana School Education Board, Bhiwani, he was banned for next three years as well as was directed to deposit total remuneration amounting to Rs. 3,120/-, which has already been deposited by him. Moreover, they demanded disciplinary action against him from this Department.

Thereafter, the charged officer was granted an opportunity of personal hearing on 17.07.2023. During the course of hearing, the charged officer reiterated the contents of his earlier reply and submitted a rebuttal and

cited the Article 20 (2) of the Constitution of India which provides protection against 'double jeopardy' and requested to drop the said chargesheet.

Keeping in view the facts of the case, reply of charged officer and documents on record, I am inclined to accept his reply. Consequently, chargesheet u/r -7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 issued against Sh. Ranjodh Singh, PGT History [Guest] vide order No. 16/50-2021 PGT-II(5) dated 08.07.2021, is hereby *withdrawn* and the Show Cause Notice dated 01.12.2022 u/r 6(1) of Haryana Guest Teacher Act, 2019 is also *filed*.






