Whereas, the petitioners namely Smt. Santosh Khatak, Sarla, Rekha Gupta, Indu Bala, Sunita, Sushma Rawal had approached the Hon'ble High Court by way of filing the present CWP No. 24008 of 2017 titled as Santosh Khatak and others versus State of Haryana & others praying therein for issuance of writ of mandamus directing the respondents to grant additional increments to the petitioners on account of acquiring higher qualifications of M.Phil/Ph.D as per Government instruction dated 24.04.2014 bearing Memo No. 10/01/2014-3GSII (Annexure P-1) from the date of acquiring higher qualification.

After considering the prayer made in the writ petition, the Hon'ble High Court passed an order dated 11.04.2023, the operative part of the said orders is as under:-

"Notice of motion.

On the asking of this Court, Mr. Rohit Arya, DAG Haryana, accepts notice on behalf of respondents and submits that he has no objection in case, the directions for deciding the representation of the petitioners, are issued.

In view of the above, the petitioners are given liberty to move a fresh representation within 15 days from today. Upon receipt of such representation, respondent No.2-Director Secondary Education, Haryana, shall decide the same, within a period of eight weeks thereafter, in accordance with law.

Disposed of."

In compliance of the Hon'ble High Court orders the case of the petitioners has been examined and it is found that the matter of grant of incentive for higher qualification was considered by the Council of Ministers in its meeting on 26.10.2016 and it was decided vide memo No. 10/1/2014-3GS-II dated 17.01.2018 to withdraw such grant of incentive for acquiring higher qualification except where specifically provided in the service rules in the concerned department's Service Rules of the post.

Council of Ministers further approved that no Government Employee shall claim higher pay scale on the ground of possessing higher qualification than essential qualification of the post at the time of entry into Government Service or on acquiring higher qualification during the service and the employee will be entitled only to the pay scale prescribed for the post in the departmental Service Rules.

Thus, the claim of the petitioners for additional increments and arrears thereto in view of Government of Haryana circular dated 24.04.2014 bearing Memo No. 10/01/2014-3GS-II is not tenable and therefore rejected in light of the fact that the circular dated 24.04.2014 bearing Memo No. 10/01/2014-3GS-II stands withdrawn vide memo No. 10/1/2014-3GS-II dated 17.01.2018.



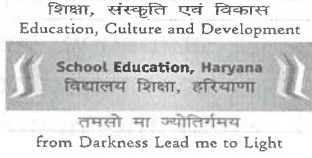

Terms and conditions:-

1. The benefit of ante-date appointment will be admissible w.e.f. 14.12.2013 from the date when his/her juniors have been appointed only for notional pay fixation & seniority and actual financial benefits will be admissible to him/her from the date he/she joins duty as **PGT Punjabi**.
2. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.

 16. The appointment will be subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
