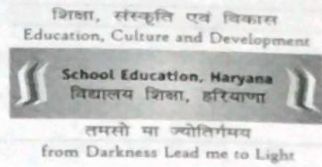

**ORDER**

On the recommendation of Haryana School Teachers Selection Board, Panchkula conveyed vide their Memo No. 2/1/2013-HSTSB/2013/CA dated 20.03.2013, the Governor of Haryana is pleased to appoint the following candidates as Post Graduate Teacher (PGT) **Punjabi** (HES-II) against Advt. No. 1/2012 in the pay band of Rs. 9300-34800 + Grade Pay 4800/- plus usual allowances as admissible from time to time. He/She directed to join at the place of posting as mentioned below:-

**Terms and conditions:-**

1. The benefit of ante-date appointment will be admissible w.e.f. 14.12.2013 from the date when his/her juniors have been appointed only for notional pay fixation & seniority and actual financial benefits will be admissible to him/her from the date he/she joins duty as **PGT Punjabi**.
2. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
3. He/She shall have to take an oath of allegiance to the Constitution of India.
4. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt him/her from this condition.
5. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
6. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
7. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules as

applicable to Haryana Government Employee and such orders/ instructions as may be issued by the Government from time to time.

8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be, is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
9. Candidate is hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned alongwith photostat self- attested copies. District Education Officer is directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
10. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining. District Education Officer will also give character and antecedent verification forms to his/her and after filling the form, the candidate would submit it to the District Education Officer concerned immediately.
11. He/She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
12. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
13. No TA/DA will be admissible to the candidate for joining as PGT.
14. If he/she gets an appointment as PGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information / facts which are detected later on, he/she would be liable for termination of service without any notice.
15. In case, he/she has not passed STET/HTET and B.Ed. as yet, he/she shall have to qualify HTET and B.Ed. as mentioned in Rule 19A of the 'Haryana State Education School Cadre (Group-B) Service (Second Amendment) Rule, 2012' amended from time to time, otherwise his/her appointment shall stand terminated automatically without giving any further notice.
16. The appointment will be subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
17. The exercise of the verification of character and antecedents should be carried out within a period of three months. Once the verification report is received and there are no objections on the facts given by the candidate, the provisional appointment letter will be confirmed.

18. If he/she is willing to accept this offer of appointment as PGT, HES-II (School Cadre) on the above terms and conditions, he/she should submit his/her joining report as per aforesaid directions.



Therefore, you are directed to issue appointment letters to who are the dependents of Deceased Govt. employee against vacancy immediately. It is also advised that the verification of their documents i.e. medical fitness, original certificates of educational qualification, character certificate up to the satisfaction of service rules and the following terms and conditions must be depicted in his appointment letter:-

1. Verify the documents of educational quification, certificate of resident of Haryana, NOC of any criminal case no pendency of court case and must verify the character certificate of candidate prior to issue appointment letter.
2. Before issue appointment letter must be verify the medical certificate which is issued by the concerned Civil Surgon.
3. The appointment should be issued against the vacant post.
4. Must be checked the prescribed age of the candidate before issue appointment letter.
5. At any time if found any suspicious regarding his character his services will be terminated without any notice.
6. Service rules of Haryana Civil Services Rules, 2016, Rules, 1994, Rules 1998 and instructions issued by the Haryana Government from time to time must be obeyed by the candidate.
7. No TA/DA will be entitled for this appointment.
8. The candidate must file an affidavit regarding his marital status, if he married then must be submitted an affidavit regarding only one alive spouse prior to issue appointment letter.
9. The terms and conditions specified by the department regarding seniority and any amendment in the rules must be obeyed by the candidates.
10. The probation period must of two years and if found at any stage any adverse regarding character then the probation period can be extended.
11. The services can be terminated without any notice if found any wrong statement at any time.



The following person who are working as Social Studies Mistresses in the Aided Schools and have opted voluntarily in accordance with the provision made in Haryana Voluntary State Education Service Rules, 2017 and found suitable for appointment in accordance with the provision made in aforesaid rules is hereby appointed to the post of Social Studies Mistresses/TGTs Social Studies in the Haryana School Education Department in the pay scale as mentioned in FPL 7 of the Schedule 1 of the Pay Matrix of the Haryana Civil Services (Revised Pay) Rules, 2016 plus usual allowances as admissible under the State Government Rules from time to time.

Further, they are posted in the Govt. Schools mentioned against their name with the following terms and conditions:-

**Terms & Conditions**

1. They are appointed purely on temporary and provisional basis.
2. These appointments are against temporary posts and their confirmation against substantive posts shall be considered on the basis of their seniority and record of service as and when such posts are available.
3. They shall have to take an oath of allegiance to the Constitution of India.
4. They shall produce a certificate before joining the duties to the effect that they have one living wife/husband in case he/she is married. None of them who has more than one living wife/husband, shall be eligible for appointment to the post offered unless the Government after being satisfied that there are special grounds for doing so, exempt him/her from this condition.
5. They shall not be allowed to apply for any post outside the department for a period of at least five years.
6. They shall not claim seniority on the basis of these orders. Their inter-se seniority will also be decided in accordance with the department rules and instructions of the State Government later on.

7. In other matters, not specifically mentioned in this communication, they shall be governed by the Civil Services Rules as applicable to Haryana Government Employees and such orders/instructions as may be issued by the Government from time to time.
8. They are further directed to show their original certificate of academic qualifications, experience and other relevant certificates to the concerned District Elementary Education Officer of their present place of postings. District Elementary Education Officer would verify the genuineness of their original certificate.
9. Their appointment is subject to the condition that in case they have not produced medical fitness certificate at the time of their initial appointment in the aided schools than concerned District Education Officer will ensure that they shall submit their medical fitness certificate first duly issued by the Medical Board only then they should join as Social Studies Mistresses in the concerned school.
10. Their appointment letter is provisional subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
11. If in case character and antecedents of they are found not verified or any false information is given by them in their self declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken as per provisions of Indian Penal Code (IPC) etc. as deemed fit.
12. The exercise of the verification of character and antecedents should be carried out within a period of two months. Once, the verification report is received and there is no objection on the facts given by them, the provisional appointment letter will be confirmed.
13. They shall be governed by the Haryana School Education (Group-C) State Cadre Service Rules, 2012.
14. If at any time during the course of their temporary appointment, any of the appointee desires to resign, they shall be required to give one month's clear notice or forfeit, in lieu thereof, their salary including allowances etc. for one month or for the period by which the notice falls short of one month. Such a notice will be given to them by the Government also in the case if it is proposed to terminate their services in lieu thereof the Government will be liable to pay their salary, including allowance for one month or for the period by which the notice falls short of one month.
15. No TA/DA will be admissible to the candidates for joining as Masters/Mistress.
16. If they get an appointment as Masters/Mistress on the basis of their furnishing false or fraudulent information/ facts/documents which are detected later on, they would be liable for termination of service without any notice.
17. The appointment under these rules shall be a fresh appointment made on the minimum of pay scale of that post however, the salary of the employee appointed under these rules shall be protected as a measure personal and shall not be less than the salary which he/she is already drawing. The past service rendered shall not be counted for any other intents and purposes except pensionary benefits.
18. An employee appointed under these rules shall not be entitled for any promotion till they attains the age of superannuation.
19. An employee under these rules shall be governed by the Haryana Civil Services (Pension) Rules, 2016.



20. An employee appointed under these rules shall be entitled for the amount of contribution towards New Pension Scheme alongwith interest liable to be paid by the concerned aided school management for the service rendered in the said school and the Management shall pay the same within a period of one month to the concerned quarters.
21. Arrears of any kind in respect of the employees who are working in aided schools and are appointed under these orders shall not be paid by the Government for the period prior to the date of appointment in the Service.
22. No grant-in-aid shall be payable to the aided schools in respect of the posts which have been taken over in the Service.

Whereas an appeal dated 18.05.2023 has been filed by Rishi Gyan Educational Social Development Research Society for setting aside the order dated 22.04.2023 passed by Director Secondary Education, Haryana Panchkula vide which the recognition of said school was withdrawn w.e.f. academic session 2022-23 for violation of Rule 43 (1) of Haryana Education Rules, 2003.

Earlier the Registrar, Sonipat vide order no. 281-84/HRC dated 31.01.2020 had cancelled the registration of the land in the name of Rishi Gyan Educational Social Development Research Society, Ganaur, Sonipat using his power under Section 68 of the Registration Act, 1908. This order was the basis for the impugned order dated 22.04.2023.

During the course of hearing on 09.08.2023, the appellant produced a copy of order dated 02.11.2020 passed by the Hon'ble Court of Additional Civil Judge (Sr. Divn.), Ganaur, Sonipat. The operative part of the order dated 02.11.2020 is reproduced here as under: -

*".....So, the present application moved under Order 39 Rule 1 and 2 read with Order 39 Rule 4 and section 151 CPC stands allowed in toto and disposed off accordingly and order dated 31.01.2020 being passed by Registrar/Collector Sonapat shall not be acted upon till the disposal of this suit."*

Accordingly, after hearing all the facts & going through the order dated 02.11.2020 *supra*, the order in question bearing memo no. 6/74-2020 PS (4) dated 22.04.2023 passed by Director Secondary Education, Haryana, Panchkula is hereby stayed till the final outcome of Civil Suit No. 331 of 2016 pending before the Hon'ble Court of Additional Civil Judge, Ganaur, Sonipat.



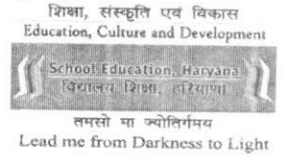
