**SHOW CAUSE NOTICE**

**Memo No. 6/93-2022 PS (1)**

Heritage Education Society 17<sup>th</sup> K.M Stone Gurgaon Farrukh Nagar Road, VPO Sultanpur, Gurugram, was granted permanent recognition for running school namely Tej Vidyapeeth School, 17<sup>th</sup> K.M Stone Gurgaon Farrukh Nagar Road, VPO Sultanpur, Gurugram upto 10th level vide memo 23/351-03 S-I (1) dated 28.06.2004 under Haryana School Education Rules, 2003.

A complaint was received against Tej Vidyapeeth School from Sh. Amarbir Kataria Son of Sh. Jagbir Katari R/o Gurugram. It was alleged in the complaint that the above mentioned school got the permission/ recognition from the Directorate of Secondary Education, Haryana, Panchkula through forged bank guarantee documents.

The District Education Officer, Gurugram vide letter No. 6/186-2022 PS (1) dated 09.02.2023, was directed to enquire this matter and to submit a report. The District Education Officer, Gurugram submitted her report vide letter No. E-3/2023/1605 dated 16.03.2023. In the report it is stated that the school had forged documents regarding the pledge money (FD) while submitting its case for recognition.

Whereas, Rule 43(1) (c) of the Haryana School Education Rules, 2003, provides for withdrawal/ suspension of recognition/ NOC of a school in case school obtains recognition by fraud, mis-representing or suppressing any particulars. Rule 43(1) is reproduced here as under: -

*Rule 43(1): The appropriate authority may withdraw/ suspend the recognition/NOC\*\* of a school after giving a reasonable opportunity against the proposed action to be taken against the school in the following circumstances:-*

(a) \*\*\*\*\*

(b) *if a school is found involved in malpractices such as mass copying in public examination conducted by any Board or bogus enrolment or tempering of records or non-cooperation to appropriate authority or moral turpitude etc. its recognition/NOC shall be withdrawn without any notice and the concerned Board shall be intimated (be asked to withdraw its affiliation).*

- (c) *if the managing committee of the school obtains recognition/NOC\* by fraud, mis-representing or suppressing any particulars or after obtaining recognition/NOC\* fails to continue to comply with any of the conditions specified in these rules the appropriate authority after giving a reasonable opportunity and one month notice to show cause against proposed action can withdraw recognition/NOC.*

On the basis of the report of District Education Officer, Gurugram, it appears that the society through management has obtained recognition by tempering with the documents pertaining to pledge money deposit.

Therefore, under the aforesaid Rule, the society through management is being issued a show cause notice as to why the recognition/NOC granted to their school be not withdrawn.

The reply/representation, if any, the society/management wants to submit, should reach the Department within a period of thirty days, failing which, it will be assumed that the society/management/trust has nothing to say in the matter and the appropriate decision shall be taken in accordance with Rules.
