



SHOW CAUSE NOTICE

Order No. 6/88-2023 PS (3)

Dated, Panchkula, the 04-09-2023

A complaint was received by CM Flying Squad, Karnal on the allegations that Shiv Deep Vidya Mandir School, Dadlana, Panipat, is being run without recognition from competent authority. An inspection in this matter was conducted by CM Flying Squad, Karnal, consisting of Sh. BaliRam, Inspector. Sh. Vikram Singh, Block Resource Coordinator, Panipat and found that Shiv Deep Vidya Mandir School, Dadlana, Panipat, is running classes upto 12th level without obtaining recognition from the competent authority. In addition, following violations also found:-

- (i) That students are being asked to use books from private publisher.
- (ii) That 11 rooms of the school are single door, whereas, there is requirement of double door.
- (iii) For toilets and drinking water, proper arrangement has not been made.
- (iv) That students taking classes in the school are made to appear in Board exams through other schools namely Arya Shiksha Niketan School Budhanpur, Karnal and M.D.N Senior Secondary School Gagsina, Karnal.

Whereas, Shiv Deep Vidya Mandir School, Village Dadlana, Karnal,, was granted permanent recognition upto 10th level vide order P.S. 2011/60-64 dated 02.12.2011 under the provisions of Haryana School Education Rules, 2003 on the condition that it shall abide by the rules, regulations, instructions of the appropriate authorities issued from time to time under the Haryana School Education Rules, 2003.

Whereas Rule 30 of Haryana School Education, 2003 provides for conditions for grant of the recognition to private schools of the State of Haryana. The operative part of Rule 30 of Haryana School Education Rules, 2003 is reproduced here as under:-

30. (1) No private school shall be recognized, or continue to be recognized, by the appropriate authority unless the school fulfils the following conditions, namely:

b. Number of classrooms shall be equal to the number of sections in the school. The classroom shall have two doors, requisite number of windows and proper ventilation.

Whereas Rule 3 provides that no school in the state can function, establish or start classes without the prior approval or permission of the Director.

It is apparent from the above mentioned facts that the school is being run in violation of rule 30(1)(a)(x), 30(1)(b)(ii)(b) read with rule 3 of Haryana School Education Rules, 2003. Furthermore school management is involved in malpractices by making students to appear in Board exam through other schools.

Whereas, Rule 43(1) of the Haryana School Education Rules, 2003, provides for withdrawal/ suspension of recognition/ NOC of a school in case school obtains recognition by fraud, mis-representing or suppressing any particulars. Rule 43(1) is reproduced here as under: -

Rule 43(1): The appropriate authority may withdraw/ suspend the recognition/NOC of a school after giving a reasonable opportunity against the proposed action to be taken against the school in the following circumstances:-**

(a) *****

- (b) if a school is found involved in malpractices such as mass copying in public examination conducted by any Board or bogus enrolment or tempering of records or non-cooperation to appropriate authority or moral turpitude etc. its recognition/NOC shall be withdrawn without any notice and the concerned Board shall be intimated (be asked to withdraw its affiliation).
- (c) if the managing committee of the school obtains recognition/NOC* by fraud, mis-representing or suppressing any particulars or after obtaining recognition/NOC* fails to continue to comply with any of the conditions specified in these rules the appropriate authority after giving a reasonable opportunity and one month notice to show cause against proposed action can withdraw recognition/NOC.

Therefore, a show cause notice is being issued to the school management of the said school as to why the recognition granted to the school may not be withdrawn under Rule 43 of the Haryana School Education Rules, 2003.

The reply, if any, the Management of said school wants to submit, should be sent to this Department within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and an appropriate order shall be passed in accordance with Rules.

Whereas, Sh. Partap Singh [020102], PGT History, Govt. Sr. Sec. School Badhawar, Hisar now posted at Govt. Sr. Sec. School Sarsod Bichpari [1473], District Hisar was charge sheeted under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide No. 16/35-2015 HRL (5) dated 15.12.2015 and the following charges were leveled against him:-

“That he i.e. Sh. Partap Singh was appointed as Chief Centre Superintendent at Centre Government Senior Secondary School, Badhawar, Hisar during annual Secondary/Senior Secondary Examination, March, 2015. As per instructions dated 3/2015 issued by Board of School Education, Haryana Bhiwani to all the District Education Officers, the packets of question papers could only be opened before 20 minutes before the commencement of the examination i.e. at 10:40 AM, as the time of commencement of examination was 11 AM. The Sub Divisional Question Paper Flying Squad, Barwala visited the aforesaid Examination Centre on 10.03.2015 and the Flying Squad while inspecting the packets of question papers, found packet of question paper of Hindi subject being opened at 10:20 A.M. He i.e. Sh. Partap Singh being Chief Centre Superintendent had signed at 10:20 A.M. on the packet of question paper. Later on, after cutting, it was mentioned as 10:40 A.M. and till that time neither the student were arranged to be seated in the examination hall nor answer sheets were distributed. On asking about the aforesaid act by the Flying Squad, he i.e. Sh. Partap Singh failed to give satisfactory reply. As such, he violated the aforesaid instructions dated, March 2015 and performed his duties in a negligent manner.”

The charged officer submitted his reply dated 25.12.2015 to the said charge sheet wherein he alleged that on the basis of facts and circumstances of the case, no charges/allegations are made out against him. He submitted that the said examination during March, 2015 of Hindi Subject of Class Matric at the Centre of GSSS Badhawar (Hisar) was got conducted by him as Chief Superintendent of the Centre as per instruction contained vide Booklet namely instructions meant for holding examination for the year 2012 as also applicable for 2014-15 issued by Haryana Education Board, Bhiwani whereas Sh. Suresh Kumar, Math Master, GSSS Barwala [Anaj Mandi] was Superintendent of the Centre whose duty it was to collect packets of question papers date wise and reconcile the same. Further, he has stated that he discharged his duties without any grievances of the Centre Superintendent. Therefore, his suspension in this


case is unjustified along with Centre Superintendent, who has been reinstated. He stated that the event has been created by Sh. Hawa Singh, Clerk of the Board who has been working pre-judicially against him as he refused to oblige him during the course of examination of his son held in year 2010 at GSSS Siwani Mandi (Bhiwani). Sh. Hawa Singh manipulated the circumstances for settling the past scores and got issued the charge sheet against him. He has further stated that Centre Superintendent Sh. Suresh Kumar had collected the papers of Hindi subject on 10.03.2015 and put up to him at 10:35 A.M. When the flying squad visited the Centre at 10:36 A.M., the students were in process of sitting in the examination hall and answer sheets had been distributed and no question paper of Hindi subject had been opened till then. No irregularity of leaking paper has been committed by him. Also, the examination has been conducted at scheduled time.

Sh. R. K. Verma, I.A.S. (Retd.) was appointed as Inquiry Officer vide order dated 11.05.2018. He submitted the enquiry report dated 24.08.2018 wherein he concluded that the charge of opening the envelope containing question paper 5 minutes' earlier than stipulated time stands partially proved but 5 mitigating factors as enumerated above minimize the intensity and seriousness of the charge.

Accordingly, the charged officer was granted personal hearing on 29.05.2023. After considering the facts on the file and the enquiry report submitted by the Inquiry Officer, I am satisfied with the conclusion arrived in the enquiry report dated 24.08.2018. Taking the mitigating factors into consideration, I am inclined to take a lenient view.

Therefore, a minor punishment of 'recorded warning' is hereby inflicted upon Sh. Partap Singh [020120], PGT History, Govt. Sr. Sec. School Badhwar, Hisar now posted at Govt. Sr. Sec. School Sarsod Bichpari [1473], District Hisar. His suspension period i.e. 10.03.2015 to 31.12.2015 will be allowed to be considered as duty period for all intents and purposes.

I order accordingly.

Whereas, Sh. Partap Singh [020102], PGT History, Govt. Sr. Sec. School Badhawar, Hisar now posted at Govt. Sr. Sec. School Sarsod Bichpari [1473], District Hisar was charge sheeted under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide No. 16/35-2015 HRL (5) dated 15.12.2015 and the following charges were leveled against him:-

“That he i.e. Sh. Partap Singh was appointed as Chief Centre Superintendent at Centre Government Senior Secondary School, Badhawar, Hisar during annual Secondary/Senior Secondary Examination, March, 2015. As per instructions dated 3/2015 issued by Board of School Education, Haryana Bhiwani to all the District Education Officers, the packets of question papers could only be opened before 20 minutes before the commencement of the examination i.e. at 10:40 AM, as the time of commencement of examination was 11 AM. The Sub Divisional Question Paper Flying Squad, Barwala visited the aforesaid Examination Centre on 10.03.2015 and the Flying Squad while inspecting the packets of question papers, found packet of question paper of Hindi subject being opened at 10:20 A.M. He i.e. Sh. Partap Singh being Chief Centre Superintendent had signed at 10:20 A.M. on the packet of question paper. Later on, after cutting, it was mentioned as 10:40 A.M. and till that time neither the student were arranged to be seated in the examination hall nor answer sheets were distributed. On asking about the aforesaid act by the Flying Squad, he i.e. Sh. Partap Singh failed to give satisfactory reply. As such, he violated the aforesaid instructions dated, March 2015 and performed his duties in a negligent manner.”

The charged officer submitted his reply dated 25.12.2015 to the said charge sheet wherein he alleged that on the basis of facts and circumstances of the case, no charges/allegations are made out against him. He submitted that the said examination during March, 2015 of Hindi Subject of Class Matric at the Centre of GSSS Badhawar (Hisar) was got conducted by him as Chief Superintendent of the Centre as per instruction contained vide Booklet namely instructions meant for holding examination for the year 2012 as also applicable for 2014-15 issued by Haryana Education Board, Bhiwani whereas Sh. Suresh Kumar, Math Master, GSSS Barwala [Anaj Mandi] was Superintendent of the Centre whose duty it was to collect packets of question papers date wise and reconcile the same. Further, he has stated that he discharged his duties without any grievances of the Centre Superintendent. Therefore, his suspension in this


case is unjustified along with Centre Superintendent, who has been reinstated. He stated that the event has been created by Sh. Hawa Singh, Clerk of the Board who has been working pre-judicially against him as he refused to oblige him during the course of examination of his son held in year 2010 at GSSS Siwani Mandi (Bhiwani). Sh. Hawa Singh manipulated the circumstances for settling the past scores and got issued the charge sheet against him. He has further stated that Centre Superintendent Sh. Suresh Kumar had collected the papers of Hindi subject on 10.03.2015 and put up to him at 10:35 A.M. When the flying squad visited the Centre at 10:36 A.M., the students were in process of sitting in the examination hall and answer sheets had been distributed and no question paper of Hindi subject had been opened till then. No irregularity of leaking paper has been committed by him. Also, the examination has been conducted at scheduled time.

Sh. R. K. Verma, I.A.S. (Retd.) was appointed as Inquiry Officer vide order dated 11.05.2018. He submitted the enquiry report dated 24.08.2018 wherein he concluded that the charge of opening the envelope containing question paper 5 minutes' earlier than stipulated time stands partially proved but 5 mitigating factors as enumerated above minimize the intensity and seriousness of the charge.

Accordingly, the charged officer was granted personal hearing on 29.05.2023. After considering the facts on the file and the enquiry report submitted by the Inquiry Officer, I am satisfied with the conclusion arrived in the enquiry report dated 24.08.2018. Taking the mitigating factors into consideration, I am inclined to take a lenient view.

Therefore, a minor punishment of 'recorded warning' is hereby inflicted upon Sh. Partap Singh [020120], PGT History, Govt. Sr. Sec. School Badhwar, Hisar now posted at Govt. Sr. Sec. School Sarsod Bichpari [1473], District Hisar. His suspension period i.e. 10.03.2015 to 31.12.2015 will be allowed to be considered as duty period for all intents and purposes.

I order accordingly.


