

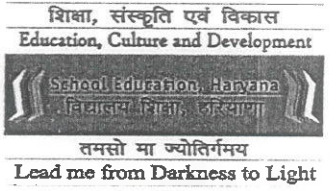

The following person who is working as Hindi Teacher in the Aided School and has opted voluntarily in accordance with the provision made in Haryana Voluntary State Education Service Rules, 2017 and found suitable for appointment as mentioned in aforesaid rules to the post of Drawing Teacher in the Haryana School Education Department in the pay scale FPL 7 of the Schedule 1 of the Pay Matrix of the Haryana Civil Services (Revised Pay) Rules, 2016 plus usual allowances as admissible under the State Government Rules from time to time.

The following terms and conditions may be imposed in his appointment orders:

1. She is appointed purely on temporary and provisional basis.
2. This appointment is against temporary posts and his confirmation against substantive posts shall be considered on the basis of his seniority and record of service as and when such posts are available.
3. She shall have to take an oath of allegiance to the Constitution of India.
4. She shall produce a certificate before joining the duties to the effect that she has one living husband in case she is married. None of them who has more than one living husband shall be eligible for appointment to the post offered unless the Government after being satisfied that there are special grounds for doing so, exempt him from this condition.
5. She shall not be allowed to apply for any post outside the department for a period of at least five years.
6. She shall not claim seniority on the basis of these orders. Her inter-se seniority will also be decided in accordance with the department rules and instructions of the State Government later on.
7. In other matters, not specifically mentioned in this communication, she shall be governed by the Civil Services Rules as applicable to Haryana Government Employees and such orders/instructions as may be issued by the Government from time to time.
8. She is directed to show her original certificate of academic qualification, experience and other relevant certificate to the concerned District Elementary


Education Officer of his present place of posting. District Elementary Education Officer would verify the genuineness of his original certificate.

9. Her appointment is subject to the condition that in case she has not produced medical fitness certificate at the time of her initial appointment in the aided schools than concerned District Elementary Education Officer will ensure that she shall submit her medical fitness certificate first duly issued by the Civil Surgeon only then she should join as Hindi Teacher in the concerned school.
10. Her appointment letter is provisional subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
11. If in case her character and antecedents are found not verified or any false information is given by him in his self declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken as per provisions of Indian Penal Code (IPC) etc. as deemed fit.
12. The exercise of the verification of character and antecedents should be carried out within a period of two months. Once, the verification report is received and there is no objection on the facts given by him, the provisional appointment letter will be confirmed.
13. The services of Hindi Teacher will be governed under the same rules applicable for such teachers already working in Govt. Schools.
14. If at any time during the course of his temporary appointment, any of the appointee desires to resign, she shall be required to give one month's clear notice or forfeit, in lieu thereof, her salary including allowances etc. for one month or for the period by which the notice falls short of one month. Such a notice will be given to him by the Government also in the case if it is proposed to terminate her services in lieu thereof the Government will be liable to pay her salary, including allowance for one month or for the period by which the notice falls short of one month.
15. No TA/DA will be admissible to the candidate for joining as Hindi Teacher.
16. If he gets an appointment as Hindi Teacher on the basis of her furnishing false or fraudulent information/ facts/documents which are detected later on, she would be liable for termination of service without any notice.
17. The appointment under these rules shall be a fresh appointment made on the minimum of pay scale of that post however, the salary of the employee appointed under these rules shall be protected as a measure personal and shall not be less than the salary which she is already drawing. The past service rendered shall not be counted for any other intents and purposes except pensionary benefits.
18. An employee appointed under these rules shall not be entitled for any promotion till he attains the age of superannuation.
19. She shall be governed by the Haryana Civil Service (Pension) Rules, 2016.



20. Arrears of any kind in respect of the employees who is working in aided school and is appointed under these orders shall not be paid by the Government for the period prior to the date of appointment in the Service.
21. No grant-in-aid shall be payable to the aided schools in respect of the posts which have been taken over in the Service.
22. The leave account of the employee appointed under these rules shall start with a zero balance.
23. All other matters, not specifically mentioned in the Haryana Voluntary State Education Service Rules, 2017, shall be governed by the Haryana Civil Services Rules and Punjab Financial Rules as applicable to Haryana Government Employees and by such rules and regulations as may have been, or may hereafter be adopted or made by the competent authority made under the Constitution of India or under any Law for the time being in force made by the State Legislature.





2. The official will be relieved immediately and if he/she fails to do so, he/she will be liable for disciplinary action, However if any official is working in Census duty, he/she shall not be relieved till the Census duty is accomplished.
3. No TA/DA and joining time will be admissible to the official if he/she has been shifted on his/her request after exercising option.
4. If there is no vacancy in the destination school for any reason the incumbent transferred shall re-join his/her previous place of posting and also inform to concerned branch/computer cell at HQ.
If any discrepancy is noticed in this order or there is a violation of transfer policy, It should be brought to the notice of Computer Cell/Concerned branch within three days and the order be not implemented.
5. Consent/affidavit of the official be taken that he is willing to loose his/her seniority in case of requested transfer orders.
6. The condition that official has not been joined previous transfer place of posting is not implemented on Cancellation Order.
7. The official will be update their profile in MIS Portal when he/she join/relieve from his present working station and also supply the information to the Directorate.

Whereas, the petitioner namely Sh. Sunil had approached the Hon'ble High Court by way of filing CWP No. 20112 of 2022 titled as Sunil Kumar versus State of Haryana & others, praying therein for issuance of a writ in the nature of certiorari for quashing the order dated 17.03.2020 (Annexure P-9) and claimed service benefits accrued to the father of the petitioner including salary, Gratuity and family pension etc. Further prayed for directing to the respondents to consider the petitioner for compassionate appointment on account of death of the father of the petitioner and also claimed to direct the respondents to decide the representation/legal Notice dated 06.09.2021 (Annexure P-15).

The above said writ petition came up for hearing before Hon'ble High Court on 07.09.2022 and on that day the same was disposed with the directions to decide the legal notice dated 06.09.2022 by way of speaking order. The operative part of order is reproduced as under:-

Without expressing any opinion on the merits of the case or the claim being made by the petitioner in the representation, respondent No.1 is directed to decide the legal notice dated 06.09.2022 (Annexure P.15), by passing a speaking order within a period of eight weeks from the date of receipt of copy of this order.

Present writ petition stands disposed of.

 In compliance of the above said direction of Hon'ble High Court, the legal notice dated 06.09.2021 (Annexure P-15) of the petitioner has been minutely examined and it has been found that petitioner's father was appointed as a part time sweeper on 29.08.1997 in Govt. High School, Lilas against a sanctioned post. His services were regularized on 11.09.2014 and after the said regularization he joined as a regular employee in Government High Court School, Lilas District Bhiwani. But, he did not produce any

document pertaining to his date of birth. Rather, the father of the petitioner namely Sh. Prahlad Singh had merely produced an affidavit dated 11.09.2014 wherein he affirmed his illiteracy and his own date of birth as 28.03.1973, duly attested by Gazetted Officer. Thereafter, complaints were received on 16.04.2019 and 20.02.2020 against Sh. Prahlad Singh i.e. the father of the petitioner regarding verification of his date of birth. The father of petitioner was asked to submit strict proof regarding his date of birth and the date of birth of his children. In response to the same, the father of the petitioner produced an affidavit dated 13.03.2020 counter signed by Executive Magistrate Siwani, declaring therein that he had two sons namely Sh. Mange Ram and Sh. Sunil Kumar i.e. petitioner with their respective dates of birth as 02.01.1995 and 20.04.1980. He affirmed that he had no proof of his own date of birth and age. Further, on 16.03.2020 the father of the petitioner submitted an affidavit before the competent authority (through proper channel) for seeking voluntarily retirement from the post of Sweeper-cum-Chowkidar. On the basis of the affidavit dated 16.03.2020 submitted by Sh. Prahlad Singh, he was allowed to be superannuated and hence relieved from school on 17.03.2020 after following the proper procedure, which bears the thumb impression of Sh. Prahlad Singh and the signature of the petitioner. Therefore, the services of the father of the petitioner had not been terminated rather he was relieved on 17.03.2020 from his services on account of voluntary retirement sought by him.

Keeping in view of the position explained above, the claim of the petitioner demanded through Legal Notice Dated 06.09.2022 (Annexure P.15) is not tenable. Hence, the claim of the petitioner is hereby rejected being devoid of merits.

I order accordingly.

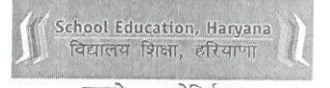

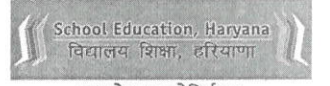
