



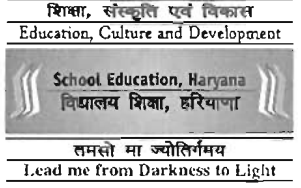

Whereas, Sh. Shiv Kumar Gaur had filed the Civil Writ Petition No.28773 of 2022 titled as Shiv Kumar Gaur vs. State of Haryana & Others in the Hon'ble Punjab & Haryana High Court praying therein for issuance of a writ in the nature of mandamus directing the respondents to re-fix the pay and pension of petitioner by stepping up at par with junior employees namely Sh. Roop Chand, Rtd Dy. Supdt and Sh. Raj Kumar (Rtd Assistant) in General Category at DEO Bhiwani by giving benefit of 1<sup>st</sup> ACP/HSS with grade pay and to release all consequential benefits with arrears.

The aforesaid writ petition came up for hearing before the Hon'ble Punjab and Haryana High Court on 14.12.2022 and on that day Hon'ble Court was pleased to dispose of the same with directions to respondent No.2 to decide the legal notice dated 19.09.2022 of the petitioner. The operative part of the order dated 14.12.2022 is as under:-

*Without expressing any opinion on the merits of the case or the claim being made by the petitioner in the legal notice, respondent No. 2 is directed to decide the legal notice dated 19.09.2022 (Annexure P-5), by passing a speaking order within a period of eight weeks from the receipt of copy of this order.*

*Present writ petition stands disposed of.*

Whereas in compliance of the said directions, the matter of the petitioner has been examined by department and it has been found that the petitioner was appointed as a clerk on 07.09.1971 in the Director Secondary Education Haryana. Then after retirement on the benefits which are available to a government employee as per prevailing service Rules, he was retired on 31.05.2008 he has claimed stepping up at par his junior namely Sh. Rup Chand and Sh. Raj Kumar.

The service record of Rup Chand was examined and found that two annual increments in the year 1975 and 1976 i.e. on 23.07.1975 and 23.07.1976 had been granted to him inadvertently by the department. Hence, the show cause notice was issued to Sh. Roop Chand vide Order No. 13/249-2022 HRME-1(6) dated 03.08.2023 for withdrawal of said annual increments and finding his reply not satisfactory the increments were withdrawn by department vide order no. 13/249-2022 HRME-1(6) dated 13.09.2023.

As far as the claim of the petitioner for stepping up of his pay at par with that of Sh. Raj Kumar, junior employee is concerned, it is clarified here that petitioner is already drawing higher pay than that of Sh. Raj Kumar at every point of time.

Hence, keeping in the view position explained above, there is no ambiguity in the pay fixation of the petitioner. Resultantly, the claim of the petitioner is not tenable and hence rejected being devoid of merits.
