Whereas, the petitioner had filed the CWP No. 27973 of 2018 titled as Raja Ram Vs State of Haryana and others, praying therein for the issuance of a writ in the nature of certiorari for quashing the order dated 26-04-2018 (Annexure P-7) qua petitioner to the extent of date of regularization i.e. vide which services of the petitioner have been regularized w.e.f 01.04.2011 instead of 27.9.2003 i.e. date on which junior to the petitioner has been regularized vide order dated 27.9.2003.

The above CWP came up for hearing on 13-12-2022 and on that day the same was pleased to dispose of with direction to respondent. The operative part of order is under:-

***“In view of the pleadings in the present petition, without expressing any opinion on the merits of the case or the claim being made by the petitioner in the legal notice, respondent No. 2 is directed to decide the legal notice dated 25.07.2018 (Annexure P-8) by passing a speaking order within a period of eight weeks from the receipt of copy of this order.***

***Present writ petition stands disposed of.”***

In compliance of the above said order of the Hon'ble High Court, the legal notice dated 25.07.2018 (P-8) of the petitioner has been examined by the department and it has been found that the petitioner was engaged in the year 1993 by the department as a class IV on the part-time basis in GHS Birdhan District Fatehabad on 30.09.1993 against unsanctioned post. On 28.02.1998, he was relieved from service. Again the petitioner joined as part time Class- IV on 13.12.2000 in GHS Hizrawn Khurd as per Order No.911 of Block Education Officer, Fatehabad and worked there as

a part time class IV till 19.05.2014. Thereafter, the petitioner was regularized vide Order No.2-20/6407-6414 dated 06.02.2020 w.e.f 08.08.2014 in view of the departmental regularization policy dated 11.11.2003 as per his seniority as well as his entitlement which came into force after superseding the previous departmental regularization policy dated 30.12.1998/25.02.1999.

Whereas, it is pertinent to mention here that the seniority of part time class IV employees was at institutional level as per the previous departmental regularization policy dated 30.12.1998/25.02.1999 and according to the said policy only those part time class IV employees were entitled for regularization of their services against vacant regular sanctioned post who had requisite experience mentioned in the policy in the institutions where sanctioned posts of class IV were available and Sh. Inder Singh, whose example was quoted by the petitioner was regularized w.e.f. 27.9.2003 as per regularization policy dated 30.12.1998/25.02.1999 because Sh. Inder Singh who was working as part-time class IV employee in GMS Chander Kalan, Fatehabad continuously since 1993 and the said school was upgraded to high school in the year 1997 and the post as class IV got sanctioned and hence regularized under the departmental regularization policy dated 30.12.1998/25.02.1999.

Whereas, it is relevant to clarify here that the petitioner joined as a fresh entrant on part time basis on fresh entrant in GHS Hizrawn Khurd and no more remained senior to Sh. Inder Singh. Moreover, the petitioner was found entitled for regularization as per the terms and conditions of the Department Policy Dated 11.11.2003 and the petitioner was regularized vide E-2-20/6407-6414 Dated 06.02.2020 w.e.f. 08.08.2014.

Keeping in view of the position explained above, the claim of the petitioner demanded through Legal Notice Dated 25.07.2018 is not



maintainable. Hence, the claim of the petitioner is hereby rejected being devoid of merits.

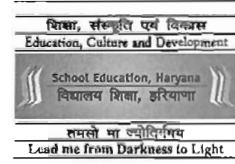

6. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.

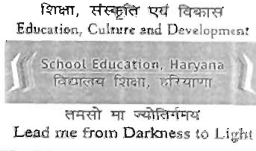


