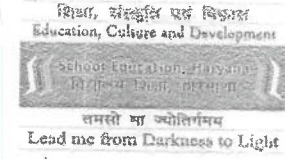

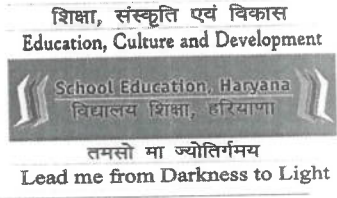



**Order No. 13/150-2022 PGT-II (6)**

**Dated, Chandigarh, the 27-9-2023**

Whereas, the petitioner, Smt. Jyoti Rani (Emp. Id 061171) PGT Hindi has filed CWP No.847 of 2023 titled as Jyoti Rani V/s State of Haryana and others, for issuance of a writ in the nature of certiorari for quashing the order dated 28.08.2022 passed by respondent no.1 in derogation to clause 14 of Teachers Transfer Policy-2016 dated 29.06.2016 and Amended Policy dated 05.06.2017.

That the abovementioned writ petition came up for hearing before the Hon'ble High Court on 17.01.2023 and the Hon'ble Court disposed of the same with the direction to respondents to decide the representation of the petitioner. The operative part of the order dated 17.01.2023 is as under:-

***Notice of motion.***

***On the asking of this Court, Mr. RS Budhwar, Additional AG Haryana, accepts notice and submits that he has no objection, if the aforesaid limited prayer made by the learned counsel for the petitioner is allowed.***

***In view of above, the present petition is disposed of with liberty to the petitioner to pursue her claim before respondent No.2 and file an application/representation within a week from today, if so advised. If the application is so filed by the petitioner, within a week from today, then respondent No.2 is hereby directed to decide the claim of the petitioner, within eight weeks thereafter, as per law.***

Whereas, in compliance of the above said order, the matter of the petitioner has been examined. The Petitioner has prayed to transfer her to a station nearer to Hisar city on the ground that her mother-in-law, who is about 85 years of age, is suffering from chronic disease. Furthermore, her husband is a Deputy District Attorney with the office of Dy. Excise and

Taxation Commissioner (S.T.), Hisar and also having an additional charge of DETC(Excise) joint ETC Range Hisar. He remains out of station for work purpose.

Whereas, she herself participated in Teacher Transfer Drive, 2022 wherein she filled up 29 choices out of which 2<sup>nd</sup> choice, namely GGSSS Balsamand Hisar, Zone-7 as per her merit points allocated to her during round-1. Thereafter, as per her choice she was deputed to GSSS Gangwa, Hisar (1447) Zone-1 on 19.01.2023 till the next transfer drive.

Whereas department has notified Teacher Transfer Policy, 2023 vide notification no. 1/44-2023-e.Gov.Cell dated 09.08.2023 to ensure equitable, demand based distribution of teachers/heads to protect academic interest of the students to optimize job satisfaction among its employees in a fair and transparent manner. As per provision of the policy, a teacher was given right to compete against a vacancy of his choice and the teacher earning highest points should be entitled to be transferred against a particular vacancy through transfer drive. As per Para 5(xi) (xii), (xiii) of the Teacher Transfer Policy dated 09.08.2023 that **all eligible teachers except C&V and PRT's shall submit choice of minimum ten educational blocks in order of their preference where they want to serve. In case of C&V and PRT cadre they shall opt all educational blocks in such particular district in order of preference. Furthermore, all eligible teachers shall be asked to fill up choices against the eligible vacancies of the schools failing in the blocks of their choice in order of preference, and allocation of vacancies shall be done purely on the merit as per the provisions of this policy.**

Keeping in view of the facts enunciated above and averments made in her representation dated 23.01.2023, petitioner's claim is not tenable at this stage as her transfer has been done as per the provisions of the transfer policy.



Hence, the claim of the petitioner is not tenable and liable to be rejected.

I order accordingly.
