Whereas, Sheelawati had filed CWP No. 4268 of 2022 titled as Sheelawati Vs State of Haryana & Ors in the Hon'ble Punjab and Haryana High Court directing the respondents to step-up the pay of the petitioner at par with his Scheduled Castes reserved category Junior- Sh. Santosh Kumar in terms of the instructions dated 18-12-2013 as the same benefit stands extended to another senior General Category Lecturer (History) Sh. Sukhbir Singh viz a viz Sh. Santosh Kumar vide order dated 29-08-2018.

That this case came up for hearing on 04-03-2022 and the Hon'ble High Court was pleased to dispose of the above mentioned CWP vide orders dated 04-03-2022. The operative part of order dated 04.03.2022 is as under:-

Notice of motion.

Mr. Harish Rathee, Deputy Advocate General, Haryana accepts notice on behalf of the respondents. Even counsel for the respondents is not averse to the expeditious disposal of the claim of the petitioner.

In view of the above, the present petition is disposed of with a direction to respondent No.2 to decide the representation of the petitioner dated 27.12.2021 (Annexure P-10) and take a conscious decision thereon by passing a speaking order; within a period of three months from the date of receipt of the certified copy of this order.

It is further ordered that if the petitioner is found entitled to any pecuniary benefits upon such a conscious decision; then the said pecuniary benefits shall also be released to the petitioner within a further period of three months; from the date of such conscious decision of the authorities.

Whereas, representation dated 27.12.2021 of the petitioner has been examined in compliance of order of the Hon'ble High Court dated 04-03-2022. The petitioner has claimed that one Sh. Santosh Kumar was given promotion for the post of Lecturer (History) from 20.05.1995, 'who was junior to her' petitioner promoted w.e.f. 28.02.2009 as Lecturer in History. The petitioner has prayed that benefits of step-up be given to her equivalent to the junior reserved category employee i.e. Sh. Santosh Kumar.

Whereas, the petitioner was appointed as a TGT Mistress on regular basis on 04.05.1991. Later on, she was promoted as a PGT History on 28.02.2009.

The detail of the particulars of the petitioner and of compared candidate are as under:-

Name and Seniority No.	Date & post on regular Basis	Promoted as Lecturer on	Remark
Sheelawati (Petitioner)	04.05.1991	w.e.f. 28.02.2009(History)	Retired as P.G.T on 28.02.2021
Santosh Kumar (SC)	07.11.1991 (Master)	25.05.1995 (History)	Now working

Whereas, the promotions from TGT to PGT was done as per the seniority of the TGT as per existing rules. Where earlier the promotion criteria from TGT to PGT was determined as 18/10/1995 according to Punjab Educational Service, Class III, School Cadre Rules 1955. As per Punjab Educational Service Class- III, school cadre rules, seats were separately earmarked for male and female employees for purpose of promotion and separate seniority list were maintained for male and females employees. The candidate namely Sh. Santosh Kumar was promoted against a seat reserved for male candidate as per separate seniority list for male candidates.

Whereas the Govt. of Haryana introduced of Service Rules, 1998. Under these rules system of separate seniority for male and female were abolished. And a combined seniority list of male and female master cadre was issued on 01.01.2006, wherein the petitioner was placed at Sr. No. 8976 and Sh. Santosh Kumar (SC) was placed at Sr. No. 9452. Smt. Sheelawati has been shown senior to Sh. Santosh Kumar in the seniority list of masters as on 01.01.2006 however this cannot be taken as reference document to certify that the petitioner was senior to Sh. Santosh Kumar reserved category candidate for her promotion as lecturer on 25.05.1995. Seniority of the petitioner and that of Sh. Santosh Kumar, reserved (category candidate) cannot be compared on the dates of their appointment as mistresses and master respectively as the seniority lists were used to be maintained separately for male and female cadre for their promotion for the post of lecturer, at that point of time and the promotion quota for the post of lecturer was 2:1 for male and female cadre respectively in the year of 1995 and education service class iii school cadre rules 1955. The petitioner has relied upon the example of Sh. Sukhbir Singh who was given the benefit of stepping up at par with his junior Sh. Santosh Kumar vide order No. 18/91-2017 PGT-II(5) dated 29.08.2018. However, Sh. Sukhbir Singh was given this benefit as Sh. Sukhbir Singh was senior to Sh. Santosh Kumar

however petitioner is junior to Sh. Santosh Kumar at the time she got promotion as PGT.

In the circumstances claim of the petitioner is not tenable being devoid of any merits hence rejected.



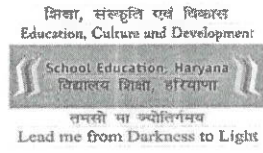

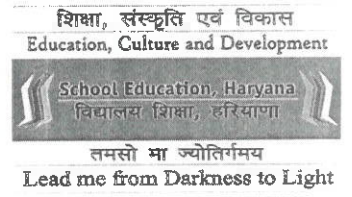
