**Order**

Whereas the petitioner filed CWP No. 12152 of 2021 titled as Sunita Devi vs. State of Haryana and others, for the issuance of a writ in the nature of certiorari for quashing the impugned transfer order dated 02.07.2021 and the petitioner prayed for quashing the impugned order dated 10.08.2021 vide which the claim of the petitioner for cancellation of her transfer order has been rejected and further prayed for directing the respondent to transfer the petitioner in Govt. Model Senior Secondary School, Panchkula, Sector-20.

The Hon'ble High Court disposed of the aforesaid writ petition vide order dated 02.12.2022. The operative part of the order is reproduced here as under:-

***“However, as there are certain disputed facts and the petitioner is claiming posting in District Panchkula and one post of PGT Hindi in Sanskriti Senior Govt. Model Secondary School, Sector-20, Panchkula is lying vacant, the respondents are directed that as and when the said post is to be filled up, the claim of the petitioner be also considered along with other candidates, in case more than one employee opts for posting to the said station.*”**

***Writ petition is disposed of in above terms.”***

Whereas vide order no. 24/02-2020 ACD (14) Dated 09.06.2021, the Department invited the applications from the PGTs who were working on regular basis in Government Schools in Haryana and were willing to be posted in Government Model Sanskriti Senior Secondary Schools. Thereafter, petitioner on dated 23.02.2021 willfully participated in process of posting in Government Model Sanskriti Senior Secondary School and opted five stations in district Kaithal. Accordingly the petitioner got selected for the Model Sanskriti School after competing in interview and Govt. Sanskriti Sr. Sec. School Kalayat, Distt. Kaithal was allotted to her vide order 24/02-2020 ACD (14) dated 02.07.2021 as per her fifth choice as mentioned in her application form.

Whereas, the petitioner earlier moved representation dated 03.07.2021 regarding the cancellation of order 24/02-2020 ACD (14) dated 02.07.2021 vide which Government Sanskriti Senior Secondary School Kalayat, Distt.



Kaithal was allotted to her. The representation of the petitioner was duly considered and after careful examination of the same, it was decided vide speaking order No.24/05-2021 ACD (14) dated 10.08.2021.

Whereas now Department of Education is posting teachers in Government Model Sanskriti Senior Secondary Schools on the basis of score in the test conducted by Centre for Teacher Accreditation [Hereinafter referred to as CENTA].

Whereas Department of Education vide order no 18/31-2022 ACD(12) dated 09.08.2023 has directed such teachers who has been selected through CENTA to opt for station through online drive. The current online drive is based on merit/score of CENTA. On the other hand petitioner was selected on the basis of interview and has not appeared in CENTA, thus have no CENTA merit/score for participation in online posting drive. Furthermore, Government Model Sanskriti Senior Secondary School, Sector 20, Panchkula, has been opted by 10 CENTA qualified candidates. Out of these candidates station has been allocated to the candidate with highest merit in CENTA Test. Therefore, it is not possible to consider the claim of the petitioner as merit list of interview and screening test by CENTA are different criteria and cannot be combined in the interest of justice.

Keeping in view of the circumstances mentioned above, claim of the petitioner for posting in Government Model Sanskriti Senior Secondary School, sector 20, Panchkula, is not tenable and is liable to be rejected.

I order accordingly.
