3. Concerned DDO is also requested to update and approved MIS data of the official at your own level & the MIS updating of the official not be updated as transfer, it should be as deputation.
4. It is his/her responsibility to report on his actual posting station on completion of deputation period.
5. The salary of the officials be drawn from his actual posting station.

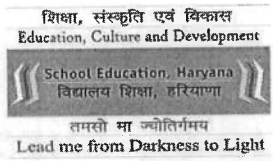
