I am directed to refer to this office memo no 1537-R-4-2022/11416, dated 10.10.2022 on the subject noted above and intimate that the State Government vide notification dated 23.08.2022 had notified "The Haryana Dholidar, Butimar, Bhondedar and Muqararidar (Vesting of Proprietary Rights) Haryana Amendment Act. 2018. by which amendment were made in Sub-Section (4) of Section 1 of the Principal Act, 2010. The amendment has been made effective retrospectively w.e.f. 09.06.2011 i.e. the date of commencement of the Principal Act, 2011. The amended provision is reproduced as below:

"This Act shall be applicable to Dholidar, Butlmar, Bhonededar and Muqararidar or any other similar class or category of persons which the State Government may notify in the Official Gazette, of land belonging to private individuals/entities only and will not be applicable to lands owned or deemed to Dave vested in the Local Bodies i.e Panchayat deh, Municipalities etc. & lands owned by any Government Department, Board or Corporation."

We amendment notification has been challenged by the petitioner Sh. Ram Singh in CWP

 N_{0} . 3958-2023 for declaring the said notification dated 23.08.2022 as null and void and ultra vires. Various other writs have also been filed challenging the same and such writs have been plubbed for adjudication. Hon'ble High Court of Punjab & Haryana in above oral Sections and CWP has passed orders dated 21.04.2023 which is as under:-52418

Ram Singh Vs. State of Haryana and others.

The petitioner filed the preset writ petition for declaring the notification dated 23.8.2022 issued vide Haryana Act No. 26 of 2022 under the Haryana Dhjolidar, Butimar, Bhondedar and Muqararidar (vesting of Proprietary Rights) Amandment Act, 2018 (P-5) asnull and void and ultra vires, as the said amendment has been effected retrospectively and also for setting aside the letter dated 10.10.2022 (P-6) issued by respondent no. 2 whereby all rights vested in the Dholidars have been declared illegal ab-initio.

On 21.4.2023 the following order was passed:-

"I 1. Notice of motion.

2. Mr. P.P. Chahar, DAG, Haryana, waives service of notice, on behalf of the respondents, and, seeks time to file reply to the petition.

3. List, as prayed for, along with CWP-3958-2023, on 24.04.2023.

4. In the meantime, the parties are directed to maintain status quo, and, the Notification dated 23.8.2022 shall remain stayed till further orders."

The aforementioned case came up for hearing before Hon'ble Division Bench comprising of Hon'ble Mr. Justice Sureshwar Thakur and Hon'ble Mr. Justice Kuldeep Tiwari on 3.8.2023. On the date of hearing no reply has been filed in the Court. The Hon'ble Court has adjourned the case 13.2.2024 for filing reply.

Accordingly, you are hereby advised to ensure compliance of the above said order dated 21.4.2023 and to issue appropriate instructions/directions forthwith so as to ensure filing of the appropriate written statement/reply well in advance of the next date of hearing i.e. 13.2.2024 after getting it vetted from this office, failing which, if any adverse order is passed, this office shall not be responsible.
