

- 1) If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Service (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbents(s) shall be reverted without issuing any prior notice.
- 2) The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality

- of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
- 3) If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of division bench judgment of Punjab and Haryana High Court in CWP No. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.
 - 4) If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate(s) shall be reverted in view of Govt. instructions dated 31.05.2006.
 - 5) If any discrepancy regarding not fulfilling the essential qualifications eligibility as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.
 - 6) The promotion being based on provisional list and without prejudice to the right of the seniors to be considered if they opt for promotion as **PGT Fine Arts** provided they are found eligible for the post.







Sh. Vakil Ahmed (028116), PGT Political Science, Government Senior Secondary School, Chhajpur, Panipat now working in the Government Senior School, Kurar, Panipat was chargesheeted under Rule-8 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016 directions vide order no. 13/57-2018 PGT-III (1) dated 13.03.2020 in which the following allegations were levelled against him:-

"That Sh. Sumit S/o Sh. Naresh resident of Chhajpur (Panipat) was not given admission in class 12th by you even after repeated requests and requests from the school administration. At last, the head of the school admitted the applicant in view of his difficulties. Even after this, you refused to take the applicant's fees and necessary documents and did not even listen to the head of the school. Thus you have misused your position".

After hearing the delinquent and perusal of the record, Director Secondary Education, Haryana, Panchkula vide order No. 13/57-2018 P.G.T. III (1) dated 01.03.2022 ordered to stop one annual increment of the employee without cumulative effect .

Thereafter, he challenged the aforesaid order on 24.05.2022 by way of filing appeal before the undersigned. In furtherance, he was granted an opportunity of personal hearing on 31.05.2023. On perusal of relevant record, it has been observed that the record does not show any delay. Without even having heard him, a mere perusal of the Schools register and transfer form shows that there was no way student could have approached him for admission before 20.07.2018 as that was the date of issue by the Principal of Public Intermediate College in Kairana. The admission actually was given on 30.07.2018 is also undisputed. Therefore, it is beyond doubt that the student would have been 'denied' admission by him only during 21.07.2018 to 30.07.2018

Mr. Vakil Ahmed's explanation was that indeed the student approached him twice in this period but he only asked him to get the transfer certificate countersigned by District School Inspector, Shamli. This was a valid demand. The certificate proves that this countersigning was

done on 30.07.2018. Since admission was granted on the same day, the explanation is completely convincing.

Hence, the order of DSE is quashed.


