

- 3. That these promotion orders are without prejudice to the right of the seniors, if any, whose promotion cases may be decided at a later stage/ and court case pending/ directions etc.
- 4. That these officials should fulfill the conditions as prescribed in the Service Rules/approved terms and conditions. In case it transpires at a later stage that any employee does not fulfill the conditions as prescribed in the service rules, he/she shall be reverted/relieved to his original post immediately. After their posting all DDO are again directed to check the record that they fulfil the conditions/parameters.
- 5. They will have to join their duties at the place of new assignment within 15 days from the date of issue of promotion/posting orders failing which these orders shall stand automatically cancelled and they will forfeit their claim for seniority.
