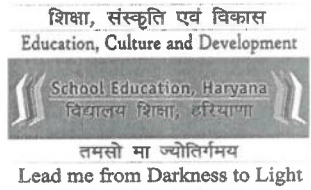

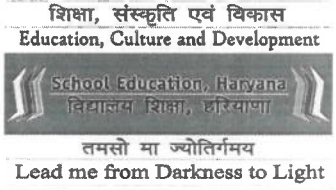

Smt. Suman [208700], PGT Hindi, Govt. High School, Bugana (Hisar) now Govt. Sr. Sec. School, Mirzapur [1249] (Hisar) was chargesheeted Under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide Directorate order No. 16/16-2021 PGT-II (6) dated 02.03.2022 and the following allegations were levelled against her:-

"That a complaint dated 08.06.2020 & 09.06.2020 was filed by the Gram Panchayat against her i.e. Smt. Suman and other staff of Government High School, Bugana (Hisar) and as per the content of enquiry report dated 24.06.2020, she i.e. Smt. Suman, Post Graduate Teacher has immoral relations with her colleague namely Sh. Suraj Kumar, Post Graduate Teacher English in the school and she used to talk on phone for long which is highly objectionable for the School atmosphere. Their behaviour and relations have adverse effect on the students as well as not conducive for teaching."

Smt. Suman, PGT Hindi submitted her reply on 27.04.2022 to the said charges and denied the allegation leveled against her. The reply of the charged officer was found un-satisfactory. Resultantly, Shri O.P. Langyan, I.A.S. (Retd) was appointed as Inquiry Officer to conduct regular departmental enquiry. Inquiry Officer submitted his report on 28.03.2023 wherein charges against her were not found to be proved.

Keeping in view the above said facts and circumstances, reply of Smt. Suman, PGT Hindi and finding of Inquiry Officer. I, being competent authority in matter, hereby drop the chargesheet against Smt. Suman, PGT Hindi.

Whereas Smt. Sangeeta W/o Sh. Om Parkash, the then Principal [deceased] in Govt. Sr. Sec. School Rania, District Sirsa was appointed to the post of Guest faculty Hindi on 21.12.2005. An enquiry was conducted by a committee comprising of two Principals i.e. Smt. Rani Devi, Govt. Sr. Sec. School, Farwai Kalan [Sirsa] and Sh. Ram, Govt. Sr. Sec. School, Sahuwala [Sirsa] under the supervision of District Education Officer, Sirsa. It is established that she is not the same person, Sangeeta, whose documents were relied upon for the selection to the said post and continuation thereof in this office. She is neither inhabitant of Rania nor her appointment was made on merit basis. It has been concluded by enquiry committee that her identity is established as wife of Sh. Om Parkash Tiwari, the then Principal (deceased); the person who was responsible to make engagement of guest faculty as on 21.12.2005 which was against the norms.

As a matter of fact, this engagement against the said post of Guest Faculty was meant for any local resident of Rania having requisite academic qualification and so called Sangeeta has failed to prove that she has ever been resident of Rania, Sirsa. Moreover, she was avoiding to give specimen of signature as similar to the signatures on the original application. It is evident from the enquiry report and other documents that the person serving as Guest faculty in Hindi has been impersonating in the name of Sangeeta. She has misrepresented this office whenever office directed her to furnish data. Thus, by impersonation, she has wrongly claimed the month-wise salary of a guest faculty by culling the rights of any other genuine candidate who was otherwise eligible for this post.

Thus, she is liable for disciplinary proceedings under Rule-6(1) of the Haryana Guest Teacher Services Act, 2019 dated 12.03.2019 which reads as under:-

“A guest teacher may be removed from the service by the appropriate Authority if he is proved guilty of an act of omission or commission which, if had been committed by a regular employee of the Government, would have made him liable for initiation of disciplinary proceedings for major penalty.”

By taking a serious view of the above, a Show Cause Notice No. 3/19-2020 PGT-II(3) dated 09.02.2021/ 02.07.2021 was served to Smt. Sangeeta, PGT Hindi (Guest) before issuance of this order i.e. termination from the service. Instead of submitting reply to Show Cause Notice, Smt. Sangeeta, PGT Hindi (Guest) has been repeatedly requesting for documents

from last one year. Whereas, photocopy of all the documents have already been provided to her. Even then, she has not submitted reply to Show Cause Notice.

Keeping in view of the above said facts and circumstances, report of District Education Officer, Sirsa, rules in force and documents on record, it has observed that Smt. Sangeeta, PGT Hindi is working as Guest teacher in the said school. The allegations to which she has been found guilty of are quite serious in nature considering the duties discharged by her. A teacher with such a conduct is not good for the Educational Institution as the teacher should always be a role model for the society. Any teacher involved in such kind of malpractices should not be allowed to continue in service. Further, the Haryana Guest Teacher Service Act, 2019 (as amended) also provides the provision regarding termination of service of Guest Teacher in case of his/her omission or commission.

Considering the seriousness of present matter, Smt. Sangeeta [5009282], Guest PGT Hindi is liable to be removed from service due to her act of omission or commission enumerated above. Therefore, Smt. Sangeeta [5009282], Guest PGT Hindi is hereby removed from service with immediate effect.


