

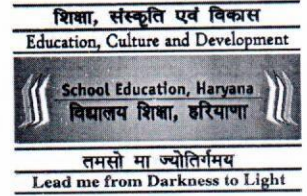



Whereas, the petitioners namely Sh. Satish Kumar and others have filed CWP No. 10053 of 2016 titled as Satish Kumar and others vs. State of Haryana & another before the Hon'ble Punjab and Haryana High Court praying therein to quash the action of the respondents by which the petitioners have been denied promotion as Post Graduate Teacher (PGT) from the date candidates junior to the petitioners have been promoted and also promote the petitioners as PGT from the date the candidates junior to the petitioners have been promoted and the petitioners be granted all consequential benefits, including posting in preference to their juniors. Further, quash the counseling for posting of the newly promoted PGT, held pursuant to letter dated 04.05.2016 and also posting of newly promoted PGT pursuant to letter dated 04.05.2016 be stayed or in alternative, petitioners may be provisionally promoted to the post of PGT and posted as such.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 09.08.2022 with following orders:

***"Learned counsel for the petitioners submits that the claim of the petitioners in the present petition is covered by the order of this Court in CWP No.10830 of 2021 titled as Satish Kumar vs. State of Haryana and others, decided on 12.07.2022 and therefore, the present writ petition be also disposed of in same terms.***

***Learned State counsel raises no objection with regard to the prayer of the petitioners that the present petition be also disposed of in terms of Satish Kumar's case (supra).***

***Keeping in view the above, as prayed for by the learned counsel for the parties, the present writ petition is disposed of in terms of Satish Kumar's case (supra)."***

Whereas, the Hon'ble Punjab & Haryana High Court disposed of CWP No.10830 of 2021 titled as Satish Kumar vs. State of Haryana and others on dated 12.07.2022 with following orders:

***".....On the asking of the Court, Mr. R.S. Budhwar, learned Additional Advocate General, Haryana, who is present in Court, accepts notice on behalf of the respondent-State and submits that the claim of the petitioner will be considered in accordance with law and appropriate order on the prayer of the petitioner will be passed by the respondents within a period of four weeks from today and the settled principle of law on the said issue will be kept in mind while considering the claim of the petitioner and passing speaking order."***



Whereas, in compliance of the above said order, the cases of Sh. Satish Kumar and others have been duly examined and it is found that the incumbents have claimed promotion to the post of PGT Mathematics. As per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the mandatory qualifications for promotion in PGT (Post Graduate Teacher) Mathematics is as under:-

Whereas, the petitioner No. 1 to 6, 8, 10, 13 to 16, 18 to 19 and 21 had passed their degree of M.A/M.Sc degree in Mathematics from Institute of Advanced Studies in Education University, Gandhi Vidhya Mandir, Sardarshar, Rajasthan.

Whereas, candidates seeking direct appointment had filed CWP No. 7626 of 2015 titled as Gurmail Kaur & Ors. Vs State Of Haryana & Ors. The Hon'ble Punjab and Haryana High Court passed an order dated 27.05.2015 and the operative part of order dated 27.05.2015 is as under:-

*"....In view of what has been observed above, Annexures P-9 and P-10 are hereby quashed. Writ petitions are accordingly allowed. The respondents are directed to issue appointment letters to the petitioners by putting a condition in the same manner as has been put while issuing appointment letters to the candidates who have challenged the exemption clause vis-à-vis sitting in HTET/STET examination forthwith. The respondents are also directed to issue re-appointment letters to the petitioners, whose services have been dispensed with by putting the same condition."*

It is further submitted that LPA No. 1215 of 2015 was filed against CWP No. 7626 of 2015 and the same was later withdrawn by the Department with the liberty to file a Review Application against the order dated 27.05.2015 which was dismissed on the grounds of delay. Later on, the Department again filed LPA No. 171 of 2021 and which was again dismissed on the grounds of maintainability. Now the matter is pending in the Hon'ble Supreme Court in SLP No.017134/2021. However, the petitioners have placed

reliance upon the judgment passed in CWP No. 7626 of 2015, In this regard, it is stated here that CWP No. 7626 of 2015 pertains to the fresh appointments of PGTs whereas the grievance of the petitioner in the present matter relates to promotion to the post of PGT.

Whereas, similar situated employees have filed CWP No. 15843 of 2018, which was allowed by Hon'ble High Court on 16.10.2019. Thereafter, the department has filed the Latent Patent Appeal No. 19 of 2021 before the Division Bench in the Hon'ble High Court against the said order of Single Bench dated 16.10.2019 & the matter is now subjudice wherein, the stay has already been granted by the Hon'ble Division Bench. The operative part of the order dated 26.02.2021 is re-produced here as under:-

***"Issue notice in the main appeal as well as in the application for condonation of delay in filing the same.***

***Mr. Ranjit Singh Kalra, learned counsel on the strength of caveat accepts notice on behalf of respondent No. 1.***

***List on 25.05.2021 alongwith LPA-626-2020.***

***In the meanwhile, operation of the impugned judgement dated 16.10.2019 passed by the learned Single Judge in CWP-15843-2018 shall remain stayed."***

Whereas, similar situated employee pertaining to appointment have filed CWP No. 22528 of 2021, which was allowed by Hon'ble High Court on 29.08.2022. Thereafter, the department has filed the Latent Patent Appeal No. 98 of 2023 before the Division Bench in the Hon'ble High Court against the said order of Single Bench dated 29.08.2022 & the matter is now subjudice wherein, the stay has already been granted by the Hon'ble Division Bench. The operative part of the order dated 02.02.2023 is re-produced here as under:-

***".....Granting time to the respondent to file reply to the stay application, this Court in the meanwhile, by way an ad-interim measure, stay operation of the impugned judgment passed by the learned Single Judge."***

*d* Whereas, Institute of Advanced Studies in Education University, Gandhi Vidhya Mandir, Sardarshar, Rajasthan being Deemed University, is not competent to run the distance education programme beyond their territorial jurisdiction without the permission of State Government and University Grants Commission. Whereas, this University did not take permission from the State Government and University Grants Commission before opening study center to run distance education programme. In absence of the permission of University Grants Commission and State Government wherein study centers are located, the degrees obtained from such study centers by the candidates are not legal and such candidates are not eligible for promotion as Post Graduate Teacher in Haryana Government Services.



Keeping in view of the facts mentioned above & documents on record and orders of Hon'ble Division Bench, the claim of Sh. Satish Kumar and others is not tenable at this stage & hereby rejected being devoid of merits.

Whereas, Smt. Deepika Kukreja [089494] was appointed as PRT on 01.02.1999 by direct recruitment vide order No. E-1/99 5990-6295 and thereafter, promoted as TGT/Master (Social Studies) vide order No. 2/42-2010-HRM-1 (2) dated 05.12.2010 and further promoted as PGT English vide order No. 15/11-16 PGT II-(3) dated 13.07.2016.

The department after receiving court cases, re-examined the promotion case of Smt. Deepika Kukreja. She had completed her post-graduation degree in English from EIILM University in 2012.

The University Grant Commission vide letter No. 5-2/2019 (CCP-I/PU) dated 28.01.2019 has clarified that the EIILM University was recognized by UGC in 2006 and closed in 2015. It was a private university notified by Act. of State Legislative (Sikkim). The university was not authorized to open study centre/off campus centre beyond Sikkim and not authorized to open centre even within Sikkim. Yet the university opened centres in various States, including Haryana and unsuspecting persons acquired degrees of the University. Smt. Deepika Kukreja completed her M.A. in English from EIILM University while studying at its study centre in Kaithal. She took permission of department for undertaking the M.A. course. She completed the course and was awarded degree in 2012. Based on this M.A. degree, she got promoted as PGT in 2016. In 2015, the UGC woke up to complaints about the university opening its study centres etc. and recommended to Sikkim Govt. to dissolve the University, on 30.04.2015, the University was dissolved. UGC further clarified in letter dated 28.01.2019 addressed to School Education Department, Haryana that only degrees in B.A. (Hospitality & Tourism), BCA and MBA were allowed as valid and none of other degrees are valid. This rendered the MA degree as acquired in 2012 by Smt. Deepika Kukreja as invalid. Degree being invalid, a show cause notice was issued vide endst. No. 15/11-2016 PGT-I (3) dated 16.11.2021 to her as to why her promotion order should not be cancelled. In respect to show cause notice she stated that she was an unsuspecting student and even the Haryana School Department had given the permission to pursue the MA degree from EIILM University. She claimed that it is not her fault that a "recognized university" was doing illegal activity by opening centres in other states and she should not be punished for this matter. She has been working as PGT for six years and she is not at fault in the matter

at all, requested to withdraw the notice and also requested for grant of personal hearing.

Accordingly, a personal hearing was granted to her. Smt. Deepika Kukreja appeared on 12.04.2023 for personal hearing and heard. She failed to submit any substantive explanation to the effect of her degree from a non recognized university in her favor.

Keeping in view of the facts on record, I am considered view that Smt. Deepika Kukreja, PGT English not found eligible to be promoted as PGT English, stands reverted as TGT with immediate effect the position from which she had been promoted.

I, pass order accordingly and DEE to take further action in regard to her posting as TGT.

*".....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no.3 to decide the pending representation of the petitioner, dated 17.1.2023, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter."*

In compliance of above said order, the representation dated 17.01.2023 of Sh. Vijay Kumar, TGT English has been duly examined and it is found that he was initially appointed as PRT/JBT on 08.07.2004 and later on, promoted to the post of TGT/Master (English) on 17.07.2018.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

**By promotion:-**

(i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND

(ii) 2 years teaching experience as TGT English; or

Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.

Whereas, Sh. Vijay Kumar joined as TGT English on 30.08.2018 and he has acquired the qualification of M.A. on 21.07.2022. The cutoff date for applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotions were issued on 08.01.2021. On that day, petitioner did not have requisite qualification as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, found not eligible for promotion to the post of PGT (English). Juniors of the petitioner

were promoted to the post of PGTs on 08.01.2021 reason being that they have the requisite experience for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) on the date of promotion.

In view of the facts mentioned above, the claim of Sh. Vijay Kumar is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 01.06.2023 with following orders:-

***".....In view of the above, the present petition is disposed of with a direction to respondent No.2-Director Elementary Education, Haryana, to decide representation dated 14.02.2022 (Annexure P-4) moved by the petitioner, within a period of eight weeks from the receipt of the certified copy of this order, by passing a speaking order, as per law."***

In compliance of above said order, the representation dated 14.02.2022 of Smt. Meenakshi Rani, TGT English has been duly examined and it is found that she was initially appointed as PRT/JBT on 16.12.2004 and later on, promoted to the post of TGT/Master (English) on 17.07.2020 w.e.f. 17.07.2018.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

**By promotion:-**

- (i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND
- (ii) 2 years teaching experience as TGT English; or  
Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.

Whereas, Smt. Meenakshi Rani joined as TGT English on 22.07.2020. The cutoff date for applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotions were issued on 08.01.2021. On that day, petitioner did not possess the mandatory 2 years teaching experience as TGT English as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, found not eligible for promotion to the post of PGT (English). Juniors of the petitioner were promoted to the post of PGTs on 08.01.2021 reason being that they have the requisite experience for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) on the date of promotion.

In view of the facts mentioned above, the claim of Smt. Meenakshi Rani is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.


