Whereas, Sh. Ranbir Singh had filed present CWP No. 1951 of 2023 titled as Ranbir Singh vs. State of Haryana & others praying therein to direct the respondents to grant the benefit of deemed-date of promotion to the petitioner to the post of Lecturer in Economics w.e.f. 16.12.1997 i.e. from the date his junior Sh. Raj Pal has been promoted, to grant seniority over and above Sh. Raj Pal, further to grant him promotion to the post of Principal w.e.f. 04.08.2021 i.e. the date from which his junior Sh. Raj Pal has been promoted as Principal and to fix/step-up his pay at par with his junior counterpart Sh. Raj Pal notionally w.e.f. 16.12.1997 and actually w.e.f. 04.12.2008 (i.e. the date from which the petitioner was promoted as Lecturer in Economics) and payment of arrears with all consequential benefits.

The Hon'ble Punjab and Haryana High Court disposed of said petition vide order dated 14.10.2022 with the following directions:-

".....In view of the above, the present petition is disposed of with a direction to respondent No.2-Director General, Department of Secondary Education, Haryana, to decide legal notice dated 26.11.2022 (Annexure P-27) moved by the petitioner, within a period of four weeks from the receipt of the certified copy of this order, by passing a speaking order, as per law."

In compliance of said order, the legal notice dated 26.11.2022 of Sh. Ranbir Singh was examined. After examination and it has been found that he was initially appointed on adhoc basis as TGT/Master Science on 21.12.1986 and regularized on 01.01.1991. Later on, he was promoted to the post of PGT Economics on 04.12.2008 and now, retired as PGT Economics on 30.09.2023.

Whereas, Sh. Raj Pal was initially appointed as TGT/Master Social Study on 23.01.1992 and later on, promoted to the post of PGT Economics on 16.12.1997 being of SC category. Thereafter, he was promoted to the post of Principal on 04.08.2021 and retired as Principal on 31.05.2022.

Whereas, an accelerated seniority was given inadvertently to Sh. Raj Pal being of Scheduled Caste category and now, the seniority of Sh. Raj Pal has been refixed at appropriate number by the competent authority vide order dated 13.10.2023/20.10.2023.

Furthermore, the Government had promoted the PGTs to the post of Principal upto seniority No. 4450 from the seniority of PGTs as stood on 08.07.2019 and Sh. Ranbir Singh is at seniority No. 8044 as stood on 08.07.2019 and Sh. Raj Pal was promoted to the post of Principal due to accelerated seniority given to him being of SC category and had already retired as Principal, so, the remedial action of reversion will be taken in this matter as per the decision of the competent authority.

Keeping in view the facts enunciated above and documents on record, it has been observed that the seniority of Sh. Ranbir Singh is at the appropriate number in the Seniority List dated 08.07.2019 which is accurate as per the rules and the seniority of Sh. Raj Pal has already been fixed and now, Ranbir Singh has become senior to Sh. Raj Pal.

Therefore, the claim of Sh. Ranbir Singh in his legal notice dated 26.11.2022 regarding necessary corrections in the seniority list of Post Graduate Teachers is not tenable, and hereby rejected being devoid of merits.

I order accordingly.




