**Dated, Panchkula: 02-11-2023**

Whereas Aggarwal Sr. Sec. School, Gohana, Sonipat was granted permanent recognition upto 10<sup>th</sup> level vide order no 30/26-2019 PS(4) dated 01.08.2019 and permission upto 12th level vide order no. 30/26-2019 PS(4) dated 18.06.2020 by Director Secondary Education Haryana, Panchkula.

Whereas Shree Bhagwan Dass, President of Dhan Sat Guru Shiksha Samiti R/o Vishwakarma Chowk Maham Road, Gohana, Sonipat made a complaint against Aggarwal Sr. Sec. School, Gohana, Sonipat alleging that Sh. Randhir Singh, Manager of the Aggarwal Senior Secondary School, Gohana, Sonipat has managed to obtain the recognition of Aggarwal senior secondary school on the basis of forged land ownership deed. The complainant further stated that he is the owner of land no. 249/4,7/1,4/1 and Sh. Randhir Singh has forged all the documents by putting fake signatures of the concerned revenue officer. Further he has alleged that the education qualification of the teachers submitted by the school on the MIS Portal of Director Secondary Education Haryana, Panchkula are false.

Whereas, the District Education Officer, Sonipat was directed vide memo No. 6/67-2022 PS (1) dated 07.06.2022 to conduct an enquiry in this matter and submit its report. That in compliance of letter No.6/67-2022 PS (1) dated 07.06.2022 the District Education Officer, Sonipat constituted a committee under the chairmanship of Block Education Officer, Gohana, Sonipat. The committee in its report dated 06.10.2022 has concluded that the documents submitted by the Aggarwal Senior Secondary School for Obtaining recognition & Permission are fake.

Whereas a show cause notice dated 08.02.2023 was served upon the school management as to why the recognition granted to their school may

not be withdrawn from academic session 2023-2024 for violating Haryana School Education Rules 2003.

Whereas vide memo no. 6/67-2022 PS (1) dated 10.07.2023, a personal hearing was granted to the complainant and school management. Sh. Randhir Singh, Manager, Aggarwal Sr. Sec. School, Gohana, Sonipat and Shree Bhagwan Dass, the complainant, attended the hearing in the department.

Whereas, in the course of hearing, it was alleged by the complainant that lease agreement in favour of school is not genuine.

Whereas, the Tehsildar, Gohana, Sonipat was directed vide memo No. 6/67-2022 PS (1) dated 19.07.2023 to verify whether the lease agreement dated 26.01.2019 is genuine. Whereas, Tehsildar, Gohana, Sonipat vide its letter no134/R.C dated 15-09-2023 submitted his report. The Tehsildar, Gohana, Sonipat in his report stated that the lease agreement dated 28.01.2019 is not genuine.

Whereas, the trust/management has made itself liable for punitive action under Rule 43 (1) of the Haryana School Education Rules, 2003. The rule 43 provides for suspension or withdrawal of recognition/ N.O.C of the school where management committee of school has obtained recognition by fraud. Rule 43 (1) of the said Rules is reproduced here as under:-

- “43. (1) The appropriate authority may withdraw/ suspend the recognition/NOC\*\* of a school after giving a reasonable opportunity against the proposed action to be taken against the school in the following circumstances:-**
- (a) xxxxxxxxx
  - (b) xxxxxxxxx
  - (c) *if the managing committee of the school obtains recognition/NOC\* by fraud, mis-representing or suppressing any particulars or after obtaining recognition/NOC\* fails to continue to comply with any of the conditions specified in these rules the appropriate authority after giving a reasonable opportunity and one month notice to show cause against proposed action can withdraw recognition/NOC\**
  - (d) xxxxxxxxx

In view of facts mentioned above, pleadings and official record, I am of the considered view that the school management has been running the

school in violation of rule 43(1)(c) of the Haryana School Education Rules, 2003. Hence, exercising the power under Rule 43 of the Haryana School Education Rules, 2003, I being competent authority, am of considered view that the recognition of concerned school (classes 9th to 12th) be withdrawn from next academic session. Further the admissions in the school be restricted from first day of new academic session.

Whereas, Smt. Sunita Rani has filed CWP No. 9078 of 2023 titled as Sunita Rani vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct the respondents-department to promote the petitioner to the post of PGT English, from the date her juniors were promoted, and to grant all consequential benefits.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 29.04.2023 with following orders:-

***“.....In view of the above, without expressing any opinion on the merits of the case, respondent No.3-Director, Secondary Education, Haryana, is directed to decide the representation dated 14.11.2022 (Annexure P-4) by passing a speaking order within a period of eight weeks from the date of receipt of copy of this order.”***

In compliance of above said order, the representation dated 14.11.2022 of Smt. Sunita Rani, TGT English has been duly examined and it is found that she was initially appointed as PRT/JBT on 28.11.2005 and later on, promoted to the post of TGT/Master (English) on 17.07.2020 w.e.f. 17.07.2018.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

**By promotion:-**

- (i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND
- (ii) 2 years teaching experience as TGT English; or  
Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.

Whereas, Smt. Sunita Rani joined as TGT English on 21.07.2020. The cutoff date for applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotions were issued on 08.01.2021. On that day, petitioner did not possess the mandatory 2 years teaching experience as TGT English as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, found not eligible for promotion to the post of PGT (English). Juniors of the petitioner were promoted to the post of PGTs on 08.01.2021 reason being that they have the requisite experience for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) on the date of promotion.

In view of the facts mentioned above, the claim of Smt. Sunita Rani is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.
