

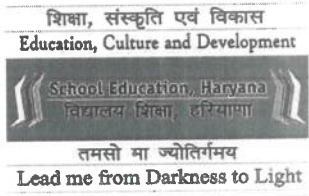

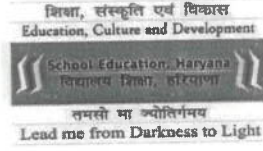

Whereas, the petitioner had filed CWP No. 12602 of 2022 titled as Rakesh Kumar vs. State of Haryana & Others in the Hon'ble High Court praying therein to grant/release annual increment to petitioner w.e.f. 2012 onwards with all consequential benefit etc. and considered demands mentioned in legal Notice dated 10.04.2022.

The Civil Writ Petition came up for hearing before the Hon'ble High Court on 01.06.2022 and on that day, the Hon'ble High Court was pleased to disposed of the same with direction to respondent No.1-Financial Commissioner & Secretary, Department of Education, Haryana to consider and decide the legal notice dated 10.04.2022 (P-2). The operative part of the order is reproduced here as under:-

*"In view of the agreed stand taken by both sides, but without adjudicating the controversy on merits, writ petition is disposed of with direction to respondent No.1-Financial Commissioner & Secretary, Department of Education, Haryana, to consider and decide the aforesaid legal notice dated 10.04.2022 (P-2), in accordance with law, within a period of 04 (four) months from the date of receipt of certified copy of this order. Needless to say that in case there is a failure on the part of competent authority, petitioner would be at liberty to move an appropriate application for revival of this writ petition and the same shall be considered as per law".*

In compliance of the above said order, the legal notice dated 10.04.2022 of the petitioner has been examined. Petitioner raised his grievance for non-grant of annual increment to him without having knowledge of typing w.e.f. 7.4.2011. The petitioner initially joined as Class- IV employee on 17.06.1996 in Department and was promoted as clerk vide order no. 2/1-2011-HRME (5) w.e.f. 07.04.2011 on 28.06.2012 with some terms and conditions. As per conditions appended with promotion orders, the promotion was subject to the

amendment in the Service Rules regarding type test. The petitioner is presently working as Clerk at Government Senior Secondary School Kadipur, District Gurugram.

The eligibility for promotion as a clerk is that a person must have the knowledge of Hindi or English typewriting, in view of the Haryana Education Department, Sub-Offices, Ministerial (Group-C) Service Rules, 1983. As per letter No. 22/40-2012 HRME-1 dated 6.04.2012 issued by Secondary Education Department Haryana, Panchkula, that ***the Class-IV employees promoted as clerk are given benefit of annual increment without passing type test with condition that they have knowledge of type writing as per service Rules.***

Further the Government of Haryana, Education Department has amended the Haryana Education Department, Sub-Offices, Ministerial (Group-C) Service Rules, 1983 vide Notification No.G.S.R.65/Const./Art.309/ 2013 dated 8.11.2013. As per amended rules: ***“the existing Clerks, who have been promoted from Group-D and Restorer etc. Who have not passed the typing test till date as required under the Services Rules shall have an option either to pass the typing test or the State Eligibility Test in Computer Appreciation and Applications (SETC)”.***

In addition to that the Proviso of Rule 38 the Haryana Civil Services (Pay) Rules, 2016 clearly provides the condition of passing Departmental test for grant of increment. The same is as under:-

***“Rule 38- Grant of increment in case departmental test is a pre-condition:-***

***Provided that on appointment by promotion to such a post, the presumptive basic pay of feeder post shall, if it is more advantageous, be admissible till qualifying the departmental test or fulfilling of other conditions prescribed for normal increment of promotional post”.***

Petitioner has cited the examples of CWP No. 5566 of 1999 titled as Prithvi Raj Versus State of Haryana and Others and CWP No. 4585 of 2009 titled as Rama Nand Versus State of Haryana and Others, wherein the

petitioners were allowed the benefit of annual increments. Petitioners of the above mentioned writ petitions were allowed the benefits before issuance of Notification No. G.S.R.65/Const./Art.309/2013 dated 08.11.2013 of Haryana Education Department, Sub-offices, Ministerial (Group-C) Service (Amendment) Rules, 2013 and exemption of type test was given.

Since the petitioner Rakesh Kumar, Clerk does not have the knowledge of type writing but has been promoted to the post of clerk. Thus, there is no force in the legal Notice dated 10.04.2022 of the petitioner claiming the benefit of annual increment on the post of clerk. Hence, the claim of the petitioner is not tenable and hereby rejected being devoid of merits.

I order accordingly.

Whereas the petitioners had filed the CWP No. 19739 of 2023 titled as Mahesh Arjun & Others Vs State of Haryana & others, before the Hon'ble Punjab & Haryana High Court, praying therein for issuance of a writ in the nature of certiorari for quashing the action of the respondents not to consider the representations of the petitioners at parity with the similar situated person and further prayed for issuance of a writ in the nature of mandamus directing the respondents to consider the representations dated 16.12.2022 (P-9) & 06.06.2023 (P-11) made by the petitioners at parity with similar situated persons whose representations have been decided vide order dated 25.05.2023 (P-10).

The above said Civil Writ Petition came up for the adjudication before the Hon'ble Court on 05.09.2023 and the same was disposed of with direction to respondent no.2 to decide their pending representations dated 16.12.2022 and 06.06.2023. The operative part of the aforesaid orders is reproduced here as under:-

***“without going into merits of the case, the instant petition is disposed of with a direction to respondent No.2/Director, Secondary Education, Haryana, to consider and decide the pending representations dated 16.12.2022 and 06.06.2023, keeping in view the decision already taken vide Annexure P-10, by passing a speaking order in accordance with law, within a period of four weeks from the date of receiving a certified copy of this order.”***

In compliance of the above mentioned orders of the Hon'ble High Court, the representations dated 16.12.2022 and 06.06.2023 of the petitioners were examined by the department. As per the transfer policy dated 06.03.2020, some of the employees participated voluntarily, whereas some of the employees participated compulsorily on completion of their maximum 05 years stay in a particular zone. All the petitioners opted the stations according to their suitability and choices. But due to low merit scores obtained by them most of the petitioners could not get the stations opted by them. Such stations were given/allocated to the employees who have scored higher marks than the petitioners. Thus transfer of the petitioners has been done in a fair & transparent manner in strict compliance of the Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas, the Government of Haryana framed Online Transfer Policy of Ministerial Staff dated 06.03.2020, thereupon, transfers were made under this

policy to ensure equitable distribution of Ministerial Cadre Employees of the Department across the State, in a fair & transparent manner and to maximize job satisfaction amongst the employees. Under this policy all the government schools/ institutes have been categorized into seven zones for the purpose of transfer of clerks and every participant is eligible to opt for any number of schools/institutes across the zones available to him/her. He/ She is free to give preferences in order of his/her suitability, so that chances of being posted in 'Anywhere in the State' category may be decreased. Further, according to the Para No. 4 sub clause V (b) of the Transfer Policy of Ministerial Staff 2020, the department is at liberty to post an employee anywhere in the State if he/she fails to get one of his/her preferred options. Thus the petitioners got the stations as per the online transfer policy of Ministerial Staff 2020.

Whereas the stations were blocked by following the process of rationalization. It is worthwhile to mention here that according to the sub clause-iv of Clause-4 of online transfer policy of Ministerial Staff 2020, the department can block actual vacant post for the purpose of rationalization. Sub clause-iv of Clause-4 online transfer policy of Ministerial Staff 2020 is as under:-

**iv) Rationalization and Blocking of posts: To avoid disproportionate concentration of employees at a particular station, the department should rationalize their sanctioned posts and also block actual vacant post to be kept vacant in the transfer drive. In the long run, however, the department may increase/decrease the total number of sanctioned posts as per the assessment/requirement in consultation with work Assessment Cell in the Administrative Reforms Department and Finance Department.**

The posts with less workload were blocked by the department, because these stations with over workload require more employees for smooth working in the department. So, for maximum utilization of the potential of an employee at over work-loaded station and to avoid inappropriate concentration of employees at a particular station, the blocking of posts was done by the process of rationalization in the public interest.

Moreover, the stations were blocked by the department by following the proper criteria i.e. the schools in which student strength is less than 125 but where the strength of the students is more than 125, the transfer of clerks has been done as per the online transfer policy. Thus for the process of even distribution of clerks in the State, the process of rationalization was done as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas it is germane to mention here that the blocked seats were opened only for the purpose of temporary posting of the clerks who later on joined the department after the present transfer drive by following the proper criteria



and lowered the strength of students from 125 to 55 only for the purpose of temporary posting. It is pertinent to mention here that these new appointees will also have to compete with the order clerks in the next online transfer drive whenever the same will be conducted by the department.

Whereas as per the provision of the policy, allotment of a vacant seat/station to an employee is based on total composite score earned by the employee concerned out of total 80 score points. The employee concerned earning highest score is entitled to be transferred against a particular vacancy. For merit points, age is prime factor for deciding the claim of the employee against a vacancy, as it has weightage of maximum of 60 points out of total 80 points. However, it is worthwhile to mention here that the categories like women, windows, widowers, differently-abled persons, employees with serious ailments have a privilege of maximum 20 points. Therefore, the employees were asked to opt for maximum stations as per their choice suitable to them so that their chances of getting posted on an un-opted station in 'anywhere in the state category' may be reduced. In other words, if a employee could not be transferred against any of the stations preferred by him/her, he/she shall be transferred under '**Anywhere in the State**' category. In case, an employee is to be transferred on an un-opted station in "Anywhere in state" category then Computer Programme/Software, instead of sending them at a distance place, searches for a vacancy nearest to them and put them at that vacancy as per their merit points.

Moreover, in regard to Right of Education, the Government of Haryana Has enacted the Haryana Right of Children to free and compulsory Education Rules, 2011 dated 03.06.2011 for the teacher and the same is not applicable to the clerks.

As references given by the petitioners in their writ petition in that context it is relevant to clarify here that the petitioners of the quoted references were transferred/adjusted in compliance of Hon'ble High Court Order dated 12.07.2022 in CWP No.11116 of 2021 and other connected matters which had filled by the similar employees for quashing impugned Transfer order dated 14.08.2020 and got stay from the Hon'ble High Court and they had not joined the station which were allotted in the Transfer Drive, 2020. But in the present writ, all the petitioners had joined the stations allotted in the Transfer Drive, 2020 and no representation was given by the petitioners within 15 days of issuance of their transfer order as per clause 6 (vii) of the Online Transfer Policy of Ministerial Staff 2020. Their representation has been received by the department after 2 and half years after joining the stations/schools. A government employee (i.e. petitioner) or any servant of a Public Service has no legal right to insist for being posted at any particular place and the same has also been upheld by the Hon'ble Apex court on 06.09.2021 in SLP No. 36717 of

2017 in CWP no. 48447 of 2017 in which the Hon'ble Apex Court has held that **"it is not for the employee to insist to transfer him/her and/or not to transfer him/ her at a particular place. It is for the employer to transfer an employee considering the employment."** It cannot be disputed that the petitioners hold transferable posts and unless specifically provided in their service conditions. So, they have no choice in the matter of posting. To get posted at a place of their choice.

Whereas, the score obtained by the petitioners along with the joining date are described as under:-

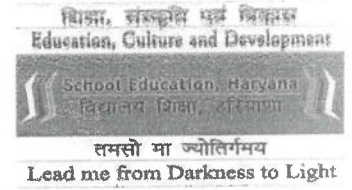

In Compliance of Hon'ble High Court order dated 03.08.2023 passed in COCP 964/2023, the speaking order dated 18.07.2023/20.07.2023 is hereby amended as under:-

Whereas, Sh. Gulab Singh, the then Head Master, Government Girls High School Mullana, District Ambala (Haryana) was charge-sheeted under Rule- 7 of HCS (P&A) Rules, 1987 on 30.04.2010 and later on he was dismissed from service vide order dated 09.09.2020/15.09.2020 for (i) remaining absent on 4 (four) days, (ii) participating in election rally, (iii) for delaying the disbursement of scholarship amount by 50 days. Thereafter, he had filed Civil Writ Petition No. 16031 of 2020 titled as Gulab Singh Vs. State of Haryana and others in the Hon'ble High Court of Punjab and Haryana, whereby he challenged the dismissal order dated 09.09.2020/15.09.2020.

The said writ petition was disposed of by the Hon'ble High Court vide order dated 18.11.2022, the operative part of which is reproduced here as under:

**"In view the above, impugned order 09.09.2020 having endorsement dated 15.09.2020 (Annexure P/10) passed by the respondents is set aside but with liberty to the respondents to pass a fresh order in accordance with law in case respondents feel that the allegations need to be taken to the logical end and while passing fresh order due care be taken that the punishment proposed/ imposed is commensurate with the allegations alleged and proved against the petitioner.**

**Learned counsel for the respondents submits that as the present order has been passed on technicalities and the petitioner stands reinstated in service after quashing of the order, the petitioner will claim benefit for the period he remained out,**

which will cause financial prejudice to the department.

Learned counsel for the petitioner, on instructions from the petitioner, who is present in Court, submits that the petitioner will not claim any benefit as arrears of salary from the date of passing of the impugned order till today but continuity in service be given to him till any fresh order is passed by the respondents.


Keeping in view the observations made in the present petition and as undertaken by the petitioner that petitioner will not be entitled for any back wages and financial benefits as arrears of salary for the period he remained out but he will be allowed continuity in service along with notional benefits for the period he remained out of service.

Present petition stands allowed in above terms."

In view of above mentioned orders passed by the Hon'ble High Court, the dismissal order dated 09.09.2020/15.09.2020 is hereby withdrawn subject to following conditions:-

- (i) He is re-instated in service w.e.f. from the date of dismissal;
- (ii) He shall not be entitled to any salary during the period from the date of dismissal and the date of joining service;
- (iii) The interim period shall be treated on duty for the purpose of pension, leave and notional fixation of pay.


