



Whereas, Sh. Ravinder Kumar had filed CWP No. 10123 of 2016 titled as Ravinder Kumar vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to quash the order dated 28.09.2015 on the ground that same is against the law laid down by the Hon'ble Court and direct the respondent to appoint the petitioner on the post of PGT Sanskrit from the date when other candidates have been joined in pursuant to the Advt. No. 1/2012 with all consequential benefits.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 19.12.2022 and later on, the petitioner again filed a CM No. 2900 of 2023 for modification of order dated 19.12.2022. The Hon'ble High Court was pleased to dispose of said CM with following orders:-

".....Keeping in view the above, the order dated 19.12.2022 is modified to the extent that though the writ petition is to be treated as not pressed but in case, the petitioner has any grievance, which he seeks to be redressed under law, keeping in view the rules governing the service, he will have the liberty to do so by filing appropriate representation.

Application stands disposed of."

In compliance of above said order, the representation dated 03.04.2023 of Sh. Ravinder Kumar was duly examined and it is found that he had applied for the post of Post Graduate Teacher (hereinafter referred to as 'PGT') - Sanskrit against the advertisement no. 1/2012 under Category No. 10.

Whereas, the Directorate of School Education Department sent a requisition to the Haryana State Teachers Selection Board (now Haryana Staff Selection Commission, Panchkula hereinafter called HSSC) for selection and recommendation of the names of eligible candidates for the post of PGT Sanskrit. Accordingly, Haryana State Teachers Selection Board advertised the said posts vide Advertisement No. 01/2012 dated 07.06.2012.

Furthermore, it is stated here that the whole selection process i.e. from issuing advertisement to the declaration of final result is carried out by the Haryana State Teachers Selection Board. But, the HSSC has not recommended the name of the petitioner in the recommendation list being an eligible candidate in pursuance to the advertisement No. 01/2012. So, in absence of recommendation from HSSC, the Department is unable to issue appointment to the petitioner for the post of PGT Sanskrit.

Keeping in view of the facts mentioned above & documents on record, the

claim raised by Sh. Ravinder Kumar in his representation dated 03.04.2023 is not tenable and the same is hereby rejected being devoid of merits.

I order accordingly.

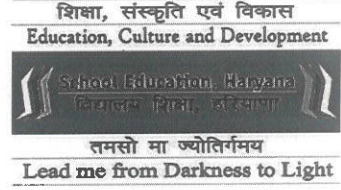
