Whereas, Smt. Sunita Kumari has filed CWP No. 16714 of 2023 titled as Sunita Kumari vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to directing the respondent Department to consider and promote the petitioner on the post of PGT-English, w.e.f. 8.1.2021, i.e., the date when her juniors were so promoted.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 03.08.2023 with following orders:-

*“.....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no.3 to decide the pending representation of the petitioner, dated 10.2.2023, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter.”*

In compliance of above said order, the representation dated 10.02.2023 of Smt. Sunita Kumari, TGT English has been duly examined and it is found that she was initially appointed as PRT/JBT on 13.08.2008 and later on, promoted to the post of TGT/Master (English) on 17.07.2018.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

**By promotion:-**

- (i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND
- (ii) 2 years teaching experience as TGT English; or  
Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.

Whereas, Smt. Sunita Kumari joined as TGT English on 30.08.2018 and he has acquired the qualification of M.A. on 25.07.2022. The cutoff date for

applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotions were issued on 08.01.2021. On that day, petitioner did not have requisite qualification (M.A. English) as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, found not eligible for promotion to the post of PGT (English). Juniors of the petitioner were promoted to the post of PGTs on 08.01.2021 and 13.04.2022 reason being that they have the requisite experience for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) on the date of promotion.

In view of the facts mentioned above, the claim of Smt. Sunita Kumari is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.

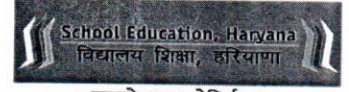

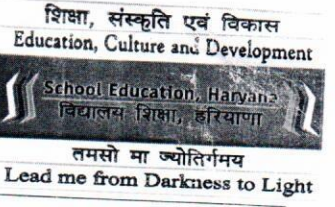

1. Their appointment is against a purely temporary post which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. Their services can be terminated without any notice, whenever there is no vacancy against which they can be retained.
2. If at any stage they desire to resign their posts they will be required to give one month's notice or forfeit in lieu thereof, their salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to them by the Directorate Secondary Education, Haryana, Panchkula in case it is proposed to terminate their services for the reason other than that mentioned in clause (1) above.
3. They will be required to take the prescribed oath of allegiance to the constitution of India.

4. In case they are married, they will produce the following certificate to his/her Head of office:-
- “That he/she is not having more than one living spouse.” In case they are unmarried, they shall have to furnish a declaration to the effect that each of these will not have more than one living spouse.
5. In case they are unmarried, they will have to furnish a declaration to the Head of the Department that they have not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
6. The candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group ‘C’ shall not be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employees shall be dispensed with.
7. They will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
8. They will be required to produce the original Educational documents and date of birth certificate before joining their duties of the said post.
9. They shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining their duties.
10. No TA/DA and joining time will be paid to them for joining this post.
11. They will remain on probation for a period of two years, from the date of their joining in the department. The period of probation can be extended in accordance with the existing rule on the subject. For assessing their performance during the period of probation, their work conduct will be taken into consideration. If their work and conduct during this period is not found satisfactory their services will be terminated without any notice.
12. Their appointment is subject to have passed 10+2 or its equivalent examination with Hindi or Sanskrit.
13. That in the matters, not specifically mentioned in this Communication, they shall be governed by the Civil Service Rules as applicable to Haryana Government employees and such rules/order /instructions as may be issued by the State Government from time to time. They shall further be governed by the “Haryana Education Department Sub Offices Ministerial (Group-C) Services Rules, 1983” and amended in the year 2013.
14. Their services will be governed under the “NEW DEFINED CONTRIBUTORY PENSION SCHEME” of the Haryana Government as per Finance Department’s notification dated 28.10.2005.

15. That if they got appointment on the basis of furnishing false/forged or fraudulent information/facts/documents which are detected later on to be false or forged or fraudulent, they would be liable for termination of their services without any notice besides such criminal action that may be taken as prescribed in the Indian Penal Code or any other Law enforce.
