Contract Renewal/Extension of Contract of manpower on HKRNL portal.

Kindly refer to the subject cited above.

As per "Deployment of contractual persons policy, 2022", all manpower was provided for one year only & concerned DDO/Department had to raise contract extension request as per Clause 5.9 for the required manpower after one year as per their requirement.

Now, as per the latest amendments in Deployment of Contractual Persons Policy. 2022 issued by HR department, GoH on 26.10.2023, the candidates with prior experience in Haryana Govt, organization can avails the benefits of relaxation in age maximum upto 5 years by the number of years of experience along with various other amendments. However, contact renewals be done as per the prevailing practices. Thus, new contract renewal/extension request can be raised on the HKRNL portal maximum up to 365 days or less as per the requirement of the indenting organization as per the clause 5.9 of Deployment of contractual persons policy, 2022

The contract of fresh engaged manpower whose contract have been expired and expiring on 31.10.2023 now can be extended as per the renewal request of indenting departments for existing manpower subject to approval of HoD/Finance Department taken by the indenting department at their own level

Manpower whose services are not required by concerned department any longer concerned DDO/Department needs to raise a manpower relieving request online for said manpower through web portal of HKRNL under the "Employee Relieving Request" tab
