



Whereas, Smt. Manju Bala has filed CWP No. 27734 of 2022 titled as Manju Bala vs. State of Haryana & another before Hon'ble Punjab and Haryana High Court praying therein to direct the respondent to decide the application dated 19.01.2022 for joining as PGT Punjabi Teacher as all the similarly situated persons has been appointed vide order dated 22.11.2021.

The Hon'ble Punjab & Haryana High Court was pleased to dispose of the said petition on dated 29.03.2023 with following orders:-

".....In view of the above, without expressing any opinion on the merits of the case, respondent No.2-Director, Secondary Education Haryana, is directed to decide the representation dated 19.01.2022 (Annexure P-9) of the petitioner by passing a speaking order within a period of eight weeks from the date of receipt of copy of this order, in accordance with law.

Disposed of."

In compliance of above said order, the representation dated 19.01.2022 of Smt. Manju Bala was duly examined and it is found that she had applied for the post of Post Graduate Teacher (hereinafter referred to as 'PGT') – Punjabi against the Advertisement No. 1/2012 dated 07.06.2012.

The name of the petitioner was recommended by the Haryana School Teachers Selection Board, Panchkula (hereinafter referred as 'HSTSB') for the post of PGT Punjabi against Advt. No. 1/2012. However, while, recommending the name of the all selected candidate, The HSTSB had imposed the following condition :-

"The selected candidates have not been medically examined and no special enquiry into their antecedents has been made. The documents pertaining to their Educational Qualification, 4 year experience, age, Caste/Category and Universities as claimed by them in the application form may please be got checked/verified from the issuing authorities, before they are allowed to join their duties. A copy of the appointments letter issued to the candidates may also be endorsed to the Board."

Whereas, the petitioner was selected on the basis of 4 years teaching experience certificate obtained from recognized Private School namely B.S. Modern Senior Secondary School, Karnal. Whereas, under Haryana State Education School Cadre (Group – B) Service Rule, 2012 (hereinafter referred as 'Rules, 2012'), One-time exemption to acquire/passing Haryana Teacher Eligibility Test (HTET) was granted to those candidates who worked under, privately managed Government aided, recognized or Government Schools for a minimum period of four years.

In furtherance to aforesaid recommendation received from HSTSB, the petitioner was called for document verification by the Departmental Verification Committee (hereinafter referred as 'DVC'). As the petitioner was selected on the basis of 4 years teaching experience, therefore, the DVC called for the corroborative record pertaining to School concerned including Appointment letter; Exam results; Staff Statement; Salary Slips; Student Strength; Provident Fund record; Attendance Register; etc., from the petitioners to prove the genuineness of her experience certificate. The DVC found that multiple experience certificates have been issued by B.S. Modern Senior Secondary School, Karnal from which the petitioner obtained the experience certificate for the post of PGT Punjabi. So, in view of this, as per the DVC report, the case of the petitioner for the appointment to the post of PGT Punjabi was kept on hold.

Thereafter, the Government referred the case of the petitioner to the Vigilance Department, Haryana for verification of the genuineness of the experience certificate as multiple experience certificates have been issued by the concerned school namely B.S. Modern Senior Secondary School, Karnal for further inquiry. However, Vigilance Department did not submit a report in this matter for a period of almost 2 years.

The Government constituted a District Level Committee under the Chairmanship of concerned SDM for re-verification of the documents relating to the school record pertaining to teaching experience certificate of the petitioner. The District Level Committee did not recommend the name of the petitioner for appointment.

Whereas, the Department took a decision that one more opportunity might be granted to the petitioner alongwith other similar situated candidates. Accordingly, the Department constituted a Document Verification Committee for re-verification of the documents relating to the school record pertaining to teaching experience certificate of the petitioner and other similar situated candidates.

The Departmental Committee submitted its report and has not recommended the name of the petitioner as eligible for appointment to the post of PGT Punjabi.

Keeping in view of the above, there is no merit in the claim of the petitioner demanded through representation dated 19.01.2022, therefore, the Department is in-capacious to consider the experience gained by the Petitioner for the post of PGT (Punjabi) from B.S. Modern Senior Secondary School, Karnal.

In pursuance with order dated 02.07.2021 passed by Hon'ble Punjab & Haryana High Court in CM-6745-CWP2021 in CWP No 19403 of 2019 titled as Baljit Singh and others V/s State of Haryana, the Governor of Haryana is pleased to promote Smt Neelima Sharma [049011] (Senoirty no. 1705 as stood on 08.07.2019), Post Graduate Teacher in Economics, Government Model Senior Secondary School, Sector-21, Chandigarh as principal w.e.f. 04.08.2021, i.e the date her junior Shri Aravil Singh [039359] (Senoirty no. 1707 as stood on 08.07.2019) was promoted as Principal along with benefit of notional pay fixation & seniority on officiating capacity as Principal (School Cadre) (Rest of Haryana Cadre), as per Haryana State Education School Cadre (Group B) Service Rules, 2012 amended in 2014, in the pay scale of Rs.15,600– 39,100 + 6600 (G.P.) plus usual allowances as sanctioned by the Haryana Government from time to time. Consequent upon her promotion as principal, she is granted proforma promotion in the light of Rule 47 of HCS (Pay) Rules, 2016 and allowed to continue with Chandigarh Administration.

Terms & Conditions:

- If any, disciplinary proceeding under Rule 7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbent(s) shall be reverted without issuing any notice.
- This promotion orders are subject to final outcome of Civil Writ Petitioner No. 19403 of 2019 titled as Baljit Singh and others V/s State of Haryana.
- 3. This promotion orders are subject to final outcome of Civil Writ Petitioner No. 6175 of 2023 titled as Anoop Singh v/s State of Haryana, CWP NO. 30137 of 2022 titled as Priyavart and others V/s State of Haryana, Civil Writ Petition NO. 11866 of 2023 - Rakesh Kumar v/s State of Haryana and Civil Writ Petition No. 8443 of 2023 titled as Arvind Kumar and others v/s State of Haryana
- The promote(s) will remain on probation for one year as per rule 27 of Haryana Civil Services (General) Rules, 2016.
- If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate shall be reverted in view of the CS office instructions dated 31.05.2006, without issuing any notice.
- 6. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding the integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
- 7. If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, then such candidate shall be reverted in view of Division Bench judgment of

- If any discrepancy regarding not fulfilling the essential qualifications as prescribed in the 'Haryana State Education School Cadre (Group B) Service Rules, 2012 amended in 2014, the said incumbent(s) shall be reverted without issuing any notice.
- In case the promote(s) officer found ineligible for the feeder post or unsuitable for appointment/promotion as Post Graduate Teacher/Headmaster on account of any reason, such officer shall stand reverted without any notice.
- 10. In the case of candidates whose inter se seniority as PGT/ Lecturer is not available in the database, then such candidates will be suitably placed by determining their inter se seniority as PGT/ Lecturer and will be assigned subsequent seniority in the corresponding Principal seniority list accordingly.
- 11. If subsequently any senior person becomes eligible for promotion due to availability of ACRs or other records, then in that eventuality, he/she shall be treated as senior to any promoted junior candidate, even if promoted later.
- 12. After joining at the station allotted herein he/she shall proceed on a School Leadership training to be imparted through *Teacher Education Institutions* controlled by the SCERT, Haryana. The detail programme in this respect shall be communicated to her by the SCERT, Haryana.
- 13. Needless to say, the present promotion is subject to the outcome of any court case pending in any court of law which might have any bearing on the present order.
- 14. The District Education Officer concerned shall ensure compliance of above conditions before letting the promoted Principal to join.
- 15. These newly promote officers shall have to seek permanent posting through MIS portal by participating in Transfer Drive.
